Wojcio opted to take off his remaining mounts. “Style Element” was reportedly banged up from the fall, but otherwise “OK” according to state veterinarian Robert Goodbary. **4<sup>th</sup> Race Inquiry**

The inquiry sign was posted to review possible interference by 5<sup>th</sup> place finisher #2 “Hi Ho Hi Ho” (Richard Wojcio) to 6<sup>th</sup> place finisher #4 “Tequila On Ice” (James Lackey). After review it was determined that #2 had pulled to the outside leaving an opening for #4 to come up the inside. As #4 comes up the inside #2 comes back toward the inside causing Driver Lackey to pull #4 out of the pacing gait and lose a chance at a better placing. #2 was placed 6<sup>th</sup> for the interference. Driver Wojcio will visit the Stewards tomorrow.

**12<sup>th</sup> Race Equipment Problem-Recall-Late Declaration**

As the field approached the start #5 “Red Star Fiona” (Richard Wojcio) suffered broken equipment (Girth Strap) causing a recall. The equipment could not be fixed in a timely manner and the horse was scratched.

**13<sup>th</sup> Race Inquiry- Disqualification**

#7 “Bo Knows Power” (James Lackey) who finished 5<sup>th</sup> was observed coming out in deep stretch placing a wheel under #3 “Keyword Hanover” causing Driver James Kennedy to check sharply costing #3 a chance at a better placing. Driver Lackey will report to the Stewards tomorrow.

**Saturday****1/14/12 (1) Richard Wojcio Ruling [REF: 1/12/12 (1)]****RULING # 03**

DRIVER **RICHARD WOJCIO**, WHO DROVE “**HI HO HI HO**” IN THE FOURTH RACE ON FRIDAY JANUARY 13, 2012 IS HEREBY FINED TWO HUNDRED (**\$200.00**)\* DOLLARS FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE # **1721 (A)** (DRIVING RULES –CHANGE EITHER TO THE RIGHT OR LEFT DURING ANY PART OF THE RACE WHEN ANOTHER HORSE IS SO NEAR THAT IN ALTERING THE POSITION OF HIS HORSE HE COMPELS THE HORSE BEHIND HIM TO SHORTEN HIS STRIDE, OR CAUSES THE DRIVER OF SUCH OTHER HORSE TO PULL SUCH HORSE OUT OF HIS STRIDE). INCIDENT OCCURRED AFTER THE HALF MILE MARKER - RESULTING IN A DISQUALIFICATION.

The above ruling was issued after Wojcio appeared and accepted the penalty with a promise to keep a closer watch on his fellow drivers.

**1/14/2012 (2) Harold Herrera Ruling****RULING # 04**

DRIVER **HAROLD HERRERA**, WHO DROVE “**BADGER CREEK**” IN THE TENTH RACE ON JANUARY 13, 2012, IS HEREBY FINED THE SUM OF ONE HUNDRED (**\$100.00**)\* DOLLARS FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #**1530** (CASES NOT COVERED – VIOLATION OF ‘CAL-EXPO HOUSE WHIPPING RULE’ – (4)(A) ANY BLATANT OR EXAGGERATED MOVEMENTS OF THE WHIPPING ARM WHICH WILL RESULT FROM RAISING THE ELBOW ABOVE THE DRIVER’S SHOULDER HEIGHT AND/OR ALLOWING THE HAND HOLDING THE WHIP TO REACH BEHIND THE DRIVER DURING THE USE OF THE WHIP).

The above ruling was issued after Herrera appeared for the second time this season on a whipping violation. The Stewards took extra time to emphasize what Herrera was doing wrong and he needs to correct his actions or face much stiffer penalties.

**1/14/12 (3) James Lackey Ruling [REF: 1/13/12 (3)]****RULING # 05**

DRIVER JAMES LACKEY, WHO DROVE “BO KNOWS POWER” IN THE THIRTEENTH RACE ON FRIDAY JANUARY 13, 2012 IS HEREBY FINED TWO HUNDRED (\$200.00)\* DOLLARS FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE # 1721 (J) (DRIVING RULES – CHANGE COURSE AFTER SELECTING A POSITION IN THE HOMESTRETCH, OR BEAR IN OR OUT IN SUCH A MANNER AS TO INTERFERE WITH ANOTHER HORSE OR CAUSE HIM TO CHANGE STRIDE OR BREAK). INCIDENT OCCURRED MID STRETCH - RESULTING IN A DISQUALIFICATION.

The above ruling was issued after Lackey contacted the Stewards and accepted responsibility for causing interference in the drive stretch of last nights 13<sup>th</sup> race.

Trainer Larry Hastings was in to explain the equipment problem with #5 “Red Star Fiona” in last nights 12<sup>th</sup> race. Hastings related that it was a broken girth strap and that the safety strap was still secure preventing any accident. Hastings, who is a conscientious trainer, was at a loss to explain the breakage. In forty years of training Mr. Hastings had never seen or had it happen before.

1/14/12	03	Driver Richard Wojcio, who drove “HI HO HI HO” in the fourth race on Friday January 13, 2012 is hereby fined two hundred (\$200.00)* dollars for violation of California horse racing board rule # 1721 (a) (driving rules –change either to the right or left during any part of the race when another horse is so near that in altering the position of his horse he compels the horse behind him to shorten his stride, or causes the driver of such other horse to pull

such horse out of his stride). Incident occurred after the half mile marker - resulting in a disqualification.

- 1/14/12      04      Driver Harold Herrera, who drove “BADGER CREEK” in the tenth race on January 13, 2012, is hereby fined the sum of one hundred (\$100.00)\* dollars for violation of California horse racing board rule #1530 (cases not covered – violation of ‘cal-expo house whipping rule’ – (4)(a) any blatant or exaggerated movements of the whipping arm which will result from raising the elbow above the driver’s shoulder height and/or allowing the hand holding the whip to reach behind the driver during the use of the whip).
- 1/14/12      05      Driver James Lackey, who drove “BO KNOWS POWER” in the thirteenth race on Friday January 13, 2012 is hereby fined two hundred (\$200.00)\* dollars for violation of California horse racing board rule # 1721 (j) (driving rules – change course after selecting a position in the homestretch, or bear in or out in such a manner as to interfere with another horse or cause him to change stride or break). Incident occurred mid stretch - resulting in a disqualification.
