Nathalie Tremblay vs. Roy Moorefield Hearing [Case No: 11SW0065]
Amended

Trainer Nathalie Tremblay was present today for an informal hearing. Trainer Tremblay has filed a complaint against Owner Roy Moorefield for alleged violation of California Horse Racing Board Rule #1876 (Financial Responsibility) Owner Moorefield testified via telephone.

Tremblay alleges that Owner Moorefield owes her two thousand seven hundred (\$2,700) dollars in delinquent training bills for the horse "Firing Line." Roy Moorefield testified by telephone and stated he did own "Firing Line" Trainer Tremblay acknowledges "Firing Line" "raced under" the name of Gene Van Tassel during the time of training in question. (February 21, 2011 to May 10, 2011). The Stewards told Tremblay that they couldn't help her recover money from an owner (Moorefield) that denies he even owns the horse in question. More specifically when he's not listed on the official registration of the United States Trotting Association (USTA). Case dismissed.

David Siegel Film Review

Driver David Siegel appeared in the Steward's office to review his drive aboard #4 "Take No Prisoners" who originally finished third in the 12th race Saturday, January 21. Driver Siegel "Take No Prisoners" was disqualified and placed ninth (last) for interference to #9 "The Future" (James Lackey) after the half mile pole.

During film review Driver Siegel told the Stewards he felt he was "clear" of #9 "The Future" and that Driver Lackey possibly had overreacted when his horse shifted outward approaching the far turn.

The Stewards called a meeting today with all Cal Expo drivers which was held at 5:30 pm in the driver's room. Along with the Stewards present for today's meeting were Cal Expo Starter Bill Vallandingham, California Horse Racing Board Investigators Carol Ann Nolan and Rod Ciganovich. Investigator Nolan discussed implementation of California Horse Racing Board Rule #1500.1 (Random Drug Testing). Starter Vallandingham discussed various reasons for "recalls" which are addressed in California Horse Racing Board Rule #1730.

RULING # 10

DRIVER **DAVID SIEGEL**, WHO DROVE “**TAKE NO PRISONERS**” IN THE TWELFTH RACE ON SATURDAY, JANUARY 21, 2012 IS HEREBY FINED TWO HUNDRED (**\$200.00**)* DOLLARS FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE # **1721 (F)** (DRIVING RULES – CARRY HORSE OUT CAUSING INTERFERENCE) RESULTING IN A DISQUALIFICATION FROM THIRD TO NINTH.

The ruling above was issued following a film review held with Driver David Siegel.

Qualifying Races

Two (2) qualifying races were held prior to tonight’s fifteen (15) race pari-mutuel card. Of the thirteen (13) competitors twelve (12) made the grade.

1/28/12 (3) **Sixth Race Inquiry**

The Steward's posted the inquiry sign after viewing wheel disc contact between first place finisher #4 "Beach Beach Beach" (Lemoyne Svendson) and fourth place finisher #2 "Ravenswood Racey" (George Luster). This incident took place in the middle of the final turn, approaching the 3/4 pole.

The Steward's reviewed several angles of this incident and spoke to both of the driver's involved. The Steward's determined that these horses were racing in tight quarters and actually it may have been fourth place finisher #2 "Ravenswood Racey" that may have drifted out and initiated the contact. In a unanimous decision "no change" was made in the order of finish. Driver George Luster was ordered to film review with the stewards.
