The ruling was a result of Driver Luke Plano missing his first five (5) drives on Friday due to weather related travel delays.

Present at the hearing Cal Expo Stewards Baker, Meyers, and Oke, Respondent Plano his representatives Racing Secretary Fred Kuebler and CHHA Executive Director Alan Horowitz CHRB Supervising Investigator Dan Dailey as an observer and Greg Anderson ROAP student/observer. The proceedings were recorded by Wendy Frazier of Frazier reporting.

The hearing was opened witnesses sworn and exhibits accepted, the matter was considered submitted. Decision to follow.

Film Review/ Driver James Lackey

Driver Lackey appeared as requested, to review his drive in the fourteenth race on Saturday March 31. [REF: 3/31/12 (4)].

After reviewing film of a race which was contested on a very sloppy track, Driver Lackey was very candid in taking responsibility for the incident and his willingness to accept a sanction the stewards felt appropriate.

Consequently the following ruling was issued.

RULING # 27

DRIVER JAMES LACKEY, WHO DROVE “RW ISLAND SPIRIT” IN THE FOURTEENTH RACE ON SATURDAY, MARCH 31, 2012 IS HEREBY FINED TWO HUNDRED (\$200.00)* DOLLARS FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE # 1721 (J) (DRIVING RULES – CHANGE COURSE AFTER SELECTING A POSITION IN THE HOMESTRETCH, OR BEAR IN OR OUT IN SUCH A MANNER AS TO INTERFERE WITH ANOTHER HORSE OR CAUSE HIM TO CHANGE STRIDE OR BREAK). INCIDENT OCCURRED MID STRETCH - RESULTING IN A DISQUALIFICATION.

Film Review Driver John McKeon

Driver John McKeon appeared to review his drive in Friday’s third race in which he was observed utilizing his whip ‘one handed’ prior to the 7/8th mile marker a violation of the Cal Expo ‘House Whipping Rule.’

Driver McKeon was very candid in accepting responsibility for his actions and the following ruling was issued.

RULING # 28

DRIVER JOHN MCKEON JR, WHO DROVE “BROADWAY VICTORY” IN THE THIRD RACE ON APRIL 6, 2012, IS HEREBY FINED THE SUM OF FIFTY (\$50.00)* DOLLARS FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1530 (CASES NOT COVERED – VIOLATION OF ‘CAL-EXPO HOUSE WHIPPING RULE’ – (2) DRIVER MUST KEEP ONE LINE IN EACH HAND AT ALL TIMES DURING THE RACE EXCEPT WHEN THE HORSE AND DRIVER REACH THE 7/8 MILE MARKER DURING THE RACE.
