Driver Richard Wojcio was excused for medical reason. Reports state he was diagnosed with vertigo and possible minor stroke. Replaced as follows: 6th race Tim Maier, 9th race Steve Desomer.

The inquiry sign was posted to review an incident in the final turn involving #1 "Broadway Victory" (John McKeon) who finished third and #4 "Giles L S Hanover" (Steve Wiseman) second. Tapes show #1 pull late hooking wheels with #4 as that rival attempted to pass. Since #4 beat #1 no change was necessary. McKeon will see the Stewards tomorrow.

- 4/14/12 (1) **Kennedy Ruling**

RULING # 29

DRIVER **JAMES KENNEDY**, WHO DROVE "CYCLE POWER" IN THE SECOND RACE ON SATURDAY, APRIL 7, 2011, IS HEREBY FINED THE SUM OF ONE HUNDRED (\$100.00)* DOLLARS FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1734 (WHIPPING – UNNECESSARY FORCE).

The above ruling was issued after Mr. Kennedy appeared and was candid in the fact that he was to aggressive.

4/14/12 (2) **McKeon Ruling [REF: 4/13/12 (3)]**

RULING # 30

DRIVER **JOHN MCKEON JR**, WHO DROVE “**BROADWAY VICTORY**” IN THE FIRST RACE ON APRIL 13, 2012, IS HEREBY FINED ONE HUNDRED (\$**100.00**)* DOLLARS VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #**1721 (B)**(DRIVING RULES – JOSTLE, STRIKE, HOOK WHEELS OR INTERFERE WITH ANOTHER HORSE OR DRIVER).

The above ruling was issued following a hearing with Mr. McKeon in which he admitted driver error in not controlling his horse properly and causing interference to a rival.

4/14/12 (3) **Wilkinson Interview**

Trainer James Wilkinson Jr. was in to give an explanation of his horse “Whipped Dreams” performance on April 7th. “Whipped Dreams” took three (3) seconds off its previous best a five (5) length victory in 1:52. Wilkinson said the horse had been training well and was maturing when it made a break in its previous start. He also said the horse was lazy and he told Driver Jim Lackey to give him a good scoring down before the race and to keep after him. Driver Lackey did as he was told and kept after the horse even with a commanding lead. Racing Secretary Fred Kuebler has now listed “Whipped Dreams” for the top class racing at Cal Expo.

4/14/12 (4) **Bragg Warning**

Owner/Groom Brandon Bragg was summoned to the stewards office for warming up a horse without proper attire. Bragg is a double extra large and is having custom colors made. He had only warmed horses up on the back track before and since it was closed due to inclement weather he went on the main track. Bragg is only eighteen (18) and unaware of the policy. A warning was issued.

4/14/12 (5) **Wojcio Off [REF: 4/13/12 (2)]**

Driver Richard Wojcio contacted the stewards wishing to resume driving tonight. The stewards agreed that a full clearance from a doctor was needed after Mr. Wojcio had stated earlier he had vertigo and a possible minor stroke. He accepted our verdict and was replaced as follows; 1st Race- Steve Wiseman, 3rd Race- Steve Wiseman, 4th Race- Scott Cisco and 10th Race- Rocky Stidham.

4/14/12 (6) **Isbell Ruling**

RULING # 31

PROVISIONAL DRIVER **KAREN ISBELL**, WHO DROVE “**FISHY’S SUSHI**” IN THE TENTH RACE ON APRIL 13, 2012, IS HEREBY FINED THE SUM OF FIFTY (\$**50.00**)* DOLLARS FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #**1530** (CASES NOT COVERED – VIOLATION OF ‘CAL-EXPO HOUSE WHIPPING RULE’ – (2) DRIVER MUST KEEP ONE LINE IN EACH HAND AT ALL TIMES DURING

THE RACE EXCEPT WHEN THE HORSE AND DRIVER REACH THE 7/8 MILE MARKER DURING THE RACE.

The above ruling was issued after Isbell appeared and plead guilty to being over anxious in the heat of battle during the amateur challenge.

- 4/14/12 (7) **Rushing**
The stewards opened the office early to see the aforementioned licensees before qualifying, Non-Wagering stakes and fifteen (15) regular races. A total of twenty (20) races were contested this evening.
- 4/14/12 (8) **Qualifiers**
Twelve (12) of the nineteen (19) participants made the grade in today's three (3) qualifying races.
- 4/14/12 (9) **Inquiry-Non Wagering Sire Stakes#1-No Change**
The inquiry sign was posted to review possible interference by the winner #4 "Rite After Disaster" (Luke Plano) for pulling late on third place finisher #1 "Elazteca" (Marco Rios) around the turn. After talking to the drivers and film review it was determined #1 was racing wide and left ample room for #4 to pull without interference. No change.
- 4/14/12 (10) **Second Race No Place or Show Wagering**
Two (2) late scratches reduced the field to three horses. Place and show wagering was cancelled in accordance with the rules.
- 4/14/12 (11) **Third Race Inquiry-No Change**
Three (3) horses made breaks in this seven (7) horse field. The inquiry sign was lit to assure no interference occurred and that all horses complied with the breaking rule. After review the race was made official with no change.
- 4/14/12 (12) **Fourth Race Inquiry-No Change**
The winner #6 "Live A Little" (Lemoyne Svendsen) went off stride before the start. After review it was determined the breaking rule was complied with and No interference occurred. No change.
- 4/14/12 (13) **Eighth Race Inquiry-No Change**
Three (3) horses went off stride during this race including third place finisher #4 "Connie's Lady" (James Kennedy). The inquiry sign was lit to assure all horses complied with the breaking rule and no interference took place. After review no change was made.
- 4/14/12 (14) **Twelfth Race Shoe Repair-Late Scratch-Delay**
The start of the twelfth race was delayed approximately five minutes due to a shoe repair on #1 "Asgoodasioncewas" (Trainer Gene Vallandingham) and a late scratch of the favorite #4 "Nightscreamer" (Trainer Tim Brown) who did not warm up to the satisfaction of Track Veterinarian Henry Cook.
