The racing office was open today accepting entries for Friday, December 21, Saturday, December 22, and Sunday, December 23. Also races were drawn today for Friday, December 21.

There will be three (3) non-wagering California Sire Stakes commencing at 1:00 pm. There will be thirteen (13) pari-mutuel events with a 2:30 pm first post. One hundred sixteen (116) horses are scheduled to start on the pari-mutuel card.

12/18/12 (1) **Scratch/Entry Day**

Scratches and changes for Friday, December 21 took place this morning in the racing office. Two (2) scratches and twenty four (24) driver changes/selections were made for this day. All changes were activated after the 9:00 am deadline. Fourteen (14) races were drawn today for races to be held on Saturday, December 22. One hundred twelve (112) horses are scheduled to start.

The racing office was open this morning taking entries for Wednesday, December 26. There will be fourteen (14) pari-mutuel events with a 5:00 pm first post. One hundred nineteen (119) horses are scheduled to start.

12/21/12 (2) **Off Track**

The stewards listed the track condition as 'sloppy' for all thirteen (13) races this afternoon. First post time is 2:35 pm. The track condition for the three (3) non-wagering California sire Stakes was also listed as 'sloppy'.

12/21/12 (3) **Thirteenth Race Inquiry – Disqualification**

The stewards posted the inquiry sign after viewing seventh place finished #1 "Wanna Glide" (Susan Boyce) make a break before the ¾ pole. This break caused tenth place finisher #7 "La Cantera" (Rocky Stidham) to check and also make a break before the ¾ pole. Following this incident, in a unanimous decision, the stewards disqualified #1 "Wanna Glide" and placed him tenth (last).

**Saturday**

12/22/12 (1) **Track Rating**  
 The steward’s listed the racetrack as ‘good’ for races one (1) through six (6). Intermittent rain led the stewards to downgrade the track to ‘sloppy’ for races seven (7) through fourteen (14).

12/22/12 (2) **Fourth Race Inquiry**  
 The stewards posted the inquiry sign after viewing first place finisher #4 “Lady’s Art” (James Lackey) possibly interfere with rivals while racing on the first turn.

Film review shows Driver Lackey race up alongside eventual fourth place finisher #1 “Bewareofthisaffair” (James Kennedy) causing that rival to check his horse at the ¼ mile pole. Lackey also threw his head backwards nearly striking Driver Kennedy’s horse. Another rival, #6 “Sleigh Belle” (Luke Plano) went on a break behind these two (2) horses. The stewards unanimously ruled that the actions of #4 “Lady’s Art” did not warrant a disqualification. Driver James Lackey was ordered to a film review with the stewards.

12/22/12 (3) **Fifth Race Inquiry – Disqualification**  
 The stewards posted the inquiry following the running of this California Sire Stakes (Two Year Old Fillies) with a purse of \$10,000. Of specific interest were the actions of fourth place finisher #5 “Blue Gem” (Harold Herrera) and fifth place finisher #1 “Babe Ridge” (Scott Cisco). Film review showed #5 “Blue Gem” veer inward in mid-stretch and then veer out in ‘deep stretch’. Both of these actions impeded a fast closing #1 “Babe Ridge”. Following film review, in a unanimous decision, the stewards disqualified #5 “Blue Gem” and placed him fifth. Driver Harold Herrera was ordered to film review.

The racing office was open today taking entries for Friday, December 28. Thirteen (13) races filled with one hundred (100) horses scheduled to start.

12/23/12 (2) **Scratch Time**

Scratch time for Wednesday, December 26 was held this evening during the races. Thirty four (34) driver changes were activated after the 5:00 pm deadline.

12/23/12 (3) **Fourth Race Inquiry**

The stewards posted the inquiry sign after viewing first place finisher #6 "Ra Ra Steven" (Richard Wojcio) make contact with third place finisher #1 "Bloom N Doom" (Lemoyne Svendsen) after the  $\frac{3}{4}$  pole. Race replays show #6 "Ra Ra Steven" race up behind #1 "Bloom N Doom" and strike the left wheel of that rival. #6 "Ra Ra Steven" made a break after

this incident. The stewards ruled that #6 “Ra Ra Steven” complied with the breaking rule before regaining his pacing gait. The stewards also ruled that interference was minimal and that no change in the order of finish was warranted.

12/23/12 (4) **Sixth Race Inquiry**

The stewards posted the inquiry sign after viewing third place finisher #3 “Cruisin In My Beamer” (Lemoyne Svendsen) race up along pylons and briefly hook the wheel of fifth place finisher #1 “Marlene’s Angel” (Luke Plano). This incident happened in mid-stretch. The stewards watched all reply angles and spoke to both drivers involved. In a unanimous decision no change was made in the order of finish.

12/23/12 (5) **Ninth Race Inquiry**

The stewards posted the inquiry sign after viewing second place finisher #9 “KD Amazin Spirit” (Scott Cisco) drift out badly in the final 1/8 of a mile. This action took place in front of third place finisher #6 “Giles LS Hanover” (Steve Wiseman). #6 “Giles LS Hanover” was also drifting out while trailing #9 “KD Amazin Spirit” and the stewards felt “Giles LS Hanover” was not cost an opportunity for a better placing. No change.
