01/14/13 (1) **Entries and Draw**

Entries were taken for this weeks racing. The draw for Thursday's card was conducted at approximately 3:15pm. A total of one hundred two (102) horses are entered for Thursday's eleven (11) race card. No Cal-Bred races were used.

**Tuesday**

01/15/13 (1) **Scratches for Thursday – The Draw for Friday**

Two scratches and numerous driver changes were taken for Thursday. Friday's draw had one hundred twenty four (124) horses divided into thirteen (13) races. No Cal-Bred races were used.

**Wednesday**

01/16/13 (1) **Scratches for Friday – The Draw for Saturday**

Two scratches and numerous driver changes were taken for Friday. Saturday's thirteen (13) race card has one hundred twenty one (121) horses entered.

01/16/13 (2) **Purse Enhancement**

Starting this Thursday, January 17, 2013, the following purse enhancement has been added by management to encourage larger fields and limit unpaid starters to three (3) a race:

9 Horse Field – 6<sup>th</sup> place: 4%

10 Horse Field – 6<sup>th</sup> place: 4%, 7<sup>th</sup> place: 3%

11 Horse Field – 6<sup>th</sup> place: 4%, 7<sup>th</sup> place: 3%, 8<sup>th</sup> place: 2%

This money comes out of a promotional fund and does not affect the original purse which will be distributed to the first five (5) finishers as usual.

**Kennedy Ruling**

**RULING # 10**

DRIVER JAMES KENNEDY, WHO DROVE "LITTLEHANNASUE" IN THE THIRTEENTH RACE ON SATURDAY JANUARY 12, 2013, IS HEREBY FINED THE SUM OF TWO HUNDRED (\$200.00)\* DOLLARS FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1721 (F) (DRIVING RULES – CARRY A HORSE OUT – RESULTING IN A DISQUALIFICATION). INCIDENT OCCURRED NEAR THE HALF MILE MARKER.

The above ruling was issued after Kennedy accepted responsibility for pulling late forcing a competitor three (3) wide.

**Plano Ruling**

**RULING # 11**

DRIVER LUKE PLANO, WHO DROVE "MEDOLAND SAPPHIRE" IN THE SEVENTH RACE ON JANUARY 17, 2013, IS HEREBY FINED THE SUM OF TWO HUNDRED (\$200.00)\* DOLLARS FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE

**#1530 (CASES NOT COVERED – DRIVING WITH FOOT OUT OF STIRRUP/URGING BY CONTACT).**

The above Ruling was issued after Plano appeared and reviewed the films with the Stewards. He accepted the penalty and was cautioned that penalties will increase for future violations.

01/18/13 (2) **Fifth Race Inquiry – No Change**

The inquiry sign was posted to review numerous horses going offstride including third place finisher #6 “Rocky Road Success.” After review it was determined all offstride horses complied with the ‘breaking rule’ and no change was warranted.

01/18/13 (3) **No Photo Finish**

Photo Operator Katherine Barbeau failed to generate a photo finish for the eleventh race. The first four (4) finishers were clear and verified with the aid of video tape. The Stewards and placing Judge Kathy Poor agreed that fifth place could not be separated and declared a dead heat for fifth. Ms. Barbeau is fairly new to the photo finish operation and realized her mistake which she assured would not be repeated. A letter of explanation will be attached.
