Trainer Dario Solares appeared with owner Corey Stevens to explain how Trinity Boring was allowed to jog “Hey Scoob” on the back track with an expired license. Boring, a former licensee, is Stevens’ fiancé and Stevens with Solares permission had asked Boring to jog the horse. The horse got loose which brought the whole issue to the attention of the Investigative Staff. Solares understands that he is responsible for his barn and help. Decision to follow.

**Liberio Pacheco Hearing – Case No. 13SW0005**

A hearing was held today concerning a test sample taken from the pacer “Pancetta” on December 29, 2012 which was reported by U.C. Davis Laboratory to contain Guaifenesin. “Pancetta” was trained by Liberio Pacheco. No request was made for a split sample. No evidence presented could enlighten this board as to the possible cause of the finding. Decision forthcoming.

**Solares Ruling [Ref: 2/28/13 (1)]****RULING # 24**

TRAINER **DARIO SOLARES**, IS HEREBY FINED ON HUNDRED (\$100.00)\* DOLLARS FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1895 (TRAINER’S DUTY TO INSURE LICENSED PARTICIPATION – UNLICENSED GROOM) PURSUANT TO RULE #1481 (OCCUPATIONAL LICENSES AND FEES).

The above ruling was issued after deliberating over yesterdays hearing.

**Pacheco Ruling [Ref: 2/28/13 (2)]****RULING # 25**

TRAINER **LIBERIO PACHECO**, WHO STARTED “PANCETTA” IN THE FIRST RACE ON DECEMBER 29, 2012, IS FINED FIVE HUNDRED (\$500.00)\* DOLLARS FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1843 (A) (D) (MEDICATIONS, DRUGS AND OTHER SUBSTANCES – PROHIBITIVE DRUG SUBSTANCE – GUAIFENESIN)

PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1887 (A)  
(TRAINER TO INSURE CONDITION OF HORSE).

The above ruling was issued after all matters including Mr. Pacheco's fairly solid record were considered.

- 03/01/13 (2) **Sixth Race Inquiry Disqualification – Objection – No Change**  
The inquiry sign was posted to review an incident in the stretch involving #6 “Doc’s Zippy” (Bruce Clarke, fifth), #5 “Whicadidja” (David Siegel, fourth) and #7 “Ra Ra Steven” (Richard Wojcio, seventh). Driver Bruce Clarke also lodged a claim of foul against #5. After a lengthy review it was determined that #6 caused interference to #7 and #5 was not guilty of interference. #5 shifted out to avoid a breaking horse while well in front of #6. #6 then shifted to the outside away from the shifting horse and caught the legs of #7. #6 was disqualified and place seventh for the interference.
- 03/01/13 (4) **Tenth Race Inquiry – Disqualification**  
The inquiry sign was posted to review an incident down the backside. After a thorough review it was determined that #2 “Natty Lite” (Williams Hernandez, sixth) pulled late forcing #5 “Bubba McGee” (Michael Eaton, seventh) three wide. #2 was disqualified from the sixth and seventh for the foul.

- 03/02/13 (1) **Hernandez Ruling [Ref: 3/1/13 (4)]**

**RULING # 26**

PROVISIONAL DRIVER **WILLIAMS HERNANDEZ**, WHO DROVE “**NATTY LITE**” IN THE TENTH RACE ON FRIDAY MARCH 1, 2013, IS HEREBY FINED THE SUM OF TWO HUNDRED (**\$200.00**)\* DOLLARS FOR VIOLATION OF CALIFORNIA HORSE RACING

BOARD RULE #1721 (I) (DRIVING RULES – COMMIT ACT IMPEDING PROGRESS OF ANOTHER HORSE RESULTING IN A DISQUALIFICATION).

The above ruling was issued after Hernandez appeared for a film review. Hernandez admitted to his error when shown the tapes and accepted the penalty for pulling late.

**RULING #27**

TRAINER **TIM BROWN**, WHO HAD “**PAUL THE POWERFUL**” PROGRAMMED TO START IN THE FOURTH RACE ON FRIDAY MARCH 1, 2013 IS HEREBY FINED THE SUM OF FIFTY (**\$50.00**)\* DOLLARS FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1530 (CASES NOT COVERED BY RULES AND REGULATIONS) LATE TO THE POST PARADE.

Trainer Tim Brown accepted the above ruling for failing to have his horse ready for the fourth race post parade. He had misplaced a piece of equipment (mini bit) which caused the delay.

03/02/13 (3) **Qualifiers**

Eleven of eleven made the grade in today’s two qualifying races.

03/02/13 (4) **Fifth Race Inquiry – No Change**

The winner #5 “Claim Jumper” (Frank Petrelli) went off stride momentarily past the ½ mile pole. The inquiry sign was posted to ensure no interference occurred and there was no violation of the “breaking rule.” After review, the original order of finish was affirmed.

03/02/13 (5) **Seventh Race Inquiry – No Change**

The inquiry sign was posted to review the actions of the first and second place finishers (#2 Hi Fidelity, Scott Cisco) and (#5 Emmasphere, Luke Plano) down the backside. #5 was observed going three wide down the backside around #2. At issue was the possibility that #5 was forced wide by #2. After a thorough review and talking with the drivers it was determined #5 raced wide of its own accord. No change.
