DRIVER **KAREN ISBELL**, WHO DROVE "COUNT DRACULA" IN THE FOURTH RACE ON APRIL 12, 2013, IS HEREBY FINED THE SUM OF ONE HUNDRED (**\$100.00**)* DOLLARS FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1530 (CASES NOT COVERED – VIOLATION OF 'CAL-EXPO HOUSE WHIPPING RULE' – (2) DRIVER MUST KEEP ONE LINE IN EACH HAND AT ALL TIMES UNTIL HORSE REACHES THE 7/8 MARKER).

The above ruling was issued after Ms. Isbell was contacted and admitted to being over anxious in this amateur event.

04/13/13 (2) **Welence Ruling**

RULING # 40

DRIVER **PAUL WELENCE**, WHO DROVE "HIHO LEGACY" IN THE SEVENTH RACE ON APRIL 12, 2013, IS HEREBY FINED THE SUM OF ONE HUNDRED (**\$100.00**)* DOLLARS FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1530 (CASES NOT COVERED – VIOLATION OF 'CAL-EXPO HOUSE WHIPPING RULE' – (2) DRIVER MUST KEEP ONE LINE IN EACH HAND AT ALL TIMES UNTIL HORSE REACHES THE 7/8 MARKER).

The above ruling was issued after Welence was contacted and admitted to being whipping one handed too early.

04/13/13 (3) **Qualifiers**

Eight (8) of ten (10) made the grade in today's three qualifiers.

04/13/13 (4) **Tote Delay**

The Tote System froze at 7:51 PM. Post time for tonight's sixth race was scheduled for 7:52 PM. The horses were on the track warming up when the stewards were notified of a system wide failure of the Tote System.

Starter Bill Vallandingham was notified immediately to delay the start until further notice. After approximately ten minutes Tote personnel could not give an estimated time for a fix to the problem and the horses were ordered back to the paddock. Los Alamitos was experiencing the same problem and the Cal-Expo stewards were in contact with the Los Alamitos stewards to formulate a timeframe for possible cancellation if the problem could not be rectified. Executive Director Kirk Breed was also made aware of the problem and possible scenarios. After approximately thirty five (35) minutes Tote informed us they expected a switch to their backup system would be completed in twenty (20) minutes. The Los Alamitos stewards and us at Cal-Expo agreed to hold cancellation until 9:00 PM to give Tote an opportunity for a fix. At approximately three (3) minutes to nine, Tote Supervisor Ted Shaine contacted the stewards stating the system would be up and running in less than five minutes. During the conversation it was observed that our Tote board was coming back on line and the system was starting to function. Wagering resumed at 9:00 PM and the sixth race horses were hitched and sent to the post. Off time was 9:09 PM. A total delay of approximately one (1) hour eight (8) minutes. A letter of explanation was requested from Sport Tech (Tote Company) and will be attached to these minutes.

04/13/13 (5) **Fourteenth Race Inquiry – No Change**

The inquiry sign was posted to review #3 “Morwyn Hanover” (David Siegel) racing inside the pylon line in the stretch. After review it was determined #3 raced inside of one pylon of its own accord and no disqualification was necessary.
