05/10/13 (1) **Trainer Gretchen Smith Ruling**

After receiving notification of a stipulated agreement between the CHRB and Trainer Smith the Cal Expo Board of Stewards issued the following ruling.

RULING # 49

ACTING UPON A SIGNED STIPULATED SETTLEMENT AGREEMENT BETWEEN THE CALIFORNIA HORSE RACING BOARD (DATED MAY 7, 2013) AND TRAINER **GRETCHEN SMITH**, THE CAL- EXPO BOARD OF STEWARDS HEREBY SUSPEND TRAINER GRETCHEN SMITH FOR A PERIOD OF THIRTY (30) DAYS (MAY 10, 2013 THROUGH JUNE 8, 2013 INCLUSIVE) AND ISSUE A FINE IN THE AMOUNT OF FIVE HUNDRED (\$500.00)* DOLLARS FOR VIOLATION OF CHRB RULE #1843 (A) (B) (D) (MEDICATIONS, DRUGS, AND OTHER SUBSTANCES), AND CHRB RULE #1887 (TRAINER TO INSURE CONDITION OF HORSE). AFTER THE HORSE “FEETDON’TFAILMENOW” TESTED POSITIVE FOR THE PROHIBITED SUBSTANCE “NORPROPOXYPHENE” (CLASS 3 – PENALTY CLASS B) AFTER COMPETING ON JANUARY 5, 2013 AND JANUARY 12, 2013.

05/10/13 (2) **Film Review – Driver Daniel Gassien**

Driver Dan Gassien attended film review in order to review his drive in Saturday, May 4th's second race. Gassien's mount #1 “In Regal Attire” the original second place finisher was disqualified and placed third for interference with #4 “Forever My Love” (Tim Maier) in deep stretch. By majority vote (Steward Meyers dissenting) the majority felt #4 has been cost an opportunity for a better placing. In reviewing his drive the driver stated and the films confirmed the fact that his mount was “bearing out” and he was attempting to maintain his course while maintaining his placing. The steward in a split vote (Baker dissenting) felt the horse was primarily responsible for the problem and a warning was in order.

05/10/13 (3) **Film Review – Driver Lemoyne Svendsen**

Driver Lemoyne Svendsen was in to review his drive on #7 “Bloom N Doom” on Saturday, May 4th, Race #8. Shortly after the start #7 and #5 “Fork In the Road” (Steve Wiseman) made ‘wheel to wheel’ contact. Svendsen's mount was obviously “bearing in” and initiated the contact. As #5 finished ahead of #7 in the official order of finish no change was necessary. Svendsen was advised to be more careful.

05/10/13 (4) **Eighth Race Inquiry – No Change**

The “inquiry” sign was lit to review an incident mid stretch in which #3 “Major Marcus” (Richard Wojcio) and #4 “Boot Scootin Bow” (Bruce Clarke) were observed to be in very close quarters. Upon reviewing video
