10/05/13 (1) **Qualifying Entries**

The race office was open this morning accepting entries for Qualifying Races to be conducted this afternoon commencing at 4:00pm. The resultant qualifying sheet showing twenty four (24) head participating in four (4) qualifying races.

10/05/13 (2) **Horseman's Meeting**

A brief meeting was convened in the paddock. The purpose of which was to review procedures to be followed during the meet. In particular, the ramifications of the new draw schedule which requires entries by 9:00am each Monday for the weeks racing. Also emphasized was the situation with no one being allowed to live in the tackrooms.

10/05/13 (3) **Qualifying Races**

Four (4) qualifying races were conducted commencing at 4:00pm with twenty (20) of twenty four (24) participants successful in their qualifying efforts.

10/05/13 (4) **Tenth Race Inquiry/Disqualification**

The "inquiry" sign was posted at the conclusion of the tenth race in order to review an incident at the head of the stretch in which #4 "Lodi Dorian Blues" (James Kennedy) broke stride while in close quarters with #2 "AJ's Little One" (George Luster) the eventual second place finisher. After reviewing video and speaking with Driver Kennedy (Driver Luster failed to come to the phone) the stewards unanimously concluded that #2 had interfered with #4 costing #4 an opportunity for a better placing thus #2 was seventh placed in the official order of finish. Driver George Luster was ordered to film review.

10/05/13 (5) **Twelfth Race/ Inquiry**

The "inquiry" sign was posted in order to review an incident in mid stretch when #5 "Asgoodasioncewas" (Gene Vallandingham) the eventual sixth place finisher, #6 "mighty Fine Hi Ho" (Lemoyne Svendsen) and #3 "Gusty Winds Ahead" (Tim Maier) were observed to have been in extremely close quarters. After reviewing video it was unanimously determined that #5 had interfered with both #6 and #3 in mid stretch. However, #5 had finished behind both horses in the official order of finish. Consequently no change was necessary. Driver Vallandingham was ordered to film review.

10/05/13 (6) **Thirteenth Race Recall/Scratch**

As the field assembled for the thirteenth race, #1 "Little Bit Country" (Steve Wiseman) "refused the gate" after conferring (by radio) with driver Wiseman and Outrider Billy Don Wainscott the stewards scratched #1. A second attempt at a start went off with no problems.
