07-20-12¹ **RULING NO. 6 – BAZE**
Jockey **RUSSELL BAZE**, who was scheduled to ride **MRS. COCORAN** in the fifth race on July 19, 2012 is hereby fined the sum of one hundred dollars (\$100.00) for failure to fulfill his mount; a violation of California Horse Racing Board rule #1872 (Failure to Fulfill Jockey Agreement).

The above ruling was issued after Baze failed to arrive in time for his first mount. He apologized and accepted the penalty without argument.

07-20-12² **RULING NO. 7 – GLEASON**
Owner **ELAINE GLEASON**, having now resolved the outstanding financial obligation to San Francisco Equine, Inc., is hereby restored to good standing and Pacific Racing Association Ruling #28, dated November 17, 2011, suspending Elaine Gleason for violation of California Horse Racing Board rule #1547 (Failure to Appear) is set aside.

The above ruling was issued after Lisa Rodriguez of San Francisco Equine reported the outstanding balance of \$1,813 has been paid in full.

07-20-12³ **RULING NO. 8 – TOROK**
Trainer **SANDY TOROK**, who was scheduled to start **DASHIN CASANOVA BE** in the first race at the California State Fair (Sacramento) on Thursday, July 19, 2012, is fined two hundred dollars (\$200.00) for violation of California Horse Racing Board rule #1629 (Penalty for Late Declaration – Identification).

The above ruling was issued after Torok was contacted and accepted the penalty for entering an ineligible horse.

07-20-12⁴ **WAGERING POOLS CANCELLED**
Show wagering was deleted from today's second race, a seven horse Arabian race. Place and show wagering were eliminated from today's five horse third race for thoroughbreds. Show wagering was cancelled on today's six horse fourth race for thoroughbreds.
Arabian representative Mei Davis complained about show wagering being cancelled on the second race. She was also complaining that place and show wagering are cancelled for tomorrow's second race, a ten horse Arabian event. Ms. Davis was directed to bring her complaints to management and the CHRB Board office.

07-20-12⁵ **RACE DELAY – Scratch - Sixth Race**
#8 WILD SONG (Tr. Terri Eaton) ran off after breaking through the starting gate after unseating rider David Lopez. No injuries to horse or jockey. The race was delayed for eight (8) minutes while the outriders captured the loose horse. WILD SONG was scratched by the stewards.

07-20-12⁶ **RACE DELAY – Eighth Race**

The eighth race was delayed for approximately twenty-five (25) minutes due to a couple of incidents. A female patron passed out and fell hitting her head near the Winner's Circle. The track ambulance was called into action as it was near the finish line awaiting the start of this mile event. First aid was contacted and soon took over for the track ambulance. As the horses were starting to load #2 PINE DRIVE unseated apprentice jockey Shyann Garcia who sustained minor injury (see accident report). Apprentice jockey Irving Orozco was called on to replace Garcia.

Saturday07-21-12¹ **RULING NO. 9 – MATOS**

Trainer **GIL MATOS**, who started the horse **PROUD ILLUSION** in the second race on June 16, 2012 at Golden Gate Fields, is hereby fined the sum of five hundred dollars (\$500.00) pursuant to California Horse Racing Board rule #1887 (Trainer to Insure Condition of Horse) for violation of California Horse Racing Board rule #1843 (a) (Medication, Drugs and Other Substances – Flunixin – 32.4.ug/ml [Class 4]).

The above ruling was issued after Matos appeared and accepted the penalty. Mr. Matos explained that he only uses bute at the barn and only had this horse treated with Banamine by his vet because the horse showed an allergic reaction to bute. The horse received the shot twenty-eight (28) hours prior to post according to Matos. Slow metabolism was his only explanation.

07-21-12² **JOCKEY ABILITY QUESTIONED – Seventh Race**

Jockey **Marcial Ramirez** was ordered to appear tomorrow before this Board of Stewards. Ramirez obtained a license at Pleasanton and this was his first mount according to available records. Mr. Ramirez did not perform up to our standards for a jockey and a review of his qualifications will be forthcoming.

07-22-12¹ **JOCKEY DOWNGRADE** (Ref: 07-21-12²)

Jockey **Marcial Ramirez** appeared before this Board of Stewards for two reasons: 1) He is taking 125 lbs. as a new rider and 2) He rode a thoroughbred very poorly yesterday showing a need for more seasoning. Mr. Ramirez is comfortable with riding mules and understood why the stewards told him that he would be downgraded to riding 'mules only' until his weight comes down and his ability improves in the eyes of the stewards.

07-22-12² **JOCKEY IN**

Jockey **Barrington Harvey** was cautioned to keep his mount straight in the stretch after reviewing the seventh race from yesterday.

07-22-12³ **HORSE EUTHANIZED**

#11 HUSKY GLORY (Tr. Genaro Vallejo) went lame near the 1/8 pole. Jockey Victor Carrero was able to pull #11 up without falling. Dr. Clifton found it necessary to euthanize HUSKY GLORY due to catastrophic injury to its left front leg.

07-22-12⁴ **TRAINER RESPONSIBILITY ISSUE**

Verification of **Robert Berrett's** insurance was questioned today. Mr. Berrett has not participated at this meet and trainer Mike Lenzini was listed as sub-trainer. In order to comply with insurance coverage Mr. Lenzini submitted a letter accepting full responsibility as trainer.

07-22-12⁵ **TRACTOR BREAKDOWN – Ninth Race**

While renovating the track for the ninth race one of the tractors pulling a harrow blew up in a cloud of smoke. After much effort the crippled tractor was taken off the track. The horses came on the track at one (1) minute to post and given extra time to warm up. Last post was delayed approximately five (5) minutes.
