PRE-MEET

The judge's stand was inspected today prior to this year's 11 day stand at the California State Fair. The brand new "Mawsafe" inside rail has been installed and is a very bright white in color. Steward's supplies were situated and set up in preparation for the three (3) week meet that will be held for the first time this year.

PRE-MEET

The steward's office was open today at Cal Expo. The previous week's (Alameda County Fair) minutes were completed. Tom Doutrich (Racing Secretary) and Kevin Ingram (Stable Superintendent) were on hand in their offices adjoining the steward's office and gave updates of the upcoming meet.

Wednesday

07-08-15¹

SCRATCH/ENTRY DAY

Scratches and changes for the opening day card to be held on Friday, July 10th took place this morning in the racing office. One (1) equipment change and one (1) jockey change were made. Both changes were activated after the 9:00 a.m. deadline.

The racing office was open today accepting entries for Saturday, July 11th. Nine (9) races were drawn. 56 horses are scheduled to face Starter Todd Stephens.

07-08-15² **MEDIA LUNCHEON**

The California Authority of Racing Fairs (CARF) sponsored a luncheon today to promote this year's 2015 version of the California State Fair. Media members Debbie Arrington (Sacramento Bee) and Jack Shinar (Blood-Horse Magazine) were both in attendance. Local television station Fox 40 will have representatives here tomorrow. California State Fair Chief Executive Officer Rick Pickering and CARF Chief Operating Officer Larry Swartzlander welcomed the thirty (30) or so people in attendance. New State Fair Announcer/Morning Line Maker Dave Rodman, who comes here from Maryland also gave an entertaining talk. The speakers talked about recent improvements including the aforementioned "Mawsafe" inner rail, construction of backside living quarters and water conservation efforts here at the California State Fair.

Thursday

07-09-15¹ **SCRATCH/ENTRY DAY**

Scratches and changes for Saturday, July 11th were accepted this morning in the racing office. One (1) equipment change and five (5) jockey changes were submitted. All changes were activated after the 9 a.m. deadline.

The racing office was open today accepting entries for Sunday, July 12th. Nine (9) races filled with sixty six (66) horses are scheduled to start.

Friday

07-10-15¹ **RULING NO. 1 – JJJ THOROUGHBRED LLC RULING**

Assistant Trainer Janet Hollendorfer contacted the stewards to inform us that Owner Jonathan Ross Frankel (DBA JJJ Thoroughbred Racing LLC) had paid in full a past due training bill in the amount of \$7,090.00.

Owner **JONATHAN ROSS FRANKEL DBA JJJ THOROUGHBRED RACING LLC** having settled his financial obligation in accordance with case 15GG0067 is hereby restored to good standing. Ruling #5 issued at Oak Tree at Pleasanton on June 21, 2015 is hereby set aside.

07-10-15² **RULING NO. 2 – ETIENNE DESOMER RULING**

Driver Etienne J. Desomer is a Standardbred participant who is currently attempting to drive on the Kentucky Fair circuit. Desomer failed to appear at a hearing at Cal Expo Harness in November of 2011. Donald Fowler who operates the backstretch kitchen and the driver's room café alleged that in 2011 Desomer owed him \$828.00 in café/cafeteria items. Desomer contacted the steward's today after being contacted in Kentucky in regards to his California suspension. Vendor Donald Fowler told the stewards today that five hundred dollars (\$500.00) would satisfy the outstanding bill. Vickie Desomer delivered a check today for \$500 and the stewards subsequently issued the ruling below.

Driver **ETIENNE J. DESOMER** having settled his financial obligation in accordance with case #11SW-0060 is hereby restored to good standing. Cal Expo Harness Association (Sacramento) ruling #35, dated November 19, 2011 is hereby set aside.

07-10-15³ **RULING NO. 3 & 4 – JESUS VELAZQUEZ INFORMAL HEARING**

Jockey Jesus Velazquez appeared in the steward's office in order to address two (2) separate matters this afternoon.

Jockey Velazquez was aboard #1 AYERS who finished sixth in the second race (Sheikh Zayed Sultan A. Nahyan Arabian Cup - \$47,800 estimated) on July 5, 2015 at the recently

concluded Oak Tree at Pleasanton meeting.

Velazquez was disqualified and placed ninth (last) in this race (REF: 07-05-15³) for interference at the start. Race replays show #1 AYERS break outward and then continue to drift out affecting a total of four (4) rivals to his outside. Films show that Velazquez was very slow to correct his mount and his actions led to significant interference. Velazquez accepted responsibility and understood the stewards following unanimous decision.

Jockey **JESUS VELAZQUEZ** who rode **AYERS** in the second race at the Alameda County Fair (Pleasanton) on Sunday, July 5, 2015, is suspended three (3) racing days (July 17, 18 and 19, 2015) for failure to make a proper effort to maintain a straight course causing interference down the backside, resulting in a disqualification. A violation of California Horse Racing Board rule #1699 (d) & (f) (Riding Rules – careless riding).

Jockey Jesus Velazquez remained in the steward's office to review another film. Velazquez was aboard #6 MONSAJEM HEIGH who finished second in the third race on July 5, 2015 at the recently concluded Oak Tree at Pleasanton meeting. Velazquez croppered his horse over ten (10) times in the final furlong of this race. Velazquez told the stewards he forgot about CHRB Rule 1688 (Use of Riding Crop) that became effective July 1, 2015 which requires a jockey to give a horse a chance to respond after a jockey uses his crop three (3) times. In a unanimous decision, the stewards issued the following ruling:

Jockey **JESUS VELAZQUEZ** who rode **MONSAJEM HEIGH** in the third race at the Alameda County Fair (Pleasanton) on July 5, 2015 is hereby fined Two Hundred Dollars (\$200)* for violation of CHRB rule #1688 (Use of Riding Crop – used more than three times without giving the horse a chance to respond).

07-10-15⁴ **STEWARDS – INVESTIGATORS MEETING**

CHRB General Counsel Phillip Laird chaired a meeting in the steward's office this afternoon which was attended by the Cal Expo stewards and most of the Northern California CHRB investigative unit. Along with Mr. Laird present at today's meeting were CHRB Investigators Carol Ann Nolan, Duane Tadlock, Joe Mulligan and Derrick Merritt. Safety Steward Tom McCarthy was in attendance along with stewards Grant Baker, John Herbuveaux and Will Meyers. Some of the discussion involved formal and informal hearing procedures. Some discussion involved investigator/steward joint cooperation.

Several topics were covered during this meeting. Some of those were:

- A. Giving proper notice
- B. When to obtain a court reporter
- C. How to obtain a translator
- D. Steward's ability to obtain licensee history
- E. Sharing of office equipment
- F. Interpretations of being 'under the influence'
- G. Timing of stewards receiving complaint packets

An excellent 'back and forth' took place between all parties in attendance. Mr. Laird told the stewards that these meetings will be held more often and that they will be held on the first day of each California race meet.

07-10-15⁵ **RACE #1 - HUMAN AMBULANCE DELAY / ACCIDENT**

Horses were called back to the paddock prior to this meet's first race as the human ambulance for the races was not on the grounds. The human ambulance (American Medical Response) arrived on the grounds at 3:38 p.m. Post time for the first race was 3:30 p.m. Horses for the first race were then sent back out on the racetrack to warm up after the arrival of the ambulance.

Prior to the start of this race #3 SEPARATE GIFT JH3 reared in the starting gate injuring Jockey Luis Godoy (an accident report is attached to these minutes). Track Veterinarian Forrest Franklin examined #3 SEPARATE GIFT JH3 and determined he was fit to race. This horse was brought back to the paddock, resaddled and replaced with Jockey Pedro Flores. SEPARATE GIFT JH3 went on to a very competitive second place finish.

This race eventually went off at 3:54 p.m. Cal Expo Director of Racing Larry Swartzlander was contacted and has provided a letter of explanation regarding the ambulance that will accompany these minutes. A CHRB investigator was apprised of the matter.

07-10-15⁶ **TIMER PROBLEM**

The electronic timing system for the first race going 350 yards did not work. CARF Director of Racing Larry Swartzlander was informed of the problem. This race was hand timed by clocker/timer Melody Truitt.

07-10-15⁷ **RELATIVELY PROBLEM FREE**

Other than numerous incidents regarding today's first race, today's opening day eight (8) race card went well as it was free of steward's inquiries and/or jockey's objections.

07-10-15⁸ **JOCKEY'S GUILD REP**

Jockey's Guild Western Regional Manager Darrell Haire stopped by the judge's stand today. Darrell shared with the steward's happenings at racetracks in the western United States. Of primary discussion was our current enforcement of CHRB rule #1688 (Use of Riding Crop), an obviously important rule to the jockey's he represents in California.

07-11-15¹ **RULING NO. 5 & 6 – MARCIAL RAMIREZ MEETING**

Jockey Marcial Ramirez appeared in the steward's office to address issues with the stewards today. He was accompanied by Trainer Humberto Loma who served as an interpreter. Jockey Ramirez was aboard #2 FIRST REGAL CHOICE who finished fourth in the third race (\$10,000 – Jack Robinson Handicap – Oak Tree at Pleasanton) which was a Quarter Horse racing going three hundred and fifty (350) yards. Jockey Ramirez used his crop six (6) times. The stewards, in a unanimous vote, issued the following ruling:

Jockey **MARCIAL RAMIREZ** who rode **FIRST REGAL CHOICE** in the third race at the Alameda County Fair (Pleasanton) on July 4, 2015 is hereby fined Two Hundred Dollars (\$200)* for violation of CHRB rule #1688 (Use of Riding Crop – used more than three times without giving the horse a chance to respond).

Jockey Marcial Ramirez remained in the steward's office in order to discuss his actions on the day of Sunday, July 5, 2015 when he failed to fulfill his riding assignment aboard #2 OUI MAN in the tenth race on closing day at the Oak Tree at Pleasanton meeting. Ramirez told the stewards he went to a friend's ranch in Tracy, California and got stuck in traffic on his way back to the racetrack in Pleasanton. Ramirez did not request permission to be late on this day. Approximate post time for this race was 5:58 p.m. In a unanimous decision the stewards issued the following ruling.

Jockey **MARCIAL RAMIREZ** is fined the sum of One Hundred Dollars (\$100.00)* for failure to ride the horse **OUI MAN** in the tenth race on Sunday, July 5, 2015 at the Alameda County Fair (Pleasanton); a violation of California Horse Racing Board rule #1872 (Failure to Fulfill Jockey Agreement).

07-11-15² **RULING NO. 7 – BRIAN KOZAK INFORMAL HEARING (AMENDED CASE#15GG0066)**

Trainer **BRIAN KOZAK**, who started the horse **SAM SLICK**, winner of the tenth race at Golden Gate Fields on May 16, 2015, is fined the sum of Five Hundred Dollars (\$500.00)* pursuant to California Horse Racing Board rule #1887 (Trainer to Insure Condition of Horse) for violation of CHRB rule #1843 (a) & (d) (Medication, Drugs and Other Substances: Unapproved Substance – Guaifenesin [Class 4]).

The ruling above was issued after the stewards spoke with Trainer Brian Kozak who is currently racing at Northlands Park in Edmonton, Alberta. The original complaint was amended in order to add rule 1843 (a), (b) and (c) (Medication, Drugs and Other Substances).

Trainer Kozak told the stewards he gives all his medications orally and he thought there was a mix up with his horses feed tubs in his shed row. The decision in the ruling was unanimous.

07-11-15³ **RULING NO. 8 & 9 – SILVIO AMADOR MATTERS**

Jockey Silvio Amador appeared in the steward's office today accompanied by interpreter/valet Joe Hernandez. The stewards wanted to review three (3) incidents that took place with Amador on Sunday, July 5th which was closing day at the Oak Tree at Pleasanton (Alameda County Fair) meeting.

The first matter regarded Jockey Amador's late arrival to the paddock for the third race on July 5th. Pleasanton Paddock Judge Matt Nichols informed the stewards that Amador came out of the jockey's room with about seven (7) minutes to post while other jockeys were ready to mount their horses. Jockey Amador attributed his tardiness to problems he was having with his safety vest. Golden Gate Fields stewards fined Amador fifty dollars (\$50.00) for a similar incident on June 6, 2015 (REF: GGF Ruling #90). In a unanimous decision the following ruling was issued:

Jockey **SILVIO AMADOR** is hereby fined the sum of One Hundred Dollars (\$100.00)* pursuant to California Horse Racing Board rule #1530 (Case Not Covered by Rules and Regulations) for reporting late to the paddock for the Third race on Sunday, July 5, 2015.

The stewards also wanted to review the ninth race from Sunday, July 5th (Oak Tree at Pleasanton) with Jockey Amador. He was aboard #2 FOOLHARDY who finished second in this one and one quarter mile event. Race replays show Amador crop his horse four (4) consecutive times during the stretch run of this race. All three (3) stewards felt this was a clear violation of CHRB rule #1688 (Use of Riding Crop) which became effective on July 1, 2015. The following ruling was issued:

Jockey **SILVIO AMADOR** who rode **FOOL HARDY** in the Ninth race at the Alameda County Fair (Pleasanton) on July 5, 2015 is hereby fined the sum of Two Hundred Dollars (\$200.00)* for violation of CHRB rule #1688 (Use of Riding Crop – used more than three times without giving the horse a chance to respond).

In a third matter the stewards reviewed the sixth race from yesterday July 10th with Jockey Amador. He finished fifth aboard #7 IT'SALLYOURSBABY in this race and was up high in the saddle while crossing the finish line. The stewards told Amador to 'stay down' in the saddle while crossing the finish line.

07-11-15⁴ **HAROLD 'DON' HARRISON COMPLAINT (CASE NO: 15GG0072)**

The CHRB filed a complaint against owner Harold 'Don' Harrison for alleged violation of CHRB rule #1876 (Financial Responsibility). Owner/Trainer Jim Bumgardner had claimed that owner Harrison owed him \$1,395.00 for horse training fees that were past due. CHRB Investigator Duane Tadlock informed the stewards that the full amount in this matter had been paid and therefore the complaint has been withdrawn.

07-11-15⁵ **TIMER PROBLEM (REF: 07-10-15⁶)**

The electronic timer for today's third race failed to operate for today's three hundred and fifty yard Quarter Horse event. Fair officials will be contacted.

07-11-15⁶ **KIRK BREED STATUE DEDICATION**

A special ceremony was held behind the winner's circle following the running of the California Governor's Cup (Purse \$50,000 added) which was won by #1 HANDFULL (Trainer Jerry Hollendorfer/Jockey Russell Baze).

This ceremony was for the unveiling of a life-size bust, complete with cowboy hat, of the late Kirk Breed. Mr. Breed was Executive Director of the CHRB from 2008 to 2013. Mr. Breed was also a lobbyist for the Pacific Quarter Horse Association. Prior to that he was the General Manager of the California State Fair from 1979 to 1985.

This bust was crafted by local Folsom artist Larry Stark. Kirk's wife Mary Ann and children were here today for the celebration. Also present today were the Honorable Steve Beneto (Commissioner), CHRB Executive Director Rick Baedeker, California State Fair Chief Executive Officer Rick Pickering and California State Fair Board Members Sonny Chong, Rex Hime, David Mallel, Mark Nelson and Craig Gallagher. Speakers included Mary Ann Breed, Rick Baedeker and Rick Pickering. The bust and plaque are beautiful and will stand at the entrance to the Cal Expo grandstand as a tribute to the life and memory of Kirk Breed who died in August of 2013 at the age of 73.

07-11-15⁷ **EXECUTIVE DIRECTOR VISIT**

CHRB Executive Director Rick Baedeker paid a visit to the judge's stand today. The stewards appreciated the visit.

07-11-15⁸ **RACE #6 – STEWARDS REVIEW**

The stewards called for a 'steward's review' following the start of the sixth race which was contested at six (6) furlongs. Sixth place finisher #1 CHARLIES SWELL (Frank Alvarado) ducked in sharply at the break nearly unseating Jockey Alvarado. This horse caused his own problems and the steward's detected 'no interference.' After a brief review the stewards declared the race official.

Sunday07-12-15¹ **RULING NO. 10 – CRISTOBAL HERRERA**

Jockey Cristobal Herrera along with valet/interpreter Andy Gutierrez attended a film review with the stewards this morning. The stewards wanted to review the ninth race from yesterday Saturday, July 11th. Jockey Herrera was aboard sixth place finisher #6 SEVENS LUCK and used his riding crop four (4) consecutive times in the stretch drive of the race. Herrera acknowledged this but both he and valet/interpreter/advocate Gutierrez felt a warning was in order. The stewards told these gentlemen that a May jockey's room meeting at Golden Gate Fields and two (2) meetings at Pleasanton (June/July) were considered warnings for Rule 1688 (Use of Riding Crop). The decision was unanimous. The following ruling was issued.

Jockey **CRISTOBAL HERRERA** who rode **SEVENS LUCK** in the Ninth race at the California State Fair (Sacramento) on July 11, 2015 is hereby fined the sum of Two Hundred Dollars (\$200.00)* for Violation of CHRB rule #1688 (Use of Riding Crop – used more than three times without giving the horse a chance to respond).

07-12-15² **TOTE PROBLEMS**

There were tote problems during or after two (2) races today at Cal Expo. Betting could not be locked from the judge's stand as the placing console froze. Scientific Games Technician Michelle Arendt immediately stopped all betting from her tote room location.

Following the running of the ninth race, the accurate order of finish was entered in the judge's stand however the tote board showed #16 finishing second. There obviously was no #16. There were originally ten (10) horses slated to start before the mid-morning scratch of #1 BEAUTIFUL DESERT. The stewards made the race official without the order of finish posted. On track patrons were directed by the track announcer Dave Rodman to check the TV monitors on track and on the satellite network. The correct order of finish appeared on the infield tote board about two (2) minutes after going official.

07-12-15³ **RACE #6 – INQUIRY**

The inquiry sign was posted after #8 JACKSON STRUTT (Hugo Herrera) ducked out sharply and unseated his rider at the start of this five (5) furlong race. This horse started from the outside post position and no other horses were affected. Jockey Herrera was examined by paramedics and cleared to ride in the next race. The stewards let the original placings stand. Accident report attached.

07-12-15⁴ **JUDGE'S STAND VISITORS**

Sisters Kimberly Krausch and Candace Mitchell paid the stewards a visit today at Cal Expo. Both are former employees at Golden Gate Fields. They are the daughters of the late Lloyd and Charlotte Dorn who were key officials at Golden Gate during the sixties, seventies and eighties. Kimberly was the steward's secretary and in charge of backside mail distribution for nearly three (3) decades.

07-12-15⁵ **TRAILER PARK FIRE**

A house trailer located across the road that begins at entrance gate 12 at Cal Expo was engulfed with flames following today's seventh race. This trailer area is located very close to the ¾ chute. Smoke from the fire was blowing towards the racetrack prior to the start of this six (6) furlong race. Tanker trucks from the nearby Sacramento Metro Fire Department were quickly on the scene to quell the very significant flames. The eighth and

ninth races went off at their scheduled post times.




