 Saturday's card is made up of eight races with a total of 52 equines entered. Seven Thoroughbred races and 1 mule race are on tap for Saturday. No Cal-bred races were used.

Friday07-08-16¹**RULING NO. 1 & 2 - GODOY RULINGS****RULING NO. 1**

Jockey **LUIS GODOY** who rode **PLEASE BELIEVE ME** in the First race on Monday, July 4, 2016 at the Alameda County Fair (Pleasanton) is hereby suspended three (3) racing days (July 15, 16 and 17, 2016) for failure to make a proper effort to maintain a straight course after the start and causing interference resulting in the disqualification of his mount from first to fifth; a violation of California Horse Racing Board rule #1699 (d) & (f) (Riding Rules – Careless Riding).

RULING NO. 2

Jockey **LUIS GODOY** who rode **PLEASE BELIEVE ME** in the First race on Monday, July 4, 2016 at the Alameda County Fair (Pleasanton) is hereby fined the sum of two hundred dollars (\$200)* for violation of California Horse Racing Board rule #1688 (d) & (f) (Use of Riding Crop – used more than three times without giving the Mule a chance to respond – second offense).

The above rulings were issued after Mr. Godoy appeared and reviewed the race in question. He apologized for not attempting to straighten the mule stating he felt he was clear. He realized after review that he was not clear.

07-08-16²**RULING NO. 3 - PORRECA RULING**

In the Matter of: Owner **ANTHONY EDWIN PORRECA**

Having now satisfied the outstanding financial obligation to Trainer Terri T. Eaton the license privileges of **ANTHONY EDWIN PORRECA** are restored to good standing and Mr. Porreca is deemed eligible to be relicensed.

Further, Pacific Racing Association ruling #20, dated October 31, 2008, suspending Mr. Porreca for violation of California Horse Racing Board rule #1547 (Failure to Appear) is hereby set aside.

The above ruling was issued after Ms. Eaton was contacted by Safety Steward Richard Lewis and stated she was given payment and signed a paid in full agreement. The stewards obtained a copy of said agreement.

07-08-16³**RACE #1 - INQUIRY - NO CHANGE**

#2 INCENTIVE AWARD stumbled at the start unseating jockey Kyle Frey. After review it was determined that #2 stumbled of its own accord and no interference was detected. Jockey Frey suffered an injury to his right shoulder and was taken off his remaining mounts by Dr. Streeter, Track Physician. Accident report attached.
