1 WESLEY WARD RULING

RULING #81

Trainer Wesley Ward is fined three hundred dollars (\$300.00)* pursuant to California Horse Racing Board Rule #1629 (Penalty for Late Declaration), for failure to have the foal certificate in the Racing Office, necessitating the late declaration of "Goodbye Norma Jean" from the third race on Wednesday, August 29, 2007, at Del Mar Thoroughbred Club

The ruling above was issued after the stewards spoke with Trainer Wesley Ward by telephone. Trainer Ward, who was in Florida, stated that the foal certificate for the aforementioned horse was at a location in Orlando, Florida where he would be unable to retrieve them.

2 DMTC BACKSIDE SECURITY NOTICES

3 MICHAEL BAZE FILM REVIEW

Jockey Michael Baze appeared in the stewards' office to review his ride in the seventh race Monday August 29th. Jockey Baze was involved in a stewards' inquiry in which his mount #5 "Our Partner" makes slight contact with sixth place finisher #1 "Bronzino" (Mike Smith) #5. "Our Partner", who finished fifth, was closing stronger than #1 "Bronzino". Jockey Smith steadied his tiring mount when Jockey Baze 'cut it close' while passing. Jockey Baze was issued a warning in this matter.

4 SIXTH RACE INQUIRY/DISQUALIFICATION

The stewards posted the Inquiry sign following this one-mile turf race. Just inside the 1/16th pole # 4 "Valiant Effort" (Michael Baze) ducked in sharply under right handed whipping. At this point "Valiant Effort" breaks through the temporary inner railing. Jockey Baze showed great balance, miraculously staying on his mount. "Valiant Effort" then re-entered the main course finishing ninth. "Valiant Effort" was placed on the steward's list, as he was hard to manage throughout the race.

For leaving the racecourse the stewards disqualified #4 "Valiant Effort" and placed him 'unplaced'.

1 FAIRPLEX PARK VS. DAVID YOUNG

The stewards held an informal hearing today regarding a security violation notice issued by Fairplex Park Security Officer Gene ‘Corky’ Gray. This notice was issued alleging ‘verbal threats and ‘racial comments’ made by Groom David Young towards Pony Boy/Association Employee Jeffery ‘J.J.’ Stoudmire. Hotwalker Linda Fulko was also present at the hearing. Young and Fulko stated that they work for Trainer Uri Rafaelli at Fairplex Park.

The nature of this alleged incident made it apparent to the stewards that a court reporter would be needed. A formal hearing date was set with all parties present. All parties were told to ‘stay away’ from one another until a new scheduled formal hearing date of September 12th at 9:30 a.m. at Fairplex Park.

2 EIGHTH RACE INQUIRY

The stewards posted the Inquiry sign after observing an incident with less than sixty (60) yards before the finish. Second place finisher #6 “Instant Action” (Aaron Gryder) steadied at this juncture when first place finisher #2 “Laday Tale” (Corey Nakatani) drifted outward.

The margin at the finish line between these two (2) rivals was ¾’s of a length. While this incident did warrant an inquiry, the stewards unanimously felt the incident fell short of changing the official order of finish. The steward’s spoke with both jockeys involved, viewed race replays and received patrol judge input before declaring the race official. Jockey Corey Nakatani was ordered to film review.

1 AARON GRYDER RULING

RULING #88

Jockey Aaron Gryder is fined Fifty Dollars (\$50.00)* for violation of California Horse Racing Board Rule # 1530 (Cases Not Covered by Rules & Regulations – Failed to Sign In - Jockeys Room) on August 25, 2007.

The ruling above was issued after the stewards noticed an omission on the daily jockey’s sign-in sheet. Jockey Gryder was issued a warning by the stewards earlier this meet.

2 JOSEPH TALAMO RULING

RULING #89

Jockey Joseph Talamo, having withdrawn his appeal of DMTD Ruling #003 dated July 20, 2007, in which he was suspended for three (3) racing days for violation of California Horse Racing Board Rule # 1699 (Riding Rules), the suspension days are reimposed and the license of Joseph Talamo is suspended for three (3) racing days (September 28th, 29th, and 30th, 2007).

The terms of this suspension shall not prohibit participation in designated races in California.

The ruling above was issued after Joseph Talamo’s Del Mar based attorney (Bing Bush) contacted the California Horse Racing Board. Mr. Bush requested that the appeal of Jockey Talamo’s early meet suspension (Ruling #3) be withdrawn. This ruling was issued immediately after the stewards received an ‘Order of Remand’ (Case No. SAC 07-0062) from the CHRB.

3 MICHAEL BAZE RULING

RULING #90

Jockey Michael Baze, having withdrawn his appeal of DMTD Ruling #018 dated July 28, 2007, in which he was suspended for three (3) racing days for violation of California Horse Racing Board Rule # 1699 (Riding Rules), the suspension days are reimposed and the license of Michael Baze is suspended for three (3) racing days (September 29th, 30th, and October 3rd, 2007). The terms of this suspension shall not prohibit participation in designated races in California.

The ruling above was issued after Michael Baze's Del Mar based attorney (Bing Bush) contacted the California Horse Racing Board. Mr. Bush requested that the appeal of Jockey Baze's early meet suspension (Ruling #90) be withdrawn. This ruling was issued immediately after the stewards received an 'Order of Remand' (Case No. SAC 07-0065) from the CHRB.

4 COREY NAKATANI FILM REVIEW

Jockey Corey Nakatani appeared in the stewards' office to review the running of yesterday's (August 30) eighth race. Jockey Nakatani survived a steward's inquiry, in deep stretch, while aboard (Ref 8/30/07 (2)) first place finisher #1 "Laday Tale". The stewards also wanted to 'go over' an incident at the start of this race.

Shortly before the finish, Jockey Nakatani ("Laday Tale") drifted out while second place finisher #6 "Instant Action" (Aaron Gryder) is racing on his outside. In the incident at the start Jockey Nakatani drops his left rein thereby allowing his mount to drift out, contributing to interference on his outside.

The stewards deliberated and then called Jockey Nakatani into their office and informed him this was 'close' to a suspension type ride. Warning issued.

5 SIXTH RACE INQUIRY/DISQUALIFICATION

The stewards posted the Inquiry sign following this turf race after viewing an incident at the 1/16th pole. While driving for the lead third place finisher #8 "Wondrous Event" (Michael Baze) drifts inward under right handed whipping. After drifting inward, Jockey Baze and his mount make contact with the far side of fourth place finisher #7 "Carly Effect" (Alonso Quinonez) knocking him inward.

Two (2) other horses racing along the inside were forced to steady sharply due to this occurrence. Fifth place finisher #1 "Lady in Love" (Tyler Baze) and sixth place finisher #3 "Bright Moon" (Mike Smith) were also 'bothered' by this occurrence.

Fourth place finisher #7 "Carly Effect" was beaten a 'head' for third position in this race. The stewards unanimously ruled that this interference necessitated #8 "Wondrous Event" to be disqualified and placed fourth. Jockey Mike Baze was ordered to film review.

1 JOESPH TALAMO FILM REVIEW

Jockey Joseph Talamo appeared as directed in the stewards' office to review his ride from yesterday's (September 1) seventh race. Jockey Talamo was involved in a stewards inquiry that took place about sixty (60) yards before the finish.

Jockey Talamo was aboard #13 "Chop House George" who finished third, while bothering fourth place finisher #14 "Honouramongfriends" (Michael Baze).

The stewards felt Jockey Talamo was only partially to blame for this incident. His mount made a quick duck outward without warning in the final stages of this race. No sanction issued.

2 BRUCE HEADLEY HEARING (COMPLAINT NO:07DM047)

Trainer Bruce Headley failed to make the proper notification of the altering of the sex of the horse to the horse identifier and racing secretary. This was Trainer Headley's second violation of CHRB Rule #1865 this meet. He plead guilty over the telephone. The following ruling was issued.

RULING #92

Trainer Bruce Headley, is fined five hundred dollars (\$500.00)* for failure to properly report the gelding of the horse "Choctaw Chief" that ran in the sixth race at Del Mar Thoroughbred Club on August 18, 2007, which is a violation of California Horse Racing Board Rule #1865 (Altering of Sex of Horse).

3 GOOD RACING

For the second day in a row, there were no steward inquires or jockey objections throughout the afternoon's card.

4 LATE SCRATCH—DEL MAR DEBUTANTE

Just prior to the eighth race (57th Running-Del Mar Debutante) Assistant Steward Luis Jauregui telephoned the stewards to call attention to a 'situation' at Trainer Jack Van Berg's barn. All horses in this Grade I race were under surveillance by DMTC Security under the supervision of the CHRB.

While surveilling the Van Berg trained "The Golden Noodle", DMTC security notified Assistant Steward Jauregui that a 'suspicious' substance was administered to that horse. Assistant Steward Jauregui informed the stewards immediately of this occurrence. The steward's then spoke with CHRB Veterinarian Gary Beck.

A plastic bottle marked 'Glycerin Peppermint' was confiscated from Trainer Jack Van Berg. Trainer Van Berg admitted administrating the substance at his barn before the race. The steward's then discussed their interpretation of CHRB Rule 1843.5. The stewards then informed Trainer Jack Van Berg immediately before the eighth race that #2 "The Golden Noodle" would be a 'late scratch' for the ninth race. More to follow.

Groom Jaime Adrian Garcia is fined Twenty Five Dollars (\$25.00)* for violation of Stable area regulations at San Luis Rey Downs, pursuant to California Horse Racing Board Rule # 1530 (Cases Not Covered by Rules & Regulations – Alcohol on Premises.)

The ruling above was issued after the stewards received a San Luis Rey Downs Violation Notice from their Stable Manager Laura Rosier.

2 PATRICK BIANCONE HEARING (CASE NO:07SA043)

RULING #98

Trainer Patrick Biancone who started the horse "Iron Butterfly" in the second race at Santa Anita Race Track on January 7, 2007 having entered into a stipulated agreement with the California Horse Racing Board, is fined Ten Thousand Dollars (\$10,000.00)* pursuant to California Horse Racing Board Rule #1887 (a) (Trainer to Insure Condition of Horse) for violation of California Horse Racing Board Rule #1843 (a) (b) (c) (d) (Medications, Drugs, and Other Substances – Salmeterol – Class 3) pursuant to the terms of the stipulated agreement, subject shall serve a fifteen (15) day suspension with the suspension stayed pending the passage of one year from the date of this ruling without violation of California Horse Racing Board Rules and Regulations, sections 1843, 1843.6, and 1887, regarding Class 1, Class 2, or Class 3 substances.

The ruling above was issued after the stewards held a hearing in their office. Trainer Patrick Biancone was contacted in Kentucky and testified via speakerphone. Also present were Court Reporter Barbara Weinstein and CHRB Southern Supervising Investigator Bill Westerman.

Trainer Biancone entered into a 'signed settlement agreement' with the CHRB on August 31, 2007. The steward's issuance of Ruling #97 enforces the terms and conditions of that agreement.

A hearing regarding the order of finish in this race (Race 2- SA -January 7, 2007) will be heard at a late date.

3 RACING OFFICIAL CHANGE'S

Placing Judge Robert Moreno is working at Fairplex Park today serving as their Quarter Horse Racing Secretary. Patrol Judge Sue Brent will go to the placing stand to fill in today. Horse I.D. Assistant Leslie Miller will work the 1/8th pole patrol judge stand.

4 EIGHTH RACE INQUIRY

The stewards posted the Inquiry sign to review an incident just inside the ¼ pole. At this point, third place finisher #7 “Phoebe’s Song” (Garrett Gomez) steadies from between horses. Eventual winner #8 “Placid Lake” (Joseph Talamo) was on his outside.

Race replays show fifth place finisher #4 “Hunsley Bunsley” (Alonso Quinonez) causes the majority of the interference by drifting out at the ‘top of the turn’. After speaking with the riders involved and receiving a patrol judge report, the stewards made ‘no change’ in the order of finish.
