TUESDAY

JULY 21, 2009

1 PRE-MEET MEETING

The annual pre-meet meeting was held this afternoon to discuss the imminent Del Mar meeting. In attendance were Tom Ward (Steward), Ingrid Fermin (Steward), Scott Chaney (Steward), Luis Jauregui (Safety Steward), Joe Harper (President DMTC), Craig Fravel (Vice President DMTC),

Dr. Rick Arthur (CHRB Equine Medical Director), Bill Westermann (CHRB Supervising Investigator), Kirk E. Breed (Executive Director, CHRB), Bill Sullivan (Director of Security), Sam Templeton (Backside Security), Dr. Jill Bailey (Official Veterinarian, CHRB), Dr. Barrie Grant (Racetrack Veterinarian), Marsha Naify (TOC), Ed Halpern (TCC), Darrell Haire (Jockeys' Guild), Tom Robbins (Director of Racing), RoseMarie Stephens (Stewards' Secretary), Lucy Vaillancourt (Stewards' Aide), and Guy Lamothe (TOC). Issues discussed included, but were not limited to, morning soundness examinations, horse ambulance protocol, entry procedures for horses on a prolonged entry schedule, safety or cushion whips, and starting gate safety. Management also reiterated their concern for the safety of the horse, and explained that the examining veterinarians should always err on the side of protecting the animal when deciding whether to scratch a horse is appropriate.

WEDNESDAY
JULY 22, 2009

1 MEETING REGARDING SAFETY

The stewards met with Risk Management director Kim Jacobsen as well as the morning and afternoon outriders to discuss emergency procedures as well as overall safety protocol. Also at the meeting were Director of Security Bill Sullivan, Ms. Jacobsen's assistant Jeremiah Mendoza, safety steward Luis Jauregui, Official Veterinarian Jill Bailey and head clocker John Malone. Ms. Jacobsen reviewed safety procedures mainly for morning track related emergencies but conferred with the stewards regarding afternoon protocol as well. All parties were given an opportunity to provide insight and all seemed satisfied with the procedures.

2 JOCKEYS' MEETING

The BOS held its annual meeting with the jockeys; although we had very little to say given the high quality of riding and the low number of inquiries in recent meets. However, the jockeys were introduced to new racetrack veterinarian Dr. Barrie Grant. Management reiterated its strong desire to keep the races as safe as possible and asked the jockeys both to help Dr. Grant in identifying potentially problematic horses and to be cooperative when Dr. Grant asked to see a horse or when recommending a scratch to the stewards. Director of Risk Management Kim Jacobsen reviewed procedures for injured jockeys and Joe Harper welcomed everyone to what he hoped would be a successful and safe meeting.

3 BEJARANO INJURED

Jockey RAFAEL BEJARANO was injured when his horse broke down during the running of the third race. He was transported to the hospital with apparent injuries to his face and shoulder pain. BEJARANO'S mount, Mi Rey (Arg) was removed via horse ambulance and euthanized. See attached accident report.

THURSDAY
JULY 23, 2009

1 VON BLUECHER HEARING

Veterinarian DR. HELMUTH VONBLUECHER met with the stewards informally to discuss case number 09HP149 which was a complaint filed by CHRB Official Veterinarian Dr. William Bell alleging violation of CHRB rule 1842 (Veterinarian Report) for failing to properly report a shockwave therapy treatment. Evidence revealed that the treatment in question was not a shockwave treatment but an equipoise treatment. There was a notation on Dr. VonBluecher's confidential of an equipoise treatment but not on the separate form as required for anabolic steroids. We explained the importance of this paper work, but given the circumstances and license history, we believed a warning was appropriate.

2 HARTMAN RULING

Trainer CHRIS HARTMAN entered his horse "Guiding Hand" in the first race on opening day, but neglected to register him as a bleeder as required by CHRB rules. The horse was previously racing in New Mexico. Mr. Hartman was permitted to register the horse as a bleeder, but was fined in the following ruling for the violation:

DMTD Ruling #1

Trainer Chris Hartman is fined the sum of THREE HUNDRED DOLLARS (\$300.00)* for violation of California Horse Racing Board rule # 1845 (Authorized Bleeder Medication) on July 22, 2009.

3 SANTIAGO COMPLAINT AND FILM REVIEW

Apprentice jockey CHRISTIAN SANTIAGO REYES visited the stewards informally this morning to discuss two matters. The first involved his ride in the fifth race in which we cautioned him that he needs to relieve the pressure when he is on the outside of horses in trouble. The second involved a complaint by the Official Veterinarian through the CHRB alleging a violation of the whip rules. Specifically, case number 09HP0151 alleged that Mr. Santiago cut his mount, Copa de Plata, on the flank with his whip during the running of the fourth race on July 10, 2009 at Hollywood Park. There was photographic evidence to support these allegations. There was little defense and Mr. Santiago accepted the following ruling:

DMTD Ruling #3

Jockey Christian Santiago Reyes is fined THREE HUNDRED DOLLARS (\$300.00)* for violation of California Horse Racing Board rule #1688 (Use of Whip – causing welts or breaks in the skin) in the fourth race at Hollywood Park on July 10, 2009.

4 AVILA HEARING AND RULING

Trainer AC AVILA contacted the stewards by telephone to discuss case number 09HP0130 filed by the CHRB alleging a high bute discovered in the post race blood sample of one of his runners. Specifically, a level of 6.33 ug/ml was found in the post race blood sample of "One Shot (ARG)" who won the second race at Hollywood Park on June 21, 2009. This overage was confirmed by a split sample test requested by the trainer. Mr. Avila did not really have an explanation for the overage. After careful deliberation, this BOS agreed upon the following penalty, based in part, on Mr. Avila's poor NSAID history:

DMTD Ruling #4

Trainer Antonio Avila, who started the horse "One Shot" which finished first in the second race at Hollywood Park Racetrack on June 21, 2009, is fined Fifteen Hundred dollars (\$1500) * pursuant to California Horse Racing Board rule #1887 (Trainer to Insure Condition of Horse) for violation of California Horse Racing Board rules # 1844 © (1) (Authorized Medication – Phenylbutazone, in excess of permitted level).

5 BIANCONE RULING

Trainer PATRICK BIANCONE contacted this office and explained that his horse "Whyprincesswhy" was erroneously treated with Clenbuterol precluding her from running in the race in which she had been entered. The horse was scratched and we issued the following ruling:

DMTD Ruling #2

Trainer Patrick Biancone, the trainer of the horse Whyprincesswhy that was entered in the second race at Del Mar July 23, 2009, is fined FIVE HUNDRED DOLLARS (\$500.00) * for violation of California Horse racing Board rules # 1844 (b) (Authorized Medication –administered medication within 24 hours of a race) and # 1629 (Penalty for Late Declaration).

6 JACOBSEN MEETING

The stewards asked to meet with Director of Risk Management, Kim Jacobsen to discuss several concerns that manifested themselves during opening day. These concerns were the number and activity of people at the starting gate, paddock security, ambulance route when leaving the racetrack for the hospital, and winner's circle activity. Ms. Jacobsen and Del Mar have always been very responsive to safety concerns, and it appears that this season is no exception.

JULY 24, 2009

1 STEAD RULING

On Thursday afternoon, we were contacted by veterinarian Melinda Blue, who explained that her associate, DANA STEAD, had inadvertently treated a Saturday runner with Banamine and Robaxin rather than the intended bute. The stewards determined that a scratch was necessary and also fined Dr. Stead for the mistake. This was memorialized in the following ruling:

DMTD Ruling #6

Veterinarian Dana Stead is fined FIVE HUNDRED DOLLARS (\$500.00) * for violation of California Horse Racing Board rule # 1843 (b) (Medication, Drugs and Other Substances – Banamine, Methocarbamol) resulting in the declaration of Droumeragh from the eighth race at Del Mar on July 25, 2009.

2 O’NEILL RULING

Trainer DOUG O’NEILL phoned the stewards and explained that he had inadvertently entered a trainee in the incorrect race. After examining the past performances, it became clear that this was in fact the case. Therefore the horse was scratched and the following ruling was issued:

DMTD Ruling #5

Trainer Doug O’Neill, who entered the horse Digestivo in the fifth race at Del Mar on July 24, 2009, is fined THREE HUNDRED DOLLARS (\$300.00) * pursuant to California Horse Racing Board Rule #1629 (Penalty for Late Declaration) for violation of California Horse Racing Board Rule # 1588 (g) (Horse Ineligible to Start in Race).

3 WYGOD MEETING

Owner Martin Wygod and his attorney Roger Licht requested a meeting with the stewards today at 1:30 pm. At the meeting, Mr. Licht requested that Steward Ingrid Fermin recuse herself from races involving any of his horses running at Del Mar, including one in the second race this afternoon. Ms. Fermin considered his request, and in order to avoid a scratch and provide an ample opportunity to carefully consider his request, told him that she would have assistant steward Luis Jauregui in the stewards' stand during the race. Steward Fermin stated that she would make a decision with respect to recusal after the running of the race if the circumstances required it. Fortunately, the race was run without incident, so no decision needed to be made.

JULY 25, 2009

1 FILM REVIEW

Jockey JOE TALAMO came into the office this morning to discuss his ride in the fifth race yesterday in which his mount drifted in, going into the clubhouse turn putting a rival in tight quarters. Films revealed that Mr. Talamo's horse had a tendency to lug in and that he was making a reasonable effort to prevent this behavior.

Apprentice jockey CHRISTIAN SANTIAGO REYES met with the stewards to discuss several races. The first was Thursday's sixth race in which Mr. Santiago Reyes split horses when it appeared that there was really not enough room to do so. He stated that he knew that there was insufficient room but that his horse became very strong and pulled him into the space. To his credit, he did not start riding his horse until there was enough room. The majority believed that enough of the blame could be placed on the horse to spare him a suspension whereas Steward Chaney believed that three days were appropriate. The second incident occurred in yesterday's fourth race in which Mr. Santiago Reyes' horse drifts out during the stretch run. Although he was clear, we emphasized that this type of riding would certainly result in suspension days in the future. He seemed to understand.

Jockey TYLER BAZE met with the stewards to discuss his ride in the fourth race yesterday in which he appears to hit a rival horse in the nose with his whip. The horse that was struck finished in front of Mr. Baze and therefore no inquiry or change was required. Films clearly demonstrated that the contact was inadvertent; nevertheless we cautioned Mr. Baze that he had to be far more careful with respect to using his whip.

2 HARRINGTON COMPLAINT

Trainer MIKE HARRINGTON appeared this morning to address case number 09HP153 which alleged that one of his horses was late to the receiving barn. Dr. Harrington took the blame and was issued a warning due to his spotless record.

3 SAYLER HEARING AND RULING

Trainer JAMES SAYLER called this morning to answer a complaint filed by the CHRB alleging a high bute uncovered after a post workout test in order to be removed from the veterinarian's list. Case number 09HP152 indicated a level of 13.41 ug/ml. Mr. Sayler took full responsibility for the mistake, explaining that he had mixed two bute tablets in his horse's feed the night before the workout. Unfortunately, due to the high level, the following penalty was required:

DMTD Ruling #7

Trainer James F. Sayler, who worked the horse "**Cork Creek**" for removal from the Veterinarian's List at Hollywood Park on July 3, 2009, is fined **ONE THOUSAND DOLLARS (\$1000.00)** * pursuant to California Horse Racing Board rule # 1866 (Veterinarian's List) for violation of California Horse Racing Board rule # 1844 © 1 (Authorized Medication – Phenylbutazone, in excess of permitted Level).

4 PAPAPRODROMOU HEARING

Trainer GEORGE PAPAPRODROMOU contacted the stewards by telephone to answer case number 09HP155 which involved a financial complaint filed by a former employee, Ginove Morales in the amount of \$850.00 for unpaid wages. He acknowledged the debt and said that he would bring the entire amount to Del Mar this coming Friday.

5 YAKTEEN HEARING

Trainer TIM YAKTEEN appeared this morning to address case number 09HP156 which alleged that one of his horses was late to the receiving barn. Mr. Yakteen took the blame and was issued a warning due to his spotless record.

6 INQUIRY/NO CHANGE

Following the running of the seventh race, the stewards put up the inquiry sign to examine an incident around the clubhouse turn on the turf course. Films showed that #4 Thorn Song, while racing on the lead under Mike Smith, ducked out sharply and went to the outside fence. No other horses caused the abrupt movement and Thorn Song did not finish the race so no change was required.

JULY 26, 2009

1 KAENEL HEARING

Former jockey JACK KAENEL requested a fitness for license hearing in order to obtain a jockey’s agent license. After agreeing to a conditional license several years ago, MR. KAENEL left the state. He explained what he had been doing since then, but he lacked documentation regarding his continued sobriety. The BOS will make a decision in the next couple of days.

2 FILM REVIEW

Apprentice jockey CHRISTIAN SANTIAGO REYES met with the stewards to review two races from yesterday. Both races involved Mr. Santiago Reyes angling his horse inward going into the turn causing the horses to his inside to either check or take up sharply. In the first instance, Mr. Santiago Reyes claimed that the horse was running off with him and in the second instance, he blamed the horse to his outside for forcing him in. We didn’t accept either of these explanations as valid and therefore issued the following:

DMTD #8

Jockey Christian Santiago Reyes, who rode # 6 Noblety in the fifth race and #6 E.P. Bombay in the seventh race at Del Mar Thoroughbred Club on July 25, 2009, is suspended for FIVE RACING DAYS (5) (August 2,5,6,7, and 8, 2009) for placing his horses in positions where there was insufficient clearance causing interference in the 7/8ths and 3/8ths turns, respectively. This constitutes a violation of California Horse Racing Board rule # 1699 (d) (Riding Rules – Careless Riding). Terms of suspension shall not prohibit participation in designated races pursuant to California Horse Racing Board rule # 1766 (Designated Races).

Jockey JOEL ROSARIO met with the stewards to discuss his ride in the eighth race yesterday (Eddie Read Handicap) in which his mount drifted out on two occasions. While the first time Mr. Rosario could reasonably claim that he was marginally clear of his rivals, the second time he does cause the two rivals to his outside to shift as well. This action was accompanied by left handed whipping. The majority believed that this action did not rise to the level of days but warned Mr. Rosario that there would be no more warnings, while steward Chaney voted for three suspension days.

3 INQUIRY/NO CHANGE

Following the running of the ninth race, the stewards hung the inquiry sign to examine a point of contact between the first two finishers nearing the finish line. Films revealed that the winner #5 Street

Royale and the second place finisher #6 Low Gear Power made contact in deep stretch, but that the blame for the contact could be assigned equally to the two horses. Despite their close finish, however, no change would have been appropriate. After consulting with the patrol judges and speaking with the riders involved, the stewards made the race official.
