**FILM REVIEW**

Apprentice jockey Drayden Van Dyke met with the Stewards to review the first race yesterday. The BOS wanted to discuss Mr. Van Dyke's drift in the stretch when he switched sticks. The incident was not penalty worthy, but the BOS felt Mr. Van Dyke should meet and discuss the issue. He did state that Mike Smith offered to show him how to take a good hold of his horse, before switching sticks from left to right and vice versa.

**JOCKEY OBJECTION 1ST RACE (3/4 poly) NO CHANGE**

Following the running of the race jockey Rafael Bejarano who finished second on #4 U S Citizen, claimed foul against the winner #5 Fighting On (A. Delgadillo). In a five-horse spread approaching the quarter pole, it was the Stewards' opinion #4 (fourth out) stepped in, got tipped by the horse to his inside, who stepped out slightly. #5 was the fifth horse out and did not effect the bumping to its inside. After consultation with both jockeys and the Patrol Judges the original order of finish was made official.

**INQUIRY 4TH RACE (6 1/2 poly) NO CHANGE**

The Inquiry sign was posted to review an incident in mid stretch. This involved #3 Reneesgotzip (C. Nakatani 3rd) and #5 Amaranth (D. Carr 4th). On the inside, #5 drifted out slightly and was bumped hard by #3 with Mr. Nakatani aboard, who swung his horse inward to change leads. Both jockeys were contacted as well as the Patrol Judges. In the Stewards' opinion the contact did not affect the order of finish. The original order of finish was made official.

**STEIN FORMAL HEARING CASE 14SA160; 14SA161**

The CHRB filed a complaint pursuant to CHRB rules 1844 (Authorized Medication), 1887 (Trainer to Insure Condition of Horse) and 1843 (a)(b) (Medication, Drugs and Other Substances) and 1843.1 (a) (Prohibited Drug Substance). (Case 14SA160) Also in a separate complaint CHRB rule 1859.5 (Disqualification Upon Positive Test Findings)(case14SA161).

Present at the hearing before the BOS were Supervising Investigator Rick Amieva, trainer Roger Stein was available by telephone and court reporter Michelle Derieg documented the proceedings. Mr. Stein’s runner “Luckbox Sam” on May 1, 2014 tested with a positive finding of the class 3 drug Norpseudoephedrine, a metabolite of pseudoephedrine and O-desmethylpyrilamine a metabolite of pyrilamine. These drugs are category “B” penalty guidelines (in accordance with CHRB Rule 1843.3). Mr. Stein stated the horse in question was treated for hives orally. He said his nephew Josh Stein (assistant trainer) treated the horse up to and through the fourth day before the race, which was obviously to close. He also stated that his practicing Veterinarian prescribed the drug and in his opinion, it was not a performance-enhancing drug.

Mr. Stein stated he has returned his licenses to the CHRB and does not plan to participate further in the industry as a licensee. Decision to follow.

**FILM REVIEW**

Jockey Corey Nakatani met with the Stewards to review the fourth race. (Ref-08-17-14<sup>3</sup>). In the stretch run, in a four-horse field the #5 horse with jockey Dennis Carr riding, drifted out slightly. To his outside, #3 with Corey Nakatani, while passing #5, tried to get his mount to switch leads by pulling it into #3 causing a hard bump. Mr. Nakatani was adamant he was doing what was best for his horse. In a majority vote (Jauregui felt the contact was mutual ) Mr. Nakatani was given a three-day suspension. The following ruling was issued.

**DMTD RULING # 030**

Jockey COREY NAKATANI, who rode Reneesgotzip in the fourth race at Del Mar Race Track on August 17, 2014, is suspended for THREE (3) racing days, (August 24, 27, and 28, 2014) for failure to make the proper effort to maintain a straight course in the stretch, causing interference. This constitutes a violation of California Horse Racing Board Rule #1699 (Riding Rules – Careless Riding). Pursuant to California Horse Racing Board rule #1766 (Designated Races), the term of suspension shall not prohibit participation in designated races.

Jockeys Rafael Bejarano and Agapito Delgadillo met with the Stewards to review the first race Sunday. It was a discussion to look at the five-horse spread on the turn and advise them to allow more room between horses, for their safety and the safety of the horse. They both agreed to take the advice.

**FRANKHAM--CARMODY FORMAL HEARING CASE 14DM018**

The CHRB filed a complaint against owners, David Frankham and Brian Carmody for a possible violation of CHRB rules 1629 (Penalty for Late Declaration) and 1698 (Failure to Start and Run). Appearing before the BOS were court reporter Michelle Derieg, representing the CHRB Investigator Jim Hamilton and owners David Frankham in person and Brian Carmody participated by phone. On July 31, 2014 Mr. Frankham and Mr. Carmody refused to run their horse "Smogcutter" against the A. C. Avila trainee "Masochistic" who previously had a post race positive. These owners wanted to protest the fact that Mr. Avila had not been sanctioned for the aforementioned positive.

Mr. Frankham testified that the issue started two days prior to the scratch. He also notified a Steward at that time that he and his partner, Mr. Carmody realized they were competing against A.C. Avila's trainee "Masochistic", in protest they did not want to run their horse. Both owners stated they wanted to object on principal. They felt that Mr. Avila's positive was so "egregious" and they were very frustrated with the system taking 4 ½ months for a hearing, they wanted to make a statement. Decision to follow.

**PURSE MONEY ONLY**

After notification from Assistant Clerk of Scales Chris Merz, who was informed by Equibase representative Ken Davis, #12 Bullet Chaser, in the third race, had been mistakenly removed from the wagering pool by tote and was placed back in, (10:06 AM-11: 54 AM), the Stewards, pursuant CHRB rule 1974 made the proper adjustments and announced the horse was scratched but would race as a non wagering interest, for purse money only. The was referred to the CHRB Investigators.

**INQUIRY FIFTH RACE (3/4 poly) DISQUALIFICATION**

Following the running of the race the inquiry sign was posted to review an incident inside the 1/16 marker. It involved #8 Elusive Mistress (I. Orozco 8<sup>th</sup>) and #11 Cinderella Lady (J. Vargas Jr., 5<sup>th</sup>). #11 drifted in several paths taking the path of #8 who was on the rail, causing him to check hard. After a review of the videos and conversation with the Patrol Judges and both Jockeys involved in a unanimous decision #11 was disqualified and placed eighth behind #8.

**INQUIRY SIXTH RACE (5 ½ poly) NO CHANGE**

Following the running of the race the inquiry sign was posted to review an incident at the top of the stretch coming off the turn. There were five horses involved, #3 Lady Now (E. Trujillo 7<sup>th</sup>), #5 Pearl de Vere (J. Talamo 1<sup>st</sup>), #7 Shared Image (K. Stra 9<sup>th</sup>), #8 Fly to Freedom (D. Van Dyke 4<sup>th</sup>) and #10 Bunuska (T. Baze 2<sup>nd</sup>). After much review, conversation with the Patrol Judges and all jockeys involved in a unanimous decision, the original order of finish was made official. It was the Stewards' opinion that all involved contributed; therefore no one horse was blamed.

**FILM REVIEW**

Jockeys Elvis Trujillo, Joe Talamo, Tyler Baze, met as directed with the Stewards to review the sixth race yesterday. Kayla Stra was excused after she called and stated she was traveling to Ecuador and would not be available. The incident involved a group of horses turning for home, bunched and movement from all. After a thorough review, those present all agreed that everyone was

involved in the incident. No penalties were given but those who attended agreed they could have done better.

Jockey Kent Desmoreaux met with the Stewards to review the fourth race. Mr. Desmoreaux turning for home on the fence, drifted out, it appeared he then noticed a horse advancing on the fence and pulled his mount back in, to close the hole. After a review of the incident Mr. Desormeaux stated he moved his horse to be clear before a lead change. The BOS found Mr. Desormeaux's excuse fairly plausible and he was exonerated.

Jockey Jose Vargas, Jr. met with the Stewards to review the fifth race yesterday (ref-08-21-14<sup>4</sup>). Mr. Vargas was very candid in admitting he made a mistake in the stretch run by not keeping a straight course, which caused interference and a disqualification of his mount. The following ruling was issued.

#### DMTD RULING #032

Jockey JORGE VARGAS, JR., who rode CINDERELLA LADY in the fifth race at Del Mar Race Track on August 21, 2014, is suspended for THREE (3) racing days (August 28, 29, and 30, 2014) for failure to make the proper effort to maintain a straight course in the stretch, causing interference which resulted in the disqualification of his mount from fifth to eighth position. This constitutes a violation of California Horse Racing Board Rule #1699 (Riding Rules – Careless Riding).

Pursuant to California Horse rule #1766 (Designated Races), the term of suspension shall not prohibit participation in designated races.

#### **INQUIRY THIRD RACE (51/2 poly) ACCIDENT NO CHANGE**

Following the running of the race the inquiry sign was posted to review an accident near the 3/8ths marker. Involved was #4 Little Tower with William Antongeorgi aboard. The horse went wrong and unseated the jockey. After a review of the videos and talking to the Patrol Judges and jockeys, in a unanimous decision, there were no other horses involved in the incident. **STEIN RULING ref-08-20-14<sup>1</sup>**

The following ruling was issued after the referenced hearing took place.

**DMTD RULING #033**

Acting on a report from the University of California, Davis Kenneth L. Maddy Analytical Laboratory, the official testing laboratory for the California Horse Racing Board, that urine sample SA15904 obtained from the horse LUCKBOX SAM, the second place finisher in the fourth race at Santa Anita Race Track on May 1, 2014, contained the drugs Norpseudoephedrine and O-desmethylpyrilamine (class 3), it is ordered that LUCKBOX SAM be disqualified from all purse monies earned in said race in accordance with California Horse Racing Board rule 1859.5 (Disqualification Upon Positive Test Finding).

It is further ordered that the purse money earned in said race (\$3,200.00) be returned by owner Stein Stables Inc. (\$3,020.00) and jockey Julien Couton (\$85.00) to the Paymaster of Purses at Santa Anita Race Track by September 23, 2014 for redistribution in accordance with the revised order of finish.

All records are ordered changed to reflect this ruling. In accordance with California Horse Racing Board Rule #1956 (Race Declared Official) neither pari-mutuel payoffs nor the distribution of any pari-mutuel pool shall be affected.

**FILM REVIEW**

Jockey Mike Smith appeared to review the first race yesterday. As a Guild representative, Mike Smith also represented Martin Garcia who rides today in New York. Down the backside in a ¾ event, both Mr. Garcia and Mr. Smith changed paths with little or no clearance. In the opinion of the Stewards, Mr. Smith was marginally clear when he shifted out and was issued a warning. Mr. Garcia shifted out four paths and caused a horse to his outside to check. In a unanimous decision Mr. Garcia was issued a three-day penalty in the following ruling.

**DMTD RULING #034**

Jockey MARTIN GARCIA is suspended for THREE DAYS (August 29, 30, and 31, 2014) for crossing over without sufficient clearance and causing interference while riding BOOKWORM in the first race at Del Mar Race Track on August 22, 2014. This constitutes a violation of California Horse Racing Board Rule #1699 (Riding Rules – careless riding).

The term of suspension shall not prohibit participation in designated races pursuant to California Horse Racing Board Rule #1766 (Designated Races).

Jockey Rafael Bejarano met with the Stewards to review the fifth race. Coming off the turn, Mr. Bejarano was making a run behind a wall of horses, in the BOS opinion Mr. Bejarano changed his path as a horse to his inside drifted out; this caused a horse on his outside to take up. The field was tightly bunched and movement from several horses contributed to the incident. Mr. Bejarano left with a warning.

**JOHNSON FORMAL HEARING CASE 14DM009**

The CHRB filed a complaint against trainer Ernest Johnson pursuant to CHRB Rules 1844 C (1) (Authorized Medication), 1887 (Trainer to Insure Condition of Horse) and 1843 (a)(d) (Medication, Drugs and Other Substances). Present at the hearing before the BOS were, representing the CHRB, Investigator Jim Hamilton, trainer Earnest Johnson appeared by telephone and court reporter Michelle Derieg documented the proceedings. Mr. Johnson's runner "Inherit the Throne" on July 10, 2014 tested with a Phenylbutazone level of 4.97 ug/ml. Mr. Johnson stated his practicing veterinarian Dr. Warren gave the medication. He also stated he has no idea how the level was over the 2.0 limit. According to CHRB rule 1843.3 category "D" penalty guidelines, Mr. Johnson is eligible for and received a warning.

**WHIP REVIEW**

Jockeys, Mike Smith, Joe Talamo, Rafael Bejarano, Tiago Pereira and Guild Representative Darrell Haire all attended a voluntary viewing of a collection of videos the BOS had compiled. Several different races were viewed and discussed pertaining to the new whip rule, which will likely be a house rule before the California Horse Racing Board adopts it. Good results were attained from the discussion and there will be further meetings to try to help implement the new style of whip use.
