CHRB Chief Steward Darrel McHargue stopped by the stewards' office this morning. Chief Steward McHargue and CHRB Executive Director Rick Baedeker are at Del Mar today in order to attend an ARCI (American Racing Commissioners International) meeting that is being held in the Surfside Race Place facility.

ALONSO QUINONEZ MEETING

Jockey Alonso Quinonez appeared this morning in our office after it was alleged he 'got rough' with his horse after he dismounted and began to unsaddle following the seventh race on Sunday, August 14. Safety Steward Luis Jauregui was also present today. Jockey Quinonez said his horse was jumping around and he admitted to having used an open palm in order to push the horse away from his feet. He was given a warning not to strike horses.

JAMIE THERIOT FILM REVIEW

Jockey Jamie Theriot, who has failed to attend film reviews twice as ordered, (REF: DMTC Rulings #45 and #47) finally appeared in our office today. The first race we reviewed was the Green Flash Handicap (\$75,000 added) which was the seventh race (5 Furlongs-Turf) on Friday August 12. Jockey Theriot was aboard #4 Holy Lute who finished fifth, beaten a head for fourth position. Film review shows Jockey Theriot stand up in the saddle before the finish line. The stewards'

unanimously felt his actions cost his horse a good chance at fourth place. (Note: The owner's of Holy Lute get \$1,500 for fifth place. \$4,500 went to the owners of fourth place finisher #2 No Silent. There was Superfecta wagering on this race). In a 3-0 vote the stewards' issued the following ruling.

DMTD RULING #51

Jockey JAMIE THERIOT, who rode HOLY LUTE in the seventh race on August 12, 2016 at Del Mar Race Track is fined FIVE HUNDRED DOLLARS (\$500.00)* for violation of California Horse Racing Board rule 1692 (Requirements for Horse, Trainer and Jockey – stood up before finish line).

The Stewards also reviewed the third race (1 1/16 miles turf) from Saturday, August 13 with Jockey Theriot aboard #5 Horizontalyspeakin who finished eighth (last) in this race. His mount put outside pressure on #4 Canecao (ARG) (Fernando Perez) forcing that eventual seventh place finisher to check entering the first turn of this race. Warning issued.

ROBERT FLETCHER VISIT (REF: 8/13/16(3) & 8/14/16(2))

Robert Fletcher (Winners Foundation) stopped by the stewards' office in order to go over the language contained in DMTC Ruling #46 which has placed Jockey Norberto Arroyo's license on probation through the term of his license (July 31, 2019). This ruling was issued for violation of CHRB Rule # 1874 (Disorderly Conduct).

INFORMAL HEARING

Exercise Rider Jesse Sauder appeared in the Stewards' office today doing so at the order of Del Mar Thoroughbred Club (DMTC) stable security. According to stable security Sauder has 'run' the stable gate 5 to 6 times since the start of this racing season. The Stewards, acting upon the testimony of exercise rider Sauder and a well written security report by DMTC Graveyard Security Sgt. Jim Valle, issued the following ruling.

Ruling DMTD #64

Exercise Rider JESSIE SAUDER is fined FIFTY DOLLARS (\$50.00)* for violation of California Horse Racing Board rule #1930 (Obedience to Security Officers and Public Safety Officers – failure to stop at stable gate – numerous violations).

KENT DESORMEAUX INFORMAL HEARING

Jockey Kent Desormeaux appeared in the Stewards' office in order to review his ride aboard #9 Tiz A Kiss, who finished second in the \$150,000 Guaranteed Solana Beach Stakes (Sunday, August 14) that was one (1) mile on the turf course. The purpose of today's film review was to observe Jockey Desormeaux's use of his riding crop during the stretch run of this race. Following a very thorough review it was determined that CHRB Rule #1688 (Use of Riding Crop) was not violated. This film review was originally scheduled for yesterday however Jockey Desormeaux did not appear for that hearing. Therefore the following ruling was issued.

Ruling DMTD #65

Jockey KENT DESORMEAUX is fined FIFTY DOLLARS (\$50.00)* for violation of the California Horse Racing Board rule #1930 (Obedience to Security Officers and Public Safety Officers – failure to attend film review on August 17, 2016).

TED WEST JR. COMPLAINT (CASE # 16SA178)

A formal hearing was held today for Trainer Ted West Jr. U.C. Davis Laboratories found the Class 4 drug Phenylbutazone in the official blood sample of the West trained Wife Approved, who finished sixth in the seventh race at Santa Anita Race Track on June 24, 2016. The level in the test sample was reported at 3.39 UG/ML. The maximum level should contain no more than 2 micrograms per milliliter. Along with the stewards present today were CHRHB Investigator Jim Hamilton and Court Reporter Michelle Derieg (Weinstein Court Reporters LLC). Trainer West had previously received a \$250.00 sanction in October 2005 for a high phenylbutazone (4.54 UG/ML). Trainer West told the Stewards he has recently retired from racing. He testified on the telephone today and thanked the Board of Stewards for our working with him in years past. Decision to follow.

KENJI MORINAGA COMPLAINT (CASE # 16SA0179)

The CHRHB filed a complaint against Owner Kenji Morinaga for alleged violation of CHRHB Rule 1876 (Financial Responsibility). This complaint states that Owner Morinaga is indebted to Veterinarian Vincent Baker/Equine Medical Center in the amount of \$28,607.51. The stewards’ were informed today that a payment agreement has been ‘worked out’ between the two (2) parties and this complaint has now been withdrawn.

He answered questions about horseracing and put a face with a name/position and let the security group know he would always be available if needed.

SAMUEL NICHOLS APPEAL HEARING (CASE #16SA0122 & Case #SAC-0029)

A formal hearing was held today involving Owner/Trainer Samuel Nichols. Mr. Nichols appealed Ruling #202 that was issued July 1, 2016 by Santa Anita Stewards. This ruling was the result of an informal hearing that was held on June 23, 2016 at Santa Anita. Owner/Trainer Nichols appealed the Santa Anita Stewards' decision where he was ordered to pay \$1,200 in order to complete the sale of a horse previously owned by Trainer Nick Acuna. Samuel Nichols appealed the ruling in a timely manner. CHRB Headquarters in Sacramento (Executive Director Rick Baedeker) issued an 'Order of Remand' whereby a record and transcript of hearing would be produced today per CHRB Rule 1537. Present today were Owner/Trainer Phil Miyazaki and Court Reporter Michelle Derieg (Weinstien Court Reporters LLC). Trainer Nick Acuna testified via telephone without objection by Samuel Nichols. Decision to follow.

MILTON PINEDA COMPLAINT (CASE #16DM058)

Pony Rider Milton Pineda appeared in the Stewards' office today to answer to alleged violation of CHRB Rule 1481 (A) (Occupational Licenses and Fees). Present today were CHRB Investigator Jim Hamilton and safety Steward Luis Jauregui. Pony Rider Pineda exercised the verified tough to handle 'Iowa Tiger' on the Del Mar training track on August 5, 2016 for Trainer Howard Zucker. Testimony and documents revealed Pineda was 'working outside' his license category by not having an exercise rider's license. Decision to follow.

TED WEST JR. RULING (REF 8/16/16⁴)

Trainer TED WEST JR., who started the horse WIFE APPROVED, sixth place finisher of the seventh race at Santa Anita Race Track on June 24, 2016, is fined TWO HUNDRED FIFTY DOLLARS (\$250.00)* pursuant to California Horse Racing Board rule #1887 (Trainer to Insure Condition of Horse) for violation of California Horse Racing Board rule #1843(a)(d) (Medication, Drugs and Other Substances – Phenylbutazone in excess of permitted level [3.39 ug/ml – Class 4]).

Pony rider MILTON PINEDA, is fined FIFTY DOLLARS (\$50.00)* for violation of California Horse Racing Board rule #1481(a) (Occupational Licenses and Fees – not properly licensed).

The ruling above was issued after the Stewards' held a hearing (Case #16DM058) yesterday, August 19 in the Del Mar Stewards' office. The vote was unanimous.

Jockey Brandon Boulanger appeared in the Stewards' office at the Stewards' request today. Boulanger was late weighing out prior to his mount aboard #5 What We Doing in yesterday's fifth race. Boulanger told the Stewards' he was sleeping prior to his only mount of the day. The Stewards' issued the following ruling.

RULING #68

Jockey BRANDON BOULANGER is fined FIFTY DOLLARS (\$50.00)* for violation of California Horse Racing Board rule #1682 (Weighing Out – late).

AUSTIN SOLIS FILM REVIEW

Apprentice Jockey Austin Solis appeared in the Stewards' office today along with Darrell Haire, who is Western Regional Manager for the Jockeys' Guild. Apprentice Solis was aboard #4 Golden Silence in the sixth race yesterday (August 19) and finished seventh. Golden Silence broke in and then drifted bothering fourth place finisher #5 Broken Marriage (Jamie Theriot) and eighth place finisher # 6 Dumont (Edwin Maldonado). The Stewards wanted to review Apprentice Solis' efforts to keep his mount straight after the early race confusion. This young rider showed an effort in this race and was excused without sanction.

AGAPITO DELGADILLO FILM REVIEW

Jockey Agapito Delgadillo appeared in the Stewards' office in order to review his ride aboard #4 Alltheleavesrbrown, who finished second in this one (1) mile main track event. #4 Alltheleavesrbrown tightened things up on two (2) rivals to his inside entering the first turn of this one (1) mile main track event. Both eighth place finisher #1 Allovertwistabout (Tiago Pereira) and tenth (last) place finisher #3 Thesheetsguy (Santiago Gonzalez). Jockey Delgadillo was asked if he could have provided more space for inside rivals entering the turn. He replied in the affirmative. He was cautioned that a subsequent similar occurrence would likely lead to a sanction by the Stewards. Warning issued.

FOG CITY STABLES (DAVID SHIMMON) (COMPLAINT (16DM002))

Fog City Stables (David Shimmon) is allegedly indebted to KC Horse Transport in the amount of \$1231.99 for transportation services. This hearing was originally scheduled for August 4 while KC Horse Transport and the connections of Fog City Stables spoke on the telephone. The following ruling suspends Owner David Shimmon for failure to appear at Del Mar for a scheduled hearing following the breakdown of negotiations.

RULING DMTD #69

Owner DAVID SHIMMON (DBA FOG CITY STABLES) having failed to respond to a complaint alleging violation of California Horse Racing Board rule #1876 (Financial Responsibility – \$1,231.99 to KC HORSE TRANSPORT - vanning), is suspended for violations of California Horse Racing Board rule #1547 (Failure to appear).

During the term of suspension, all licenses and license privileges DAVID SHIMMON (DBA FOG CITY STABLES) are suspended and pursuant to California Horse Racing Board rule #1528 (Jurisdiction of Stewards to Suspend and Fine), DAVID SHIMMON (DBA FOG CITY STABLES) is denied access to all premises in this jurisdiction.

MUTUEL MANAGER MEETING

DMTC Mutuel Manager William Navarro met with the Stewards to discuss the extraordinary amount of time between yesterday's (August 19) seventh and eighth races. Mr. Navarro told the Stewards that there was a miscommunication between him and the tote operator which led to about nine (9) more minutes being posted between the last two (2) races than were originally scheduled. The Stewards' had safety concerns about early evening darkness. The approximate post time for the eighth race was 7:13 p.m. The actual 'off time' for this race was 7:25 p.m.

SECURITY CHIEF VISIT

Del Mar Head of Security Patrick Kerins stopped by the Stewards' office this morning. Stewards Aide Lucy Vaillancourt had expressed concern about an individual out on the edge of the race track during yesterday's last (eighth) race. Mr. Kerins and Ms. Vaillancourt walked out to the winner's circle this morning in order to review locations of concern around the restricted area.

TVG PACIFIC CLASSIC

A good portion of the record \$25,060,204 wagered today at Del Mar was generated in the 26th Running of the \$1,000,000 TVG Pacific Classic. Today's handle is an all time single record handle for Del Mar. This eclipses the former handle record of \$24,677,351 set on Pacific Classic day back in 2007. #1 California Chrome, with Jockey Victor Espinosa defeated the champion mare Beholder by five (5) full lengths covering the 1 ¼ mile main track distance in a swift 2:00.13 seconds. 'Chromies' (members of California Chromes' fan club) and the rest of the public received a return of \$4.20 on a two (2) dollar win wager. There were 24,155 fans at Del Mar today, many of whom showed up for this outstanding race. Jockey Victor Espinosa won his first Pacific Classic today in sixteen (16) tries. Trainer Art Sherman is now one (1) for (1) in his Pacific Classic training efforts.

MIKE MUDARIS RULING (CASE16SA154)

RULING DMTD#70

Trainer MIKE MUDARIS, who started SHAKITUPBETTY in the fourth race at Santa Anita Race Track on May 29, 2016, is fined ONE THOUSAND FIVE HUNDRED DOLLARS (\$1,500.00)* for violations of California Horse Racing Board rules #1843(a)(d) (Medications, Drugs and Other Substances), #1887 (Trainer to Insure Condition of Horse), and violation of #1844(f)(4) (Authorized Medication – Dexamethasone 2776 pg/ml) and violation of 1844(c) (Authorized Medication – two approved NSAIDS – Phenylbutazone 1.11 mcg/ml; Flunixin 5.4 ng/ml).

Jockey Gary Stevens appeared to use his riding crop four (4) consecutive times while riding #5 Coldspell who finished first in yesterday's seventh race. Jockey Stevens called up the Stewards' during this afternoon's card and pled guilty and waived his right to a hearing thereby accepting the penalty listed below.

RULING #71

Jockey GARY STEVENS is fined TWO HUNDRED DOLLARS (\$200.00)* for violation of the California Horse Racing Board rule #1688 (b)(6) (Use of Riding Crop – more than three times in succession without giving the horse a chance to respond – second offense in the last sixty days; last offense on August 4, 2016), during the seventh race at Del Mar Race Track on August 20, 2016.

KENT DESORMEAUX RULING

In today's third race the stewards' felt Jockey Kent Desormeaux possibly violated CHRB Rule #1688 (Use of Riding Crop) following his ride aboard #1 Perfectly Majestic who finished first. During yesterday's racing card Jockey Desormeaux called the Stewards' and agreed that he used his riding crop more than three (3) consecutive times without giving his horse a chance to respond. After he waived his film review/informal hearing rights, the stewards' issued the following ruling.

RULING #72

Jockey KENT DESORMEAUX is fined ONE HUNDRED DOLLARS (\$100.00)* for violation of the California Horse Racing Board rule #1688(b)(6) (Use of Riding Crop – more than three times in succession without giving the horse a chance to respond – first offense in the last sixty days), during the third race at Del Mar Race Track on August 20, 2016.
