CARRILLO RULLING

The following ruling was issued when Mr. Carrillo failed to appear for a scheduled hearing.

RULING DMTD #073

Owner SAUL CARRILLO, is suspended for violation of California Horse Racing Board Rule #1876 (Financial Responsibility – Veterinarian John Araujo \$1,041.75). During the term of suspension, all licenses and license privileges of SAUL CARRILLO are suspended and pursuant to California Horse Racing Board Rule #1528 (Jurisdiction of Stewards to Suspend and Fine). SAUL CARRILLO is denied access to all premises in this jurisdiction.

GEROUX RULING

The following ruling was issued after Mr. Geroux rode a designated race in New York during a suspension day issued in California.

RULING DMTD #074

Jockey FLORENT GEROUX is suspended for ONE (1) ADDITIONAL RACING DAY (August 28, 2016) pursuant to California Horse Racing Board rule #1766 (g)(h) (Designated Races – rode in a designated race, on August 21, 2016, in another jurisdiction while under suspension).

D'AMATO HEARING CASE #16DM054

The CHRB filed a complaint against trainer Philip D'Amato for violation of CHRB rule 1890(b) (Possession of Contraband). After a routine barn search of Mr. D'Amato's barn, a bottle of prescribed Regu-mate distributed to one of his trainees when stabled in Kentucky was discovered.

The bottle returned to California with the horse with the label prescribing the medication outside of 24 hours before race time. CHRB rule 1843.5 (c) states, any drugs, medications, or any other substances shall not be administered by any means to a horse within 48 hours of the post time of the race in which the horse is entered. Mr. D'Amato explained that one of his trainees was prescribed the medication in question while in training in Kentucky and when the horse shipped back to California the medication returned with it. Decision to follow.

JOCKEY FILM REVIEW

Apprentice Edgar Orozco joined the BOS to review the second race on Saturday. Mr. Orozco was exonerated of blame for contact with another horse soon after the start. While running last in the stretch he was practicing switching sticks. He was informed that this practice was appropriate only if he did not use the crop on the horse; he stated he understood; warning.

Brayan Pena also came into the Stewards' office to discuss the stretch run in the ninth race Sunday. Although clear Mr. Pena changed paths several times in the stretch; he was told guiding his horse in and out even when clear could eventually cause a riding violation, he agreed; warning.

Brandon Boulanger met with the BOS to review his crop action in the third race on Sunday. After verifying that he violated the rule coming off the turn the following ruling was issued.

RULING #075

Jockey BRANDON BOULANGER is fined ONE HUNDRED DOLLARS (\$100.00)* for violation of California Horse Racing Board Rule #1688(B)(6) (Use of Riding Crop – more than three times in succession without giving the horse a chance to respond – first offense in the last sixty days), during the third race at Del Mar Race Track on August 21, 2016.

PHOTO FINISH MEETING

Interested parties who attended the discussion were owner Mike Wellman, his wife Cory, trainer Peter Miller, Ray Paulick (Paulick Report), Jay Privman (DRF), Mike Martin (CHRB), and Luis Jauregui (Safety Steward), among others, met with the Stewards in a prearranged meeting to discuss a dead heat photo posted on the Del Mar Web site Sunday, August 21 after the eighth race. They believed, after viewing the photo on the DMTC website, that the result of the race was not, in fact, a dead heat as determined unanimously by the Stewards and Placing Judges on Sunday.

After meeting with photo finish personnel, the Stewards discovered that the photo posted on the website did not match the image used by the Stewards to judge the margins of separation (or lack thereof) before the race was made official. It has since been discovered that the cause for this discrepancy was a distortion due to the process of sending the image from the photo finish camera/computer to the TVG TV truck and then a screen capture of that image being posted on the DMTC site. This procedure is done to expedite the posting of photos after every race. But in doing so, the BOS discovered a flaw that created a subtle distortion of the photo when transferred from the photo finish camera to the television truck and then to the website. On the website photo, the horses appeared to be slightly stretched out horizontally, making it appear that the two horses did not finish in a dead heat.

After the Stewards explained how a photo finish camera works and the procedure of examining photo finishes, the attending group was also escorted to the Stewards' stand and was given the opportunity to view the dead heat image on the same monitor that the Stewards used when determining the results of photo finishes. Jim Anderson, general manager for Plusmic was on hand to answer questions as was Del Mar photo finisher operator, Tammy Boag.

A new process has been implemented in posting photos on the website to insure the proper image is posted.

JOCKEY FILM REVIEW

Flavien Prat met with the Stewards to review a possible crop violation in the sixth race yesterday. Interestingly Mr. Prat only used his crop a total of four times during the race. Unfortunately the four strikes were consecutive and the following ruling was issued (Steward Chaney did not believe the video showed a violation).

RULING DMTD #076

Jockey FLAVIEN PRAT is fined ONE HUNDRED DOLLARS (\$100.00)* for violation of California Horse Racing Board Rule #1688(B)(6) (Use of Riding Crop – more than three times in succession without giving the horse a chance to respond – first offense in the last sixty days), during the sixth race at Del Mar Race Track on August 24, 2016.

Chantal Sutherland also met with the Stewards to discuss her tardiness to the jockey’s quarters yesterday. Ms. Sutherland was candid in admitting she arrived forty five minutes before she was due to ride, which was under the one hour requirement for all jockeys to be in attendance before the race they ride. The following ruling was issued.

RULING DMTD #077

Jockey CHANTAL SUTHERLAND is fined TWO HUNDRED DOLLARS (\$200.00)* for violation of California Horse Racing Board Rule #1680 (Jockeys and Drivers to Report – late to Jockeys’ Room) on August 24, 2016 at Del Mar Race Track.

D’AMATO RULING ref 08-24-16³

The following ruling was issued after the Stewards decision of the penalty noted in the ruling.

RULING DMTD #078

Trainer PHILIP D’AMATO is fined two hundred dollars (\$200.00)* for violation of California Horse Racing Board Rule 1890 (Possession of Contraband – out of state medication label with incorrect withdrawal period) pursuant to California Horse Racing Board rules 1864 (Labeling of Medications) and 1843.5 (Medication, Drugs and Other Substances Permitted After Entry in a Race).

PALMA HEARING CASE #16SA117

A complaint was filed against trainer Hector Palma for violation of CHRB Rules 1843 (a)(b) (Medication, Drugs and Other Substances), 1844(e)(1) (Authorized Medication), 1887 (Trainer to Insure Condition of Horse) and 1843.1 (b) (Prohibited Drug Substances).

This case involved his starter "Legal Authority" who finished second in the fourth race at Santa Anita Race Track on May 8, 2016. The post race sample was analyzed by U.C. Davis Laboratory and was found to contain the class 3 drug "Hydroxyethyl Promazine Sulfoxide a metabolite of "Acepromazine" at a level of 208 ng/ml, permitted level 10 ng/ml.

Present for the hearing before the BOS were CHRB Investigator Jim Hamilton, trainer Hector Palma and Safety Steward Luis Jauregui. A Settlement Agreement and Mutual Release was formulated between Mr. Palma and the California Horse Racing Board and was presented for the BOS to approve. Ruling to follow

After an examination of #4 Handsome Hank who raced in the fourth race, Official Veterinarian Barrie Grant reported the horse was unsound and placed it on the Veterinarian's List. The claim was voided and the horse returned to the stable of Art Sherman.

JOCKEY FILM REVIEW

Kent Desormeaux was scheduled to meet with the BOS today but is riding out of town. He arranged for his wife apprentice Rosie Higgins to represent him to discuss his ride in the first race yesterday. There were three points of discussion. First, going into the turn near the 3/8 marker he pulled out in front of a horse and caused that one to check slightly; warning. Second, coming off the turn he pushed a horse to his outside out to make room for the stretch run, warning. Third, in mid stretch, he drifted out and caused a horse to his outside on his heels to shift out; warning. Ms. Higgins had her first lesson of how to defend a jockey in the Stewards' office.

Gary Stevens met with the Board of Stewards to discuss the reason he pulled his mount up just inside the 1/16 marker in the fifth race yesterday. He stated the horse was having trouble

breathing and was laboring in the stretch, in his opinion she flipped her palate in her throat which controls the air flow. He stated after he crossed the wire on the gallop out, she relaxed and began to breathe again. Her trainer, Matt Chew was questioned, he stated the filly is very nervous and this has happened to her in the past. The Stewards felt these were acceptable explanations.

Santiago Gonzalez and his valet Ozzie Ayala, present to translate met with the Stewards to review the eighth race on Sunday. After a view of the pan shot in slow motion, it was confirmed Mr. Santiago did stand up two strides before the wire and his mount was beaten a nose for third.

GONZALEZ RULING ref 08-26-16¹

The following ruling was issued after the penalty for the violation was established.

Ruling DMTD #079

Jockey SANTIAGO GONZALEZ, who rode TEXAS TWO STEP in the eighth race on August 21, 2016 at Del Mar Race Track is fined FIVE HUNDRED DOLLARS (\$500.00)* for violation of California Horse Racing Board Rule 1692 (Requirements for Horse, Trainer and Jockey – stood up before finish line).

CERIN FORMAL HEARING CASE #16SA0176; CASE #16DM0006

Two complaints were filed against trainer Vladimir Cerin for violation of CHRB Rules 1843 (a)(b) (Medication, Drugs and Other Substances), 1844(f)(10) (Authorized Medication), 1887 (Trainer to Insure Condition of Horse) and 1843.1 (b) (Prohibited Drug Substances).

Present for the hearing before the BOS were CHRB Investigator Philip Miyazaki, trainer Vladimir Cerin and recording the proceeding court reporter Michele Derieg. Violations occurred on June 19, 2016 and July 3, 2016. Both samples were sent to U.C. Davis Laboratories and were

found to contain the same prohibited drug, Methylprednisolone. It was explained that both runners in question had their hocks injected with Methylprednisolone. According to the veterinarian's confidential reports the injections were 14 to 15 days prior to their race, which caused a level of, 346 pg/ml and 435 pg/ml in the two positives (limit 100 pg/ml). The RCI recommended withdrawal period is 21 days. The second offense occurred before Mr. Cerin was notified of the first. Decision to follow.

COMMISSIONER MEETING

Commissioner Madeline Auerbach met with the Stewards to inform them of her findings for workman's compensation insurance coverage of assistant trainers when saddling for trainers other than their employers. Ms. Auerbach stated she verified with Brad McKenzie ("Finish Line" Workman's Compensation) that an assistant trainer could saddle for another trainer and be covered by workman's compensation if injured, as long as his employer (his trainer) gave permission to do so. This will only be allowed for trainers who are physically unable to saddle their own horse.

ASSISTANT TRAINER OBJECTION NO CHANGE TENTH RACE

Following the running of the race Leandro Mora, assistant trainer for Doug O'Neill lodged an objection against #1 Temple Keys (N. Arroyo 2nd). The O'Neill trainee #3 Over Par (M. Gutierrez 3rd) was 3/4 of a length behind #1 when that one drifted in causing #3 to ease back off the heels of #6 Temple Keys (J. Theriot 1st) who at the same time drifted out slightly. This action took place three strides from the finish line. After talking to all riders involved and the Patrol Judges, in a unanimous decision, the original order of finish was made official. In the opinion of the BOS #3 was not cost the opportunity of a better placing.

Mario Gutierrez met with the Stewards to review the tenth race yesterday in which he floated a horse to his outside coming off the turn. He stated he could have been more aware and done a better job by not veering out as far as he did; warning.

Norberto Arroyo came to the Stewards' office to review the tenth race concerning his drift approaching the finish line. Although this was not penalty worthy, he was cautioned we expect better riding from him, he stated he understood. Also it was brought to the Stewards' attention, Mr. Arroyo is the last to weigh out for the races he rides and he seems to have a fondness and an attachment to the only available racing form in the jockey quarters. He fails to return the form to the assistant clerk of scales after he uses it to handicap the races he rides. He was warned the next time he violates either of these issues he will be penalized. Judge Baker voted for a one hundred dollar fine.

Trainer Mike McCarthy met with the Stewards to discuss a security violation issued for not fastening his chin strap on his helmet while riding his pony horse. There was also a question as to his location on the track while on his cell phone, he was warned to only use it in the designated area for cell phone usage, in the chute. Mr. McCarthy admitted to having been warned several times and the following ruling was issued.

RULING DMTD #080

Trainer MICHAEL MCCARTHY is fined FIFTY DOLLARS (\$50.00)* for violation of California Horse Racing Board rule #1930 (Obedience to Security Officers and Public Safety Officers – failure to fasten chin strap – numerous violations).

Exercise Rider Iris Vandentoorn met with the Stewards to review her Security notice issued by Del Mar Security yesterday. The second is her attitude with Security while being issued the first violation notice. After reading a report from Del Mar security about her demeanor, the following ruling was issued.

RULING DMTD #081

Exercise Rider/Equine Massage Therapist IRIS VANDENTOORN is fined ONE HUNDRED DOLLARS (\$100.00)* for violation of the California Horse Racing Board rule #1930 (Obedience to Security Officers and Public Safety Officers – Failure to follow instructions of outrider and Refusal to obey Security) on August 27, 2016 at Del Mar Race Track.

PALMA RULING ref 08-25-16³

The following ruling was issued after this BOS approved the Stipulated Settlement formulated between Mr. Palma and the California Horse Racing Board.

RULING DMTD #082

Owner/Trainer HECTOR PALMA, who started the horse LEGAL AUTHORITY that finished second in the fourth race at Santa Anita Race Track on May 8, 2016, having entered into a Settlement Agreement with the California Horse Racing Board is fined THREE THOUSAND DOLLARS (\$3,000.00)* and suspended for THIRTY (30) DAYS pursuant to California Horse Racing Board Rule #1887 (Trainer to Insure Condition of Horse) for violation of California Horse Racing Board rule #1844 (Authorized Medication – acepromazine in excess of authorized decision level). The suspension will be stayed for TWENTY THREE (23) DAYS and HECTOR PALMA will be placed on probation for ONE (1) YEAR subject to the terms and conditions of the Stipulated Agreement. Actual SEVEN (7) DAYS of suspension are to commence on September 26, 2016 through and including October 2, 2016. During the term of suspension, all licenses and license privileges of HECTOR PALMA are suspended and pursuant to California Horse Racing Board rule #1528 (Jurisdiction of Stewards to Suspend or Fine), HECTOR PALMA is denied access to all premises in this jurisdiction.
