Report for the period Wednesday, January 7, 2009 through Sunday, January 11, 2009.

**Wednesday**

01-07-09<sup>1</sup> **DARK DAY HEARINGS**

Six Wednesdays in January and February are designated dark days as the racing schedule calls for four day race weeks. On some of those Wednesday the stewards will conduct hearings to clear up the backlog (17 hearings in 17 days) and spend time in the barn area gathering information that wouldn't usually be available while sitting in the office.

01-07-09<sup>2</sup> **TOLLETT HEARING** (08GG215)

The stewards conducted a telephonic hearing for trainer **Bill Tollett** who was the subject of a complaint alleging violation of California Horse Racing Board rule #1843 (Medication, Drugs and Other Substances) in that the horse **PROUD SOPHIE** showed a bute level of 8.43 ug/ml in a post race urine sample.

Tollett was contacted in Seattle where he has returned for medical reasons. Bill pled guilty but could not account for the high test results. He stated he did not alter his medication program for this or any other horse. Tollett's medication history falls in the excellent category as he has had no violations in over nine years. Disposition to follow.

01-07-09<sup>3</sup> **DIXON HEARING CONTINUED** (Case 08GG225)

A hearing for groom **JAMES E. DIXON** was continued to later in the month when questions arose concerning proper notification. Dixon was cited for alleged violation of California Horse Racing Board rules #1874 (Disorderly Conduct) and #1530 (Cases Not Covered by Rules and Regulations).

01-08-09<sup>1</sup> **RULING NO. 6 – TOLLETT**

Trainer **WILLIAM TOLLETT**, who started the horse **PROUD SOPHIE**, sixth place finisher in the second race at Golden Gate Fields on December 6, 2008, is fined the sum of five hundred dollars (\$500.00) pursuant to California Horse Racing Board rule #1887 (Trainer to Insure Condition of Horse) for violation of California Horse Racing Board rule #1843 (a) & (d) (Medication, Drugs and Other Substances: - in excess of permitted level – Phenylbutazone – 8.43 ug/ml ).

The above ruling was issued following yesterday’s telephonic hearing.

01-08-09<sup>3</sup> **BURMAN / PERKINS HEARINGS** (Cases 08GG170 & 08GG171)

Two hearings were conducted this morning for pony persons **JENNIFER BURMAN** and **JULIE PERKINS**. The two have a documented history of contentious behavior with each other.

The complaint (08GG171) filed by Perkins against Burman alleged that on November 15, 2008 the two verbally confronted each other in trainer Bill McLean’s barn where Burman is employed. The confrontation became physical when Burman struck Perkins on the nose. Burman pled guilty to the charges. A ruling will follow.

The companion complaint (08GG170) filed by Burman against Perkins alleged that Perkins slapped Burman on the shoulder on October 29, 2008 while Perkins was mounted on her pony. The two testified at a formal hearing and evidence and testimony was submitted for the record. The stewards will deliberate and render a decision in the near future.

01-08-09<sup>4</sup> **LATE DECLARATIONS – Eighth Race – REFUND**

#2 MARYALICE INDALLAS, trained by Bill McLean, was scratched on the recommendation of Dr. Kerr as the field neared the starting gate after she diagnosed the mare as off in the right front. On Vet’s List. The refund amounted to \$9,991.04.

Both Ruiz and Camacho have no history of rule violations so warnings were deemed sufficient.

01-09-09<sup>3</sup> **RHEINFORD CONFERENCE** (Case #08GG243)

Trainer **Mark Rheinford** appeared in response to a complaint filed alleging violation of California Horse Racing Board rule #1843 (a) & (d) after the horse LAMPE showed a 5.9 ug/ml level of bute following a winning effort in the second race on December 20, 2008. The hearing was originally scheduled for January 25, but Mark wished to resolve the matter before then.

Rheinford has not had any medication violations in over six years and by virtue of such a spotless record is eligible to receive a warning for a high bute reading if the level is less than 7.5 ug/ml. The stewards will abide by the guidelines. Rheinford was counseled and warned.

01-09-09<sup>4</sup> **CALVARIO HEARING** (Cases #08GG160 & 08GG164)

Trainer **MANUEL CALVARIO** appeared to address two complaints alleging violation of California Horse Racing Board rule #1843 (a) & (d) after two horses in his care showed the presence of Trichlormethiazide (Naquasone) – Class IV – in post race urine samples. ONE ROYAL STAR won the sixth race on October 19, 2008 and STARSHIP COUNTESS won the third race on October 25, 2008.

Manny acknowledged the test results explaining he had the substance in his barn and was out of town for that week. In his absence his brother assumed the medication duties. Rulings to follow.

NO. 7 Trainer **MANUEL R. CALVARIO**, who started the horse ONE ROYAL STAR, winner of the sixth race at Golden Gate Fields on October 19, 2008, is fined the sum of five hundred dollars (\$500.00) pursuant to California Horse Racing Board rule #1887 (Trainer to Insure Condition of Horse) for violation of California Horse Racing Board rule #1843 (a) & (d) (Medication, Drugs and Other Substances: Unapproved Substance – Trichlormethiazide – Class IV).

NO. 8 Trainer **MANUEL R. CALVARIO**, who started the horse STARSHIP COUNTESS, winner of the third race at Golden Gate Fields on October 25, 2008, is fined the sum of one thousand dollars (\$1,000.00) pursuant to California Horse Racing Board rule #1887 (Trainer to Insure Condition of Horse) for violation of California Horse Racing Board rule #1843 (a) & (d) (Medication, Drugs and Other Substances: Unapproved Substance – Trichlormethiazide – Class IV – second offense).

The above rulings were released following yesterday's informal hearing.

01-10-09<sup>3</sup>**RULING NO. 9 – ALLEN**

In the Matter of:

Trainer **THOMAS ALLEN**

Having made arrangements to satisfy the outstanding financial obligation to the Alameda County Fair, Pacific Racing Association ruling #52, dated December 17, 2008 suspending Mr. Allen for violation of California Horse Racing Board rule #1547 (Failure to Appear) is set aside and the license privileges of THOMAS ALLEN are restored to good standing.

The foregoing ruling was published following the submission of a payment agreement between the two parties.

01-10-09<sup>4</sup>**SHERMAN HEARING** (Case #08GG173)

Trainer **STEVE SHERMAN** appeared to address a complaint alleging violation of California Horse Racing Board rule #1843 (a) & (d) after the horse SERPETINESERPETINE, showed a bute level of 7.65 ug/ml in a test sample following a race on November 9, 2008. Sherman availed himself of the split sample program and the split from Industrial Laboratories confirmed the bute at a level of 7.3 ug/ml. Since Sherman has had no other Class IV violations in the previous 36 months a warning was issued.

#2 PEPE LE FEU, trained by Bill Tollett, was scratched on the advice of Dr. Kerr as the field neared the starting gate after she reported the mare was off in the right hind. On Vet's List. The refund amounted to \$21,873.21.

01-10-09<sup>6</sup> **LATE SCRATCH – Sixth Race – REFUND**

#6 MIOMOUD, trained by Dan Markle, was scratched during the warm up when Dr. Kerr stated the horse was unsound in the left hind. On Vet's List. The refund totaled \$10,064.69.

01-11-09<sup>3</sup> **RULING NO. 10 – BURMAN**

Pony Person **JENNIFER BURMAN** is fined the sum of two hundred dollars (\$200.00) and placed on probation for the term of her license (02-28-2011) for violation of California Horse Racing Board rule #1874 (Disorderly Conduct) on November 15, 2008.

The above ruling was issued following Thursday's hearing and the respondent's guilty plea. As a condition of probation Burman will be instructed to attend anger management classes.

After reviewing the evidence and testimony from Thursday's formal hearing the stewards were of the opinion that Perkins actions on October 29, 2008 were in contravention of rule #1874 (Disorderly Conduct) and issued the following ruling:

Pony Person **JULIE PERKINS** is fined the sum of one hundred dollars (\$100.00) and placed on probation for the term of her license (07-31-2010) for violation of California Horse Racing Board rule #1874 (Disorderly Conduct) on November 15, 2008.

Attendance at anger management classes will also be considered a part of Ms. Perkins' probation.

01-11-09<sup>5</sup> **LATE SCRATCH – Second Race – REFUND**

#2 SIX CENTS OF HUMOR, trained by Quentin Miller, was scratched during the warm up period after Dr. Kerr diagnosed the mare as unsound in the right hind quarters. On Vet's List. The refund amounted to \$6,438.92.

01-11-09<sup>6</sup> **LATE SCRATCH – Fifth Race – REFUND**

#11 TURKS HEART, trained by Tony Diaz, was scratched by the stewards after the starter, Gary Stensgar, reported the filly would not load in the starting gate. On Stewards' and Starter's Lists. The refund totaled \$50,075.11.
