suspended pending appearance before the Board of Stewards for violation of California Horse Racing Board rule #1547 (Failure to Appear).

During the term of suspension, all licenses and license privileges of CATALINA PEREZ are suspended and pursuant to California Horse Racing Board rule #1528 (Jurisdiction of Stewards), subject is denied access to all premises in this jurisdiction.

The above ruling was issued after Perez failed to make an appearance. Catalina needed to meet with the Winners Foundation as part of her probation and abide by any recommendations from that organization. The hearing was scheduled to determine if she is in compliance with her probation.

During the term of suspension, all licenses and license privileges of EDWARD TRUJILLO are suspended and pursuant to California Horse Racing Board rule #1528 (Jurisdiction of Stewards), subject is denied access to all premises in this jurisdiction.

The above ruling was issued after Trujillo contacted the stewards late in the afternoon and offered a variety of excuses why he did not attend the hearing scheduled for 10:00 a.m. The main reason centered on the fact that Eddie does not have the \$583.50 awarded in the court judgment obtained by San Francisco Equine.
