Wednesday01-27-10¹ **DUTY STEWARD**

Steward Darrel McHargue will handle entries and declarations for this reporting period.

01-27-10² **JOY SCOTT** (09GG345)

A formal hearing was held for jockey **JOY SCOTT**, who is charged with alleged violation of California Horse Racing Board rule #1874 (1, 2, 3, and 4) (Disorderly Conduct) and #1930 (Obedience to Security Officers and Public Safety Officers).

Present for this hearing were the Board of Stewards (Grant Baker, Darrel McHargue and Dennis Nevin), CHRB senior special investigator Gabe Palomar, who presented the case, and Christine Niccoli, who recorded the proceedings. Ms. Scott was not represented by counsel. The stewards heard testimony from Fresno District Fair racing officials **Cheryl White** (Clerk of Scales) and **Danny Winick** (Patrol Judge), jockeys **Jorge Ayarza**, who was assisted by interpreter Rob Cochran, **Francisco Duran** and Ms. Scott.

After hearing all the testimony, receiving relevant documents and listening to closing statements, the hearing was closed.

Decision forthcoming.

01-28-10³ **RULING NO. 22 – HERNANDEZ**

Jockey **JUAN HERNANDEZ**, who rode **KALOOKAN HEAT** in the fifth race at Golden Gate Fields on Sunday, January 24, 2010, is suspended three (3) racing days (February 4, 5, and 6, 2010) for failure to make a proper effort to maintain a straight course in the stretch and causing interference resulting in the disqualification of his mount from first to second; a violation of California Horse Racing Board rule #1699 (d) & (f) (Riding Rules – careless riding).

The term of this suspension shall not prohibit participation in designated races in California.

The foregoing ruling was issued after jockey Juan Hernandez and his agent, Ramon Silva, met with the stewards for a review of the fifth race from January 24, 2010.

Following a stewards' inquiry and jockey objection Mr. Hernandez' mount, #6 KALOOKAN HEAT (Tr. Armando Lage), was disqualified from first to second place for causing interference in the stretch.

The young rider acknowledged he erred when he continued whipping left handed as his mount was drifting out, eventually bumping and impeding #1 DEEP'N IT (Adan Landeros), who finished a close second.

01-28-10⁴ **STEWARD ILL**

Steward **Darrel McHargue** became ill prior to the start of the first race and was replaced in the stand by safety steward **Paul Nicolo**.

01-28-10⁵ **JOCKEY PHYSICALS**

Track physician David Seftel, M.D., reported that all local jockeys have now completed their physicals for the New Year.

01-28-10⁶ **LATE DECLARATION – ACCIDENT – Second race**

As the field entered the track for the second race, #6 SHE'S A SWEETIE became fractious, unseated jockey Mario Gutierrez and fell.

Jockey Gutierrez was uninjured and #6 SHE'S A SWEETIE was declared on the recommendation of the track vet Heather Kerr.

01-29-10³ **RULING NO. 23 – VALLEJO** (Refer: 01-24-10³)

Trainer **GENARO VALLEJO** is fined the sum of three hundred dollars (\$300.00) for violation of California Horse Racing Board rule #1928 (Fire Regulations – unsafe storage of cooking device) on Friday, January 22, 2010 at Golden Gate Fields.

The above ruling was issued following a hearing held on January 24, 2010 regarding a Golden Gate Fields security complaint.

01-29-10⁴ **RULING NO. 24 – SCOTT** (09GG345)

Jockey **JOY SCOTT** is fined the sum of five hundred dollars (\$500.00) and placed on probation through the term of her license (July 31, 2010) for aggressive behavior on the racetrack and participating in altercations in the jockeys' room at the Big Fresno Fair on October 12, 2009; a violation of California Horse Racing Board rule #1874 (1) (2) (3) (4) (Disorderly Conduct – Fighting with jockey and racing official).

The foregoing ruling was issued after the stewards considered all evidence and testimony presented at the formal hearing held on January 27, 2010.

01-29-10⁴ **INQUIRY –NO CHANGE – Seventh Race**

The stewards posted the inquiry sign following the seventh race for a review of an incident near the 1/16 pole involving #1 DREAM NETTI (Russell Baze), second and #5 CALIFORNIA SOLDIER (Francisco Duran), who finished sixth.

After a thorough review and considering the input from both riders, the stewards decided unanimously to make no change in the original order of finish.

The tapes show #5 CALIFORNIA SOLDIER drift out slightly and bump #1 DREAM NETTIE near the 1/16 pole. The former finished behind the latter so the placings were not affected.

FILM REVIEW – FRANCISCO DURAN

Jockey Francisco Duran met with the stewards for a review of yesterday's seventh race (1-29-10).

Mr. Duran was very candid and admitted he could have responded quicker when his mount took a step out at the top of the stretch.

The stewards considered his effort adequate and issued a warning.

01-30-10⁴

INQUIRY – OBJECTION – DISQUALIFICATION – First Race

The stewards posted the inquiry sign following the first race for a review of an incident in the stretch involving #6 GORGEOUS GIBSON (Alex Gonzalez) second and #2 COUNTY KILDARE (Frank Alvarado), who finished third.

In addition, jockey Alvarado lodged a claim of foul against #6 GORGEOUS GIBSON for the same incident.

After considering the patrol judge's report, interviewing the riders involved and reviewing the tapes, the stewards decided unanimously to disqualify #6 GORGEOUS GIBSON from second to third for causing interference in the stretch.

The tapes show #6 GORGEOUS GIBSON drifted in, bumped and impedes #2 COUNTY KILDARE inside the 1/16 pole, preventing the latter from placing where he might.

The term of this suspension shall not prohibit participation in designated races in California.

The above ruling was issued after Mr. Gonzalez and the stewards reviewed the tapes of the first race from January 30, 2010.

Mr. Gonzalez was very forthright in acknowledging he erred by allowing his mount to drift in, under right handed whipping, causing another rider to take up sharply.
