**Report for the period Sunday, June 6, 2010 through Sunday, June 13, 2010.**

**Sunday**

06-06-10<sup>1</sup> **RULING NO. 89 – CHAVEZ** (Security Citation #3402)

Pony Boy **ADAN CHAVEZ** is fined the sum of fifty dollars (\$50.00) for violation of California Horse Racing Board rule #1930 (Obedience to Security Officers and Public Safety Officers) on numerous occasions.

The above ruling was issued after an informal hearing yesterday. Chavez has had seven (7) encounters with the barn area security force in the past two weeks which led to this hearing. Five cases of a radio blaring too loud, one abandoned bicycle and one improperly parked car added up to a citation. Although a language barrier may have excused some of Chavez' behavior, Adan could not be absolved of all counts.

06-06-10<sup>3</sup> **ROMERO DECISION** (Case #09GG313)

Exercise Rider/Jockey **HECTOR R. ROMERO** is suspended one hundred and twenty (120) days, June 14, 2010 through October 11, 2010, pursuant to California Horse Racing Board rule #1900 (Grounds for Suspension or Revocation) for failure to abide by the terms of his conditional jockey license as contained in California Horse Racing Board order #SAC 08-0029 dated, June 11, 2009; a violation of California Horse Racing Board rule #1485 (d) (License Subject to Conditions and Agreements – DUI conviction).

Prior to the reinstatement of his license privileges, Hector R. Romero must show proof of compliance with the court ordered in-house rehabilitation program, comply with the terms of his probation and the conditions of a

testing agreement with the California Horse Racing Board through the term of his conditional license (June 11, 2011) and renew a two year contract with the Winners Foundation beginning on October 11, 2010.

During the term of suspension, all licenses and license privileges of Hector R. Romero are suspended and pursuant to California Horse Racing Board rule #1528 (Jurisdiction of Stewards), subject is denied access to all premises in this jurisdiction.

The above ruling was issued following a formal hearing on Friday, June 4, 2010. Romero was cited for violating the terms of a conditional license issued by the California Horse Racing Board on June 11, 2009. A March 26, 2010 conviction for driving under the influence of alcohol on September 6, 2009 was alleged to have breached the prohibition against use of alcohol.

The conviction resulted in Romero being sentenced to nine months in jail and three years of formal probation. The judge allowed Romero to enroll in a six month in-house alcohol rehabilitation program at Solidarity which will be credited as time served. The remaining three month sentence will be revisited by the judge once the in-house program is completed. Testimony was presented that Solidarity may allow Romero to participate in a work-release program after the first 30 days.

The above suspension was arrived at after considerable discussion. Steward Herbeveux dissented feeling a six month suspension to run concurrent with the in-house rehab program was more appropriate.

**INQUIRY – DISQUALIFICATION – Third Race**

The stewards posted the inquiry sign to evaluate an incident at the top of the stretch involving the place horse, #2 ANGEL OF MYSTERY with Michael Martinez in the saddle and the show horse, #6 HEARDABIRD, ridden by Julien Couton. The stewards observed that Couton checked his mount off the heels of #3 FANCY SUMMER (4<sup>th</sup>, Abel Cedillo) as the field entered the stretch. After a thorough review the stewards disqualified ANGEL OF MYSTERY from second and placed him third behind HEARDABIRD.

Tapes showed that MARTINEZ allowed ANGEL OF MYSTERY to swing wide entering the stretch which then caused HEARDABIRD to go out and onto the heels of FANCY SUMMER. Couton was forced to check abruptly and, in the unanimous opinion of the stewards, lost the opportunity at a better placing.

**INQUIRY – DISQUALIFICATION – Seventh Race**

The stewards lit the inquiry lamp to determine why #5 MISS FOREST (9<sup>th</sup>, Chad Schvaneveldt) steadied at the 5/16 while negotiating the far turn. After a thorough review the stewards disqualified #9 MISSTRAILCITYZONE (6<sup>th</sup>, Barrington Harvey) and placed him ninth behind MISS FOREST. Tapes showed that MISSTRAILCITYZONE stepped in at the 5/16 putting pressure on #6 SWIM SUIT MODEL (5<sup>th</sup>, Gustavo Ortiz) who then squeezed MISS FOREST, who was racing along the rail. Schvaneveldt was forced to check his mount and, in the stewards' unanimous opinion, lost the chance to finish in a higher position.

**LATE SCRATCH – Ninth Race – REFUND**

#4 WARREN'S ROYAL MOM, trained by Sergio Ledezma, was scratched on the recommendation of Dr. Kerr approximately four minutes to post after she diagnosed the filly as off in the right front. On Vet's list. The refund amounted to \$17,111.70.

Today's second race was written for fillies and mares, three year olds and upward, bred or sired in California, racing six furlongs for a claiming price of \$6,250 and five ladies competed.

06-09-10<sup>2</sup> **RULING NO. 91 – GARCIA**

Jockey **JULIO GARCIA** is fined the sum of one hundred dollars (\$100.00) for failure to ride the horse CATSALOT in the eighth race on Sunday, June 6, 2010; a violation of California Horse Racing Board rule #1872 (Failure to Fulfill Jockey Agreement).

The above ruling was issued after Garcia called to take off his mount on Sunday even though he had accepted the call to ride. Julio didn't want to come up from southern California for just one mount.

06-09-10<sup>4</sup> **RULING NO. 92 – ANTON** (Case #10GG091)

Trainer **WILLIAM ANTON**, who started the horse DANGER, second place finisher in the fifth race at Golden Gate Fields on April 3, 2010, is fined the sum of five hundred dollars (\$500.00) pursuant to California Horse Racing Board rule #1887 (Trainer to Insure Condition of Horse) for violation of California Horse Racing Board rule #1843 (a) & (d)

(Medication, Drugs and Other Substances: Unapproved Substance – Dexamethasone – Class 4).

The above ruling was issued following last week's informal hearing. Anton stated he administered the medication well outside the recommended guidelines and was at a loss to explain the high test results.

06-09-10<sup>5</sup> **FILM REVIEW**

Jockey **Michael Martinez** viewed the tapes of last Sunday's third race in which his mount was disqualified from second to third. Martinez swung wide entering the stretch and put a rival on heels. Michael accepted responsibility for the incident and the following penalty was imposed:

Jockey **MICHAEL MARTINEZ**, who rode ANGEL OF MYSTERY in the third race at Golden Gate Fields on Sunday, June 6, 2010, is suspended five (5) racing days (June 13, 16, 17, 18 and 19, 2010) for failure to maintain a straight course entering the stretch and causing interference resulting in the disqualification of his mount from second to third; a violation of California Horse Racing Board rule #1699 (d) & (f) (Riding Rules – careless riding).

06-09-10<sup>6</sup> **STEWARDS' INQUIRY – ACCIDENT – Third Race – NO CHANGE**  
 The stewards posted the inquiry sign to determine the cause of an accident at the 7/8 in this one mile turf event. #3 EL TEJON, ridden by apprentice **Rosario Montanez**, fell suddenly while racing mid-pack entering the clubhouse turn. After a thorough review the stewards affirmed the original order of finish.

Tapes showed that EL TEJON lost his action in his hind quarters and stumbled which caused Montanez to lose his balance and become unseated. No other horses were involved. EL TEJON continued racing with the field and was captured without incident after the race. Montanez was examined by Dr. Seftel and cleared to ride his remaining mount. An accident report is attached.

06-09-10<sup>7</sup> **LATE SCRATCH – Fifth Race – REFUND**  
 #3 ARTFULLY DONE, trained by Debbie Winick, flipped in the paddock during the saddling process and was scratched on the recommendation of track veterinarian Heather Kerr. On Vet's List. The refund totaled \$7,653.30.

06-09-10<sup>8</sup> **STEWARDS' INQUIRY – Fifth Race – NO CHANGE**  
 The stewards lit the inquiry lamp to review the events around the clubhouse turn of this one mile turf race. The leader, #9 ROYALLY SMART, with Julien Couton in the saddle, raced extremely wide around the turn losing considerable ground.

After a thorough review the stewards made the race official without change. ROYALLY SMART went wide on his own accord. Jockey Couton will view the tapes of the race with the stewards in the morning so we can determine how best to prevent a repeat performance in future races.

06-09-10<sup>9</sup> **OFF AND ON AGAIN**  
 Jockey **David Lopez**, aboard #6 ICANTREMEMBER, was unseated near the 6½ during the warm-up period. The ambulance was notified but Lopez waived them off stating to the outrider that he was alright. ICANTREMEMBER was temporarily loose but did not run off even after his bridle came off. The bridle was re-applied and horse and jockey were reunited, eventually finishing fourth.

Just before the final race, Dr. Seftel contacted the stewards to report that he had sent Lopez to the hospital for a precautionary examination stating that David suffered a contusion to his spine and a mild concussion.

06-09-10<sup>10</sup> **LATE SCRATCH – Eighth Race – REFUND**  
 #2 RICHARDSONGDANCE, trained by Lloyd Mason, was scratched as the field was warming up when Dr. Kerr diagnosed the horse as being off in the right front. On Vet's List. The declaration reduced the field to four starters and the show pool was cancelled. The total refund amounted to \$9,261.35.

06-10-10<sup>2</sup> **RULING NO. 94 – TRUJILLO** (Case #10GG0104)

Trainer **EDWARD TRUJILLO**, who started the horse ALYBAMA, second place finisher in the second race at Golden Gate Fields on April 4, 2010, is fined the sum of five hundred dollars (\$500.00) pursuant to California Horse Racing Board rule #1887 (Trainer to Insure Condition of Horse) for violation of California Horse Racing Board rule #1843(a) & (d) (Medication, Drugs and Other Substances: More than one approved medication – Phenylbutazone and Flunixin [Class 4] ).

The above ruling was issued following an informal hearing conducted last week. Trujillo was at a loss to explain the test results because he stated he did not vary his medication program when this horse competed.

06-10-10<sup>3</sup> **FILM REVIEW**

Jockey **Barrington Harvey** reviewed the tapes from Sunday's seventh race in which his mount was disqualified from sixth to ninth for causing tight quarters around the far turn. Tapes showed that Barrington reacted quickly when his horse stepped in and he was held blameless.

**Julien Couton** went over yesterday's fifth race with the stewards where his mount went extremely wide on the first turn. Couton explained the horse has a tendency to do the same thing during morning training hours. He has recommended that the trainer use a stronger bit for the bridle to give him more control. The horse has been placed on the Stewards' List and will be required to work before racing again.

06-10-10<sup>4</sup> **STEWARDS' INQUIRY – Second Race – NO CHANGE**

The stewards posted the inquiry sign to evaluate the start of #2 ROSIE'S FAME after the mare failed to break with the field. When she finally did depart it was without apprentice jockey Gustavo Ortiz. After reviewing the tapes and talking with starter Todd Stephens, the stewards confirmed the order of finish as it appeared on the infield tote board.

Tapes showed that ROSIE'S FAME lifted simultaneous to the opening of the starting gate stall door causing Ortiz to step off and the horse to leave the gate very late.

Since ROSIE'S FAME caused her own problems in the gate and the stall doors opened properly she was declared a starter and no refunds were issued.

06-10-10<sup>5</sup> **STEWARDS' INQUIRY – ACCIDENT – Fourth Race – NO CHANGE**

The stewards again illuminated the inquiry sign when jockey **Michael Martinez** landed on the track approaching the finish line. Tapes showed that #4 BIG WAVE RIDER went wrong (right front) inside the 1/16, stumbled and dislodged Martinez. No other horses were involved or affected. The horse continued on past the wire and was corralled by the outriders. The injuries to the horse were catastrophic and he was euthanized at the scene. Michael Martinez was shaken but uninjured and cleared by Dr. Seftel to ride his remaining mounts. Accident report is attached.

06-10-10<sup>6</sup> **STEWARDS' INQUIRY – Seventh Race – DISQUALIFICATION**

The inquiry sign was posted so the stewards could review an incident near the 1/16 involving #3 ALOTTADAR (2<sup>nd</sup> David Lopez), #2 WIN IS IN (3<sup>rd</sup>, Diego Sanchez), #7 SMOKIN DIXI (4<sup>th</sup>, Jorge Ayarza) and #5 SAVOY (5<sup>th</sup>, Kayla Stra). After a complete review the stewards disqualified ALOTTADAR from second and placed him fifth behind SAVOY.

Tapes showed that ALOTTADAR moved off the rail nearing the 1/16 and in doing so took SAVOY off his path and caused contact between WIN IS IN and SMOKIN DIXI, who were racing outside SAVOY. The incident in the stewards' opinion was severe enough to cost SAVOY the opportunity at a better placing thus resulting in the disqualification.

LOPEZ**, who rode **ALOTTADAR** in the seventh race at Golden Gate Fields on Thursday, June 10, 2010, is suspended three (3) racing days (June 17, 18 and 19, 2010) for failure to make a proper effort to maintain a straight course in the stretch and causing interference resulting in the disqualification of his mount from second to fifth; a violation of California Horse Racing Board rule #1699 (d) & (f) (Riding Rules – careless riding).

The term of this suspension shall not prohibit participation in designated races in California.

The above ruling was issued after Lopez reviewed the tapes of the seventh race with the stewards. Lopez could not offer a reasonable defense for his actions while riding ALOTTADAR and the above penalty was imposed.

The above ruling was issued after Cedillo reviewed the tapes with the stewards. Abel went for racing room along the rail and caused a trailing horse to check sharply and clip heels.

06-13-10<sup>5</sup> **LATE SCRATCH – Seventh Race – REFUND**  
 #3 KRISTENS CAT (Jockey Luis Martinez) was scratched on the recommendation of Dr. Kerr after she reported the filly became fractious in the starting gate and injured herself. On Vet’s List. The refund was \$64,577.18. Jockey Martinez received a bruise in the incident and took off his remaining two mounts.

06-13-10<sup>6</sup> **SEVENTH RACE – BEETHOVEN’S ART**
