11-07-10⁴ **INQUIRY – DISQUALIFICATION – Ninth Race**

The stewards conducted an inquiry following the ninth race to review an incident near the finish, involving #10 ISLAND NATIVE (Juan Hernandez), second and #9 JERSEY SKY (Russell Baze), fifth.

After interviewing the riders involved, considering the patrol judges' report and reviewing the tapes of the race, the stewards decided unanimously to disqualify #10 ISLAND NATIVE from second to fifth.

The tapes show #10 ISLAND NATIVE bearing out in the final sixteenth and severely impeding #9 JERSEY SKY, preventing the latter from placing where he might.

11-10-10³ **RULING NO. 10 – HERNANDEZ**

Jockey **JUAN HERNANDEZ**, who rode **ISLAND NATIVE** in the ninth race at Golden Gate Fields on Sunday, November 7, 2010, is suspended three (3) racing days (November 17, 18 and 19, 2010) for failure to make the proper effort to maintain a straight course in the stretch and causing interference resulting in the disqualification of his mount from second to fifth; a violation of California Horse Racing Board rule #1699 (d) & (f) (Riding Rules – careless riding).

The term of this suspension shall not prohibit participation in designated races in California.

The foregoing ruling was issued after Mr. Hernandez and the stewards reviewed the tapes of the ninth race from Sunday, November 7, 2010.

Mr. Hernandez' mount, ISLAND NATIVE, was disqualified from second to fifth following that race for causing interference in the late stages.

Mr. Hernandez was very forthright in acknowledging he made a late and ineffective effort in controlling his mount prior to causing the interference.

11-13-10³ **FORMAL HEARING – DOUGLAS UTLEY (10GG0190)**
- JERALD PARKER, D.V. M. (10GG0208)

A formal hearing was held this morning to address a CHRB complaint against trainer Douglas Utley alleging a high Phenylbutazone (7.23 ug/ml) reported on his horse FEELINGS, who won the seventh race on August 1, 2010 at the Sonoma County Fair in Santa Rosa.

A companion complaint was filed against Jerald Parker, D.V.M., who was the attending veterinarian for the filly FEELINGS. This complaint alleges double treatment and filing inaccurate confidential vet reports.

Both individuals agreed to a joint hearing as both complaints pertain to the same issue and neither one was represented by counsel.

CHRB senior investigator Gabriel Palomar presented both cases and C.S.R. Christine Niccoli recorded the proceeding.

The Board of Stewards heard testimony from both of the accused and others and received documentary evidence into the record and brought the hearing to a close.

Decision forthcoming.
