12-30-10³ **WILLIAM WILBUR – Case # 10SW0135** (Refer: 08-26-10)
The Board of Stewards met with Deputy Attorney General Allison Ross, who presented a stipulated settlement agreement for consideration in the complaint filed against owner **William Wilbur**.

Mr. Wilbur was charged with a number of alleged California Horse Racing Board rule violations following his use of unregistered jockey silks (colors) on his horse (MUTE RUDULPH) on July 15, 2010 at the California State Fair (Sacramento).

Mr. Wilbur and his counsel, J. Patrick McCarthy were contacted telephonically and C.S.R. Christine Niccoli recorded the proceedings.

The record, which has been on recess since the hearing was held on August 26, 2010, was re-opened for the purpose of memorializing the elements of the agreement.

The Board of Stewards noted their approval of the agreement and will issue a ruling detailing the penalty agreed upon.

12-30-10⁴ **INQUIRY – DISQUALIFICATION – Sixth Race**
The stewards posted the inquiry sign following the running of the sixth race for a review of an incident in the stretch involving #3 NEW GENERATION (Chad Schvaneveldt), second, and #8 TOP RECRUIT (Catalino Martinez), fourth.

After considering the patrol judge's report, interviewing the riders involved and reviewing the tapes of the race, the stewards decided unanimously to disqualify #3 NEW GENERATION from second to fourth.

The tapes show #3 NEW GENERATION drift in, take the path of and impede #8 TOP RECRUIT near the 1/16 pole causing the latter to take back, lose ground and the opportunity of a better placing.

12-31-10³ **RULING NO. 1 – SCHVANEVELDT**

Jockey **CHAD SCHVANEVELDT**, who rode **NEW GENERATION** in the sixth race at Golden Gate Fields on Thursday, December 30, 2010, is suspended three (3) racing days (January 7, 8 and 9, 2011) for failure to make a proper effort to maintain a straight course in the stretch and causing interference resulting in the disqualification of his mount from second to fourth; a violation of California Horse Racing Board rule #1699 (d) & (f) (Riding Rules – careless riding).

The term of this suspension shall not prohibit participation in designated races in California.

The foregoing ruling was issued after Mr. Schvaneveldt and the stewards reviewed the tapes of the sixth race from Thursday, December 30, 2010.

Mr. Schvaneveldt acknowledged he erred in allowing his mount to drift in and impede a rival. The veteran rider accepted the penalty imposed.

12-31-10⁴ **RULING NO. 2 – WILBUR**

Owner **WILLIAM WILBUR**, having entered into a stipulated settlement agreement with the California Horse Racing Board which has been adopted by this Board of Stewards, is hereby suspended from December 28, 2010 through the term of his license (02-28-2011) and fined the sum of one thousand five hundred dollars (\$1,500.00) for violation of California Horse Racing Board rules #1489 (j) (Grounds for Denial or Refusal of License),

#1691 (a) (Colors, Number and Advertising), and #1902 (c) (Conduct Detrimental to Horse Racing).

Further, as a condition of the stipulated agreement, Mr. Wilburn will not apply for a California Horse Racing Board license prior to July 1, 2011.

During the term of suspension, all licenses and license privileges of WILLIAM WILBUR are suspended and pursuant to California Horse Racing Board rule #1528 (Jurisdiction of Stewards), subject is denied access to all premises in this jurisdiction.

The above ruling was issued to formalize a stipulated settlement agreement between the complainant, California Horse Racing Board, and respondent, WILLIAM WILBUR, to settle the complaint filed against the latter alleging misconduct related to the use of colors (silks).

It should be noted that Mr. Wilbur also submitted a letter of apology related to this matter.

The tapes show #6 SPANKSTER (Catalino Martinez) steady sharply along the rail near the 1/16 pole. After a thorough review, the stewards determined Mr. Martinez caused his own problem by attempting to drive through a diminishing opening.
