04-10-11¹ **CAL-BRED REPORT**

The Cal-bred race for four year olds and older, claiming price \$9,000 - \$10,000, six furlongs, failed to fill.

04-10-11² **DECLARATION – REFUND**

04-10-11³ **FILM REVIEW**

Jockey **Inoel Beato**, accompanied by trainer A. L. Diaz, met with the stewards for a review of the fourth race from Saturday, April 9, 2011.

Mr. Beato was advised to straighten a drifting mount before switching his whip from one hand to the other, as it appears was the case in the stretch of the race in question.

The incident did not rise to the level of punitive action, but the rider was advised to change his tactics.

04-10-11⁴ **RULING NO. 56 – PASZKEICZ**

Trainer **ALEX PASZKEICZ** is fined the sum of three hundred dollars (\$300.00) pursuant to California Horse Racing Board rule #1629 (Penalty for Late Declaration) for violation of California Horse Racing Board rule #1698 (Failure to Start and Run) necessitating a late declaration for the horse SCALPERS DREAM from the second race on Saturday, April 9, 2011.

The above ruling was issued after Mr. Paszkeicz accepted responsibility for shipping the wrong horse to Golden Gate Fields from his barn at the Alameda County Fairgrounds (Pleasanton).

04-10-11⁵ **RULING NO. 57 – FOXY JADE**

Acting on a report from the University of California at Davis Maddy Laboratories, that the official blood sample #GG10308, taken from the horse **FOXY JADE**, third place finisher in the fifth race at Golden Gate Fields on November 11, 2010, contained Trenbolone and epi-trenbolone, a metabolite of Trenbolone, class 3 prohibited drug substances, it is hereby order that FOXY JADE be disqualified from all purse monies earned and deemed unplaced, in accordance with the California Horse Racing Board rule #1859.5 (Disqualification Upon Positive Test Finding).

It is further ordered that all purse monies (\$1,344.00) earned or awarded to owners Patrick Harney and Charles Reilly, trainer Rene Amescua and jockey Diego Sanchez be returned to the Paymaster of Purses for redistribution pursuant to California Horse Racing Board rule #1760 (Purse Award or Prize to be Withheld).

The revised order of finish is a follows:

- 3rd – JUMPIN JANET
- 4th – GALLANT VICTORY
- 5th – BACARDI BAY

All records are ordered changed to reflect this ruling. In accordance with California Horse Racing Board rule #1956 (Race Declared Official) this ruling shall not affect the pari-mutuel payoffs.

The foregoing ruling was issued upon receipt of the report from U. C. Davis Maddy Lab and subsequent complaint filed by the California Horse Racing Board.

A hearing regarding the culpability of trainer Rene Amescua is pending.

04-10-11⁶ **INQUIRY – NO CHANGE – First Race**

The stewards posted the inquiry sign following the first race for a review of the stretch run.

After interviewing the riders involved and reviewing the tapes of the race, the stewards decided unanimously to make no change in the original order of finish. The tapes show #4 ELVIES LANE (Frank Alvarado) second, makes a slight shift near the 1/8 pole and #3 RUN SUKI RUN (Julien Couton) fifth, over-reacts and steadies briefly. The incident had no bearing on the outcome.

04-15-11⁴ **INQUIRY – NO CHANGE – Third Race**
 The stewards posted the inquiry sign following the third race for a review of the start. After a thorough review the stewards determined that #4 SANTA'S LOVE (Russell Baze) refused to leave the starting gate with the rest of the field. The starting gate functioned properly and SANTA'S LOVE was declared a starter. SANTA'S LOVE, trained by Genaro Vallejo will be placed on the stewards' list and starter's list until he has satisfied the starter that he can break from the gate. The three year old gelding must also show at least one recorded gate work.

04-15-11⁵ **INQUIRY/BREAKDOWN– NO CHANGE - Seventh Race**
 During the running of the seventh race, #5 BROOKE'S FANTASY (Kevin Krigger) went wrong and fell near the 3/8 pole. Track veterinarian Sara Sporer, who was trailing the field, was quick to the scene and reported the five year old mare broke both forelegs and was euthanized on the track. No other horses or riders involved.
 Track physician David Seftel, M.D., was also quick to respond to the scene and reported jockey Kevin Krigger was uninjured.

04-16-11³ **RULING NO. 58 – SOTO**

Jockey **ALFREDO SOTO** is fined the sum of three hundred dollars (\$300.00) pursuant to California Horse Racing Board rule #1629 (Penalty for Late Declaration) for failure to ride the horse UNBRIDLED BLAZE necessitating a late scratch in the third race on Friday, April 15, 2011; a violation of California Horse Racing Board rule #1872 (Failure to Fulfill Jockey Agreement).

The above ruling was issued after Mr. Soto appeared before the stewards to explain his failure to fulfill his riding engagement on April 15, 2011.

Mr. Soto accepted the mount and rode to Golden Gate Fields with Ramon Gonzalez, the trainer of UNBRIDLED BLAZE, from Pleasanton on the morning of the race.

Mr. Soto stated about 10:00 a.m. he borrowed his brother's car and left the track (GGF) to wire money home to Mexico. The car broke down and after calling his brother he sat in the car until 3:00 p.m.

This is the second recent incident of failing to fulfill an engagement and Mr. Soto was ordered to submit a urine sample for analysis. (Results pending)
