Wednesday

01-25-12¹ **DUTY STEWARD**

Steward John Herbuveaux has the entries and scratch duties for the week.

01-25-12² **FRANKLIN – MOONLIGHT RACING STABLE – DILLENBECK FINANCIALS**

CHRB complaint 11GG239, filed against owner **Laura Franklin** by Pony Express for vanning services in the amount of \$461.65, was resolved between parties per Pony Express representative Jen Lee.

CHRB complaint 12GG002, filed against **Moonlight Racing Stables** by San Francisco Equine for veterinary services in the amount of \$587.10, was resolved by pay agreement between the parties.

The complaint incorrectly listed the owner of Moonlight Racing Stables as Leonard Duncan. Michael S. Duncan is the owner of Moonlight Racing Stable and he signed the pay agreement. Michael S. Duncan is currently under suspension for failing to appear for a financial hearing that was due to be heard on November 30, 2011.

CHRB complaint 11GG238, filed against trainer **Bruce Dillenbeck** by Pony Express Vanning in the amount of \$133.00, was resolved after both parties, Jen Lee and Mr. Dillenbeck, met with this Board.

01-26-12¹ **CAL-BRED REPORT**

Purse \$12,400. For California bred or California sired fillies and mares four years old and upward, claiming price \$10,000 at one mile and one sixteenth. The race was called off with no entries.

01-26-12² **RULING NO. 26 – VELAZQUEZ**

Jockey **JESUS VELAZQUEZ**, who rode **CALLDEROLL** in the seventh race at Golden Gate Fields on Sunday, January 22, 2012, is suspended seven (7) racing days (February 2, 3, 4, 5, 9, 10 and 11, 2012) for failure to make the proper effort to maintain a straight course in the stretch and causing interference resulting in the disqualification of his mount from third to fourth; a violation of California Horse Racing Board rule #1699 (d) & (f) (Riding Rules – careless riding).

The term of this suspension shall not prohibit participation in designated races in California.

The ruling listed above was issued after Mr. Velazquez reviewed the race with the stewards and failed to offer an excusable reason for not correcting his mount's course and causing interference. Seven days were issued after a review of Mr. Velazquez's license history shows his last riding suspension was five days with the last day of that suspension on January 1, 2012.

01-26-12³ **DECLARATIONS – REFUNDS**

1st race: #5 ASTUZIA (Tr. Jerry Hollendorfer) fractious in gate/injured
Track Veterinarian Sara Sporer REFUND: \$21,990.64

The declaration of #5 reduced the field to four wagering interests which resulted in the cancellation and refund of show wagering per CHRB rule 1954 (Pari-mutuel Pools). The addition refund amounted to \$1,232.18.

6th race: #5 SHADAROKEM (Tr. William Delia) sick
Examining Veterinarian Diane Isbell REFUND: \$ 89.20
8th race: #5 COSMIC ANGEL (Tr. Bill McLean) unsound
Track Veterinarian Sara Sporer REFUND: \$6,445.60

01-26-12⁴ **INQUIRY / ACCIDENT – NO CHANGE – Second Race**

The inquiry sign was lit following the running of the second race for a review of an accident involving #4 BISMARCK BAY, ridden by jockey Leslie Mawing, near the 3/8 pole. After reviewing all the recorded views the race was made official.

The recordings show #4 loses its action behind and fall while trailing the field. Jockey Leslie Mawing was uninjured. The horse, after examination by track veterinarian Dr. Sporer, was euthanized at the scene.

01-26-12⁵ **INQUIRY – DISQUALIFICATION – Third Race**

An inquiry was held following the running of the third race for a review of observed interference on the 3/8 turn involving (from the inside out) #4 STUDIO CITY (3rd, Catalino Martinez), #2 FINISH RICH (4th, Aaron Gryder) and #5 REGENT FAN (6th, Kerwin John).

After talking with the riders involved and reviewing the recorded views, #4 was disqualified from third to sixth. The recordings show #4 veers out while attempting to bolt, causing interference to #2 and #5, costing them the opportunity for better placings.

Friday01-27-12¹**CAL-BRED REPORT**

Purse \$10,400. For California bred or California sired four year olds and upward, claiming price \$6,250 at six furlongs. The race was called off with no entries.

01-27-12²**RULING NO. 27 – MOREY**

Trainer **WILLIAM E. MOREY**, who started the horse **RED HOT CHARLOTTE**, winner of the second race at Golden Gate Fields on November 20, 2011, is fined the sum of two thousand dollars (\$2,000.00) pursuant to California Horse Racing Board rule #1887 (Trainer to Insure Condition of Horse) for violation of California Horse Racing Board rule #1843(a) & (d) (Medication, Drugs and Other Substances: Prohibited Substance – Dexamethasone [Class 4] – second offense).

The preceding ruling was issued after Mr. Morey waived his rights to a formal hearing and pled guilty with an explanation. After discussing the matter with his assistant trainer and his attending veterinarian he is of the opinion the error of administration of the drug was due to a mistake made at the barn.

Saturday01-28-12¹**CAL-BRED REPORT**

Purse \$18,400. For California bred or California sired fillies and mares four years old and upward, claiming price \$16,000 at one mile. The race was called off with five entries.

01-28-12²**DILLENBECK FINANCIAL**

CHRB complaint 11GG237, filed against trainer Bruce Dillenbeck by Herb Moniz (Paradise Road Ranch) for care and boarding of Mr. Dillenbeck's horses listed a debt of \$10,387.00. Mr. Dillenbeck paid \$7,955 of the debt, leaving an outstanding balance of \$2,432 which was addressed by pay agreement. It was requested by Mr. Moniz that Mr. Dillenbeck remove his horses and Mr. Dillenbeck signed an agreement to do so by February 4, 2012. All parties were present when the agreement was signed.

01-28-12³ **RULING NO. 28 – BAZE**

Jockey **RUSSELL BAZE** is fined the sum of three hundred dollars (\$300.00) for violation of California Horse Racing Board rule #1688 (b) (1 & 3) (Use of Whips) while riding the horse VULCAN in the seventh race at Golden Gate Fields on January 26, 2012.

The foregoing ruling was issued after Mr. Baze met with the stewards, reviewed the evidence and pled guilty.

01-28-12⁴ **RULING NO. 29 – McLEAN**

Trainer **BILL McLEAN**, who started the horse **HEART'S MUSIC**, who finished fifth in the fourth race at Golden Gate Fields on December 2, 2011, is fined the sum of five hundred dollars (\$500.00) pursuant to California Horse Racing Board rule #1887 (Trainer to Insure Condition of Horse) for violation of California Horse Racing Board rule #1843 (a) & (d) (Medication, Drugs and Other Substances: Prohibited Substance – Dexamethasone [Class 4]).

The ruling listed above was issued after Mr. McLean waived his rights to a hearing and requested to hear the matter informally. Mr. McLean, whose medication record is clear of any violation in over ten years, was at a loss as to how the horse tested positive for the Class 4 substance. Although he uses the drug, to his knowledge all the correct procedures were followed when the drug was given to the horse and the drug should have cleared the horse's system prior to its race.

After determining no other horse was involved the order of finish was made official. Jockey Aaron Gryder was uninjured. The horse was euthanized on the track.
