02-16-12<sup>3</sup> **RULING NO. 35 – HERNANDEZ**

Jockey **JUAN HERNANDEZ**, who rode **BIG TIME SUNSHINE** in the first race at Golden Gate Fields on Sunday, February 12, 2012, is suspended seven (7) racing days (February 24, 25, 26 March 1, 2, 3 and 4, 2012) for altering course without sufficient clearance entering the stretch and causing interference resulting in the disqualification of his mount from first to fifth; a violation of California Horse Racing Board rule #1699 (d) & (f) (Riding Rules – careless riding).

The term of this suspension shall not prohibit participation in designated races in California.

The ruling listed above was after Mr. Hernandez and his agent, Ramon Silva, reviewed the race with this Board and offered an explanation that Mr. Hernandez thought he had sufficient clearance when he altered his course in the stretch. However, after reviewing the race, he saw he was not clear of a horse on his heels and caused that rival to stumble after clipping heels.

Following the running of the first race the stewards were notified two claims were submitted for #6 POWERS LILSIS. One of the claims listed 1-17-12 as the date of the race and the date the paymaster verified the monies are on file. Assistant Paymaster acknowledged the wrong dates were placed on the claim by her on the date of the claim, 02-17-12. All other aspects of the claim were correct. After reviewing CHRB rule 1656 (Errors Which Invalidate Claim) the claim was deemed valid by majority vote with steward Herbuveaux dissenting.

02-17-12<sup>4</sup> **MICHAEL RANDOLPH** (Case #11GG226)  
Groom **MICHAEL RANDOLPH** was cited for alleged violation of California Horse Racing Board rules 1489 (a) (c) (Grounds for Denial or Refusal of License, 1900 (Grounds for Suspension or Revocation) and 1902 (Conduct Detrimental to Horse Racing) after he failed to list his complete criminal history information. When obtaining his original groom's license he correctly answered the question regarding court convictions and listed a 2005 domestic violence conviction but failed to list a 2000 and a 2003 domestic violence conviction. All the convictions were non-disqualifying misdemeanor convictions. After hearing Mr. Randolph's explanation and with the concurrence of CHRB investigative staff, he was allowed to file an amended application.
