03-14-12¹ **DUTY STEWARD**

Steward Darrel McHargue will oversee entries and declarations this week.

03-14-12² **FINANCIAL COMPLAINT** (12GG026)

The Board of Stewards conducted a hearing regarding a complaint filed against owner **John Gish**. The complainant, trainer **Sandy Torok**, alleges Mr. Gish owes \$1516.41 in training and boarding fees. After much wrangling and an item by item audit, the issue was settled for \$771.25.

With the above declarations the field was reduced to four wagering interests and in compliance with CHRB rule 1954 (Pari-mutuel Pools) show wagering was cancelled and the additional refund amounted to \$35.00.

03-15-12³ **PARTNERSHIP DISSOLVED**

The Board of Stewards brokered the breakup of a convoluted partnership. Owner/Trainer **Quentin Miller** and owner **Jan Johnson** were partners in a four year old colt named KNOWN ASSOCIATE. Ms. Johnson's CHRB license was terminated on February 15, 2012 for falsification and transferred her interest to **Justine Fitzhenry**. Ms. Fitzhenry has now sold her interest to **Edward Pestana**, who happens to be the husband of Ms. Johnson.

Mr. Miller signed off his 30% interest in KNOWN ASSOCIATE to Mr. Pestana and in return the three horses Miller has been boarding for some time at Ms. Johnson's ranch will be returned to him without any charges. KNOWN ASSOCIATE will remain on the Stewards' List until Ms. Johnson straightens out her CHRB license issue.

03-15-12⁴ **GATE ACCIDENT – Sixth Race**

As the field for the sixth race was being loaded into the starting gate, #2 TWIST MY KAZOO (Jockey Cristobal Herrera) became fractious and injured his rider. The ambulance crew was right on the scene and reported the rider injured his left knee.

TWIST MY KAZOO was returned to the paddock as the rest of the field dismounted. A replacement rider (Inoel Beato) was named, TWIST MY KAZOO was re-saddled, rejoined the field and the race was run after a nine minute delay.

03-17-12³ **RULING NO. 50 – SWEARINGEN**

In the Matter of:

Owner **RAYMOND “Joe” SWEARINGEN**

Having satisfied the outstanding financial obligation to trainer Sherrie Monroe, the license privileges of Raymond “Joe” Swearingen are restored to good standing and Pacific Racing Association ruling #18, dated January 13, 2012 suspending Mr. Swearingen for violation of California Horse Racing Board rule #1876 (Financial Responsibility), is hereby set aside.

The foregoing ruling was issued after trainer Sherrie Monroe notified the Board of Stewards that owner Raymond “Joe” Swearingen had satisfied his outstanding debt (\$2,369.96).

03-17-12⁴ **HUMBERTO GONZALEZ** (12GG027)
The Board of Stewards conducted an informal hearing for **Humberto Gonzalez**, who is a veterinary assistant working in the test barn.

According to the complaint, Mr. Gonzalez was displaying aggressive and unacceptable behavior toward fellow test barn employees and possibly under the influence.

CHRB senior investigator Barbara Chimero administered a breathalyzer test that registered .102 on the first test and .106 on the second. Decision forthcoming.

As a condition of probation Gonzalez must abide by the terms of a signed testing agreement with the California Horse Racing Board.

The above ruling was issued following the hearing held on March 17, 2012.
