Wednesday04-25-12¹**DUTY STEWARD**

Steward Darrel McHargue will handle entries and declarations for this week.

04-25-12²**TRAINER STEVE MIYADI** (12GG046)

Trainer **Steve Miyadi** appeared in response to a complaint filed against him alleging violations of California Horse Racing Board rules #1843 (a) & (d) (Medication, Drugs and Other Substances), #1844 (c) (1) (Authorized Medication) and #1887 (a) (Trainer to Insure Condition of Horse).

The complaint alleges that on March 3, 2012, Mr. Miyadi started the horse OVER MARKETED, who finished first in the fourth race at Golden Gate Fields. The official blood sample GG13795 showed the presence of phenylbutazone (6.19 ug/ml) in excess of permitted level, a class 4 violation. The split sample was analyzed by Industrial Laboratories and confirmed the presence of phenylbutazone in the amount of 6.7 ug/ml.

Mr. Miyadi waived his right to a hearing and accepted responsibility. Mr. Miyadi believes his veterinarian is using a generic brand of bute that is compounded and is the cause of his recent problems with bute.

04-25-12³**TRAINER NICHOLAS SLOAN** (12GG047)

Trainer **Nicholas Sloan** appeared, waived his right to a hearing and pleaded guilty to the accusation that on March 4, 2012 he used unprovoked force, causing a chest contusion to groom Fernando Amescua, an employee of trainer Andy Mathis. Mr. Sloan also berated Mr. Mathis telephonically with profanities. Mr. Sloan was upset because Mr. Mathis claimed his horse on that day.

04-25-12⁴ **LUIS NARANJO** (11GG191)

The formal hearing for groom **Luis Naranjo** was quickly brought to a halt when he declared on the record that he wanted to seek legal counsel in response to the charges.

Mr. Naranjo has been charged with alleged violation of California Horse Racing Board rules #1489 (a)(c)(f)(h) (Grounds for Denial or Refusal of License), #1900 (Grounds for Suspension or Revocation) and #1902 (Conduct Detrimental to Horse Racing).

This case was originally scheduled to be heard on December 29, 2011 and when Mr. Naranjo failed to appear, his license was suspended.

Mr. Naranjo was advised the hearing would reconvene on May 4, 2012, so that he may obtain counsel.

04-25-12⁵ **TRAINER FRANCES HENDERSON** (12GG044) Refer: 03-30-12³

A formal hearing was held for trainer **Frances Henderson** regarding a financial complaint filed against her by former employee **Michael Randolph**, for unpaid wages. C.S.R. Christine Niccoli recorded the proceedings.

The Board of Stewards heard testimony regarding complainant's employment from Mr. Randolph, Ms. Henderson, assistant trainer Ruben Ramirez, owner Dr. Paul Kypros and owner Darlan Ribeiro.

There was no disputing the fact that Mr. Randolph was an employee by Ms. Henderson. The only question is, were his duties worth fifty dollars per week as Ms. Henderson contends, or one hundred dollars per week as Mr. Randolph argues was their agreement.

RULING NO. 62 – SLOAN (12GG047) (Refer 4-25-12³)

Trainer **NICK SLOAN** is hereby fined the sum of four hundred dollars (\$400.00) and placed on probation through April 20, 2013 for violation of California Horse Racing Board rule #1874 (2) & (4) (Disorderly Conduct) on March 4, 2012.

The above ruling was issued as Mr. Sloan acknowledged he lost his cool subsequent to his losing his horse ONE MO, via the claim box.

In addition to the above ruling and a part of the settlement agreement, Mr. Sloan has agreed and is so directed to pay the workers compensation insurance deductible fee (not to exceed \$500.00) to trainer Andy Mathis, the complainants employer.

RULING NO. 63 – MIYADI (12GG046) (Refer 04-25-12²)

Trainer **STEVE MIYADI**, who started the horse **OVER MARKETED**, winner of the fourth race at Golden Gate Fields on March 3, 2012, is fined the sum of one thousand dollars (\$1,000.00) pursuant to California Horse Racing Board rule #1887 (Trainer to Insure Condition of Horse) for violation of California Horse Racing Board rule #1843(a) & (d) (Medication, Drugs and Other Substances: Phenylbutazone – in excess of permitted level – 6.19 ug/ml [Class 4] – second offense).

The preceding ruling was issued following the hearing held on April 25, 2012. This was Mr. Miyadi's second bute (Class 4) offense within one year and warranted the fine imposed.

RULING NO. 64 – HENDERSON (12GG044) (Refer 04-25-12⁵)

Trainer **FRANCES HENDERSON** is hereby directed to pay groom Michael C. Randolph the sum of fourteen hundred dollars (\$1,400.00) for wages by May 10, 2012. Failure to make such payment shall be cause for the suspension of Frances Henderson's license privileges for violation of California Horse Racing Board rule 1876 (Financial Responsibility).

The foregoing ruling was issued subsequent to the formal hearing held on April 25, 2012.

After discussion and deliberation, the Board of Stewards, accepting the fact that the employment of complainant Michael Randolph was indisputable, concluded that the duties as described by the witnesses warranted at least one hundred dollars (\$100.00) per week, the amount sought by the complainant.

04-28-12³**OBJECTION – Sixth Race – NO CHANGE**

Following the running of the sixth race jockey Leslie Mawing, who rode #2 KING COLA (4th), lodged a claim of foul against #4 CLOSE PURSUIT (3rd) ridden by jockey Ronald Richard. Jockey Mawing alleged interference near the 5/16 pole.

After considering the patrol judges report, interviewing the riders involved and reviewing the video, the stewards decided unanimously to allow the original order of finish to remain unchanged.

The video shows #2 KING COLA steady sharply along the rail after making contact with #4 CLOSE PURSUIT and it appears the former actually took a step outward and initiated the contact.

04-29-12³**INQUIRY/ OBJECTION – DISQUALIFICATION – Second Race**

The stewards posted the inquiry sign following the second race for a review of the entire stretch run that showed the two leaders, #6 SKIP TONY (Kerwin John), who finished first by a neck and #3 MAGICO (Frank Alvarado) second, finish toward the outside of the track.

Jockey Alvarado also lodged a claim of foul against #6 SKIP TONY regarding the same issue. After considering the patrol judges report, interviewing the riders involved and reviewing the video, the stewards, by majority decision (McHargue dissenting), disqualified #6 SKIP TONY from first to second.

The video shows #6 SKIP TONY drift wide entering the stretch taking #3 MAGICO with him, then continuing to drift all the way to the wire causing the latter to lose ground and the opportunity to place where it might, were it not for the interference.
