05-16-12 **ENTRIES and DECLARATIONS**

05-17-12¹ **POWER OUTAGE UPDATE**

Assistant General Manager Cal Rainey reported that all power was restored to the grandstand and barn area after Golden Gate Fields electricians and P. G. & E. personnel spend the off days (May 14, 15 and 16) repairing hot spots. The corporation yard remains on generator power as one more cable needs to be replaced and that will be done on the next dark days (May 21, 22 and 23). 05-17-12⁵ **INQUIRY – DISQUALIFICATION – Fifth Race**

The stewards posted the inquiry sign following the fifth race for a review of an incident in the stretch involving #6 TAXI RIDE (Juan Hernandez) sixth, #5 TRAPPER'S REWARD (Aaron Gryder) third and #4 SARA GOT EVEN (Francisco Duran) seventh.

After interviewing the riders involved, considering the patrol judge's report and reviewing all video angles, the Board of Stewards decided unanimously to disqualify #6 TAXI RIDE from sixth and place him seventh for causing interference near the 1/16 pole.

The video shows #6 TAXI RIDE drift out into the path of #5 TRAPPER'S REWARD, who in turn bumped #4 SARAH GOT EVEN, preventing both the opportunity of better placing.

05-18-12³ **RULING NO. 74 – GRYDER** (Refer 05-17-12⁴)

Jockey **AARON GRYDER** is fined the sum of fifty dollars (\$50.00) pursuant to California Horse Racing Board rule #1530 (Cases Not Covered by Rules and Regulations) for reporting late to the paddock for the first race on Sunday, May 13, 2012.

05-18-12⁴ **RULING NO. 75 – HERNANDEZ** (Refer 05-17-12⁵)

Jockey **JUAN HERNANDEZ**, who rode **TAXI RIDE** in the fifth race at Golden Gate Fields on Thursday, May 17, 2012, is suspended three (3) racing days (May 25, 26 and 27, 2012) for failure to make the proper effort to maintain a straight course in the stretch and causing interference resulting in the disqualification of his mount from sixth to seventh; a violation of California Horse Racing Board rule #1699 (d) & (f) (Riding Rules – careless riding).

The term of this suspension shall not prohibit participation in designated races in California.

The foregoing ruling was issued after Mr. Hernandez and his agent Ramon Silva met with the Board of Stewards for a review of the fifth race on Thursday, May 17, 2012.

Mr. Hernandez stated he simply didn't realize he was drifting off course and acknowledged he erred.

05-18-12⁵ **ACCIDENT – INQUIRY – Seventh Race**

The stewards posted the inquiry sign following the seventh race for a review of an accident in the stretch.

The video shows #6 LOOK FOR ANSWERS (Juan Hernandez), while on the lead of this one mile turf event, duck in sharply and jump the inside rail near the 1/8 pole. Jockey Hernandez, who was unseated, suffered a bruised wrist and LOOK FOR ANSWERS was uninjured, but will go on the stewards' list.
