Former jockey **Jack Kaenel** appeared today seeking direction concerning the possibility of obtaining a California jockey license. Kaenel has not been licensed in this state since 2006 when he was suspended for violating the terms of his conditional exercise rider's license.

Kaenel was advised how to proceed should he decide to pursue this quest but was also cautioned that should his licensure be denied in California it could affect any licenses he holds in other states.

09-01-12³**SHOE SHOP-TALK**

Horseshoe inspector **Butch Fyllingness** met with the stewards this morning concerning the record keeping process for horses that run without shoes in northern California. Butch was concerned that horses coming from the fairs or from southern California may slip through the cracks with respect to the mandates contained in rule #1853 (Examination Required).

Fyllingness was advised to insure that his record keeping system was in order and if problems with shippers arise the stewards will research and deal with them on an individual basis.

09-01-12⁴**LATE SCRATCH – Eighth Race – REFUND**

#4 TROPILUK, trained by Mike Lenzini, was scratched on the recommendation of track veterinarian Sara Sporer, D.V.M. after the horse flipped in the starting gate and became cast underneath the gate. After very carefully moving the starting gate TROPILUK was extricated and walked off the track under his own power with minor abrasions. Dr. Sporer, along with starter Todd Stephens and his crew deserve kudos for their efforts in minimizing the effects of a precarious situation. Post time was delayed approximately 12 minutes and the refund amounted to \$34,398.72.

09-02-12²**JOCKEY OBJECTION – Seventh Race – NO CHANGE**

Jockey **Inoel Beato**, aboard the sixth placed horse #2 STORMY FRANK, lodged a claim of foul against the fifth placed horse #5 WESTERN VINO with Pedro Flores in the saddle. Beato alleged interference at the 1/8. After a thorough review the stewards dismissed the objection.

Tapes showed that WESTERN VINO stepped in near the 1/8 putting STORMY FRANK in

close quarters but always left enough room for STORMY FRANK to maneuver. It appeared Beato anticipated that WESTERN VINO would continue in toward the rail but such was not the case.

#9 MADI TWO SHOES, trained by Holly Evans, was scratched on the recommendation of Dr. Sporer after the filly flipped in the starting gate and injured herself. On Vet's list. The refund totaled \$23,316.50.

09-03-12³ **JOCKEY OBJECTION – Ninth Race – NO CHANGE**

Jockey Alejandro Gomez, aboard the show horse #2 GALITZIANER, filed an objection against the winner, #5 SIBERIAN LAUGHTER, ridden by Julien Couton. Gomez maintained he was fouled at the 1/16. After a thorough review the stewards disallowed the claim of foul. Tapes showed that it was GALITZIANER who came out just before the wire and initiated the contact with SIBERIAN LAUGHTER.

09-03-12⁴ **STEWARDS' INQUIRY – Tenth Race – DISQUALIFICATION**

The stewards lit the inquiry lamp to evaluate contact between #7 DOWN TOWN CLYDE (2nd, Freddy Rodriguez) and #4 SHALL I DANCE (5th, David Lopez) at the 1/8. After a thorough review the stewards disqualified DOWN TOWN CLYDE from second and placed him fifth behind SHALL I DANCE.

Tapes showed DOWN TOWN CLYDE came in at the 1/8 under a right handed whip, bumped and impeded SHALL I DANCE and in the opinion of the stewards, cost SHALL I DANCE the opportunity at a better placing. Rodriguez will review the tapes of the race with the stewards on Wednesday.
