JOCKEY OBJECTION – FIFTH RACE – DISQUALIFICATION

Jockey Christian Santiago Reyes aboard the seventh placed horse, #5 SECRET SPY, lodged a claim of foul against the fifth placed finisher, #3 MUTE RUDULPH with Frank Alvarado in the saddle. Reyes alleged interference around the far turn. After reviewing the tapes of the race the stewards disqualified MUTE RUDULPH from fifth and placed him eighth behind #6 GOLDEN JET (David Lopez).

Tapes showed that MUTE RUDULPH bore out around the far turn and in doing so caused SECRET SPY and GOLDEN JET to shorten stride and lose ground.

In the opinion of the stewards the incident cost both horses the opportunity at a better Placing. Jockey Frank Alvarado will view the tapes of the race with the stewards in the morning.

1-4-13³**LATE SCRATCH – SEVENTH RACE – REFUND**

#5 CATONNIER, trained by Jerry Weaver, was scratched by the Stewards on the Advice of Official Veterinarian, Forrest Franklin, in mid afternoon after he examined the mare and determined she was sick. On vet's list. The refund amounted to \$316.82.

The Stewards placed the horse on the Stewards List and will contact trainer Bill McLean about his plans for an equipment change.

Jockey Catalino Martinez aboard the fifth placed finisher, #6 ANDYDAR, lodged a claim of foul against the winner #5 STEFANELLI with Eric Camacho in the saddle. Martinez alleged interference in the stretch. After a thorough review the stewards dismissed the objection as the tapes failed to substantiate that Martinez suffered any interference.

1-06-13²**FILM REVIEW**

Jockey Angel Sanchez viewed the tapes of yesterday's eighth race where he rode #5 KING KAYAN for trainer Reina Gonzalez. Sanchez appeared very tentative on the horse and stated he was in close quarters all down the backstretch of this 5 ½ furlong dash. The stewards did not share Sanchez' opinion regarding the close quarters but concurred with his decision that he was not going to make himself available to ride the horse in the future.

1-06-13³**RULING NO. 07**

Jockey INOEL BEATO, is fined the sum of one hundred dollars (\$100.00)* for failure to ride his mounts on Friday, December 28, 2012 and Sunday, December 30, 2012; a violation of California Horse Racing Board rule #1872 (Failure to Fulfill Jockey Agreement).

The above ruling was issued after Beato met with the stewards regarding his absence on the two days referenced above. Beato explained that he returned home to the Dominican Republic and obtaining an exit visa prevented his timely departure from that island.

The majority felt the penalty imposed was sufficient while Steward Nevin felt a \$200.00 fine was appropriate because Beato missed two days.

1-06-13⁴**STEWARDS INQUIRY – JOCKEY OBJECTION – EIGHTH RACE – NO CHANGE**

The Stewards posted the inquiry sign to evaluate contact in late stretch between the winner, #3 EAGLE SCREAMS, with Inoel Beato in the saddle and the place horse #5 HEROICALLY, with Dennis Carr aboard. Carr also lodged a claim of foul against the winner. After a thorough review the stewards made the original order of finish official.

Tapes showed that while EAGLE SCREAMS drifted in slightly during the last 1/16 it was HEROICALLY who made a major outward shift to initiate contact. Jockey Carr will review the tapes of the race with the Stewards on Thursday.
