1-30-13¹ **ENTRIES AND DECLARATIONS DUTIES**

Steward John Herbuveaux was present today for entries for Saturday, February 2 and declarations for tomorrow. Mr. Herbuveaux will continue with those duties for the remainder of the week.

1-31-13¹ **CAL-BRED REPORT**

Purse \$13,000. For California bred or California sired fillies and mares four years old and upward, claiming \$10,000 at one mile. The race was called off with three entries.

1-31-13² **FILM REVIEW – Jockey Pedro Terrero**

Mr. Terrero was invited in to review the stretch run of Sunday's sixth race in which he rode #4 BLACK TORNADO.

The recordings show Mr. Terrero's mount shift out suddenly and make contact with a horse on his outside after he applied a left hand whip. Although the shift of his mount was sudden, he was informed this Board is of the opinion he could have responded quicker and we expect him to do so in the future. A warning was issued.

Friday2-1-13¹**CAL-BRED REPORT**

Purse \$20,000. For California bred or California sired three olds. Claiming \$20,000 at six furlongs. The race received only one entry and was called off.

2-1-13²**RULING NO. 18 – LAURA FRANKLIN**

On January 17, 2013 the California Horse Racing Board adopted the Administrative Law Judge's proposed decision as the Board's Decision in the above referenced matter. That decision amended Alameda County Fair ruling #18 dated July 14, 2011 to read as follows:

It is determined that Owner Laura Franklin is indebted to San Francisco Equine, Inc. in the amount of \$19,055.24, which represents all charges for services rendered between May 7, 2007 and November 16, 2010.

Laura Franklin is hereby directed to satisfy the obligation to San Francisco Equine, Inc., either by payment in full or, if acceptable to both parties, by payment agreement, by a date that shall be set by the California Horse Racing Board. Should the Board of Stewards thereafter be formally notified by San Francisco Equine, Inc., that Franklin failed to resolve this obligation by the date set by the board, she will be deemed to be in violation of California Horse Racing Board rule 1876 (Financial Responsibility), which shall result in suspension of her California Horse Racing Board licensing privileges.

Acting for the California Horse Racing Board this Board of Stewards sets February 21, 2013 as the date by which Owner Laura Franklin shall satisfy the financial obligation of \$19,055.24 to San Francisco Equine, Inc., either by payment in full or, if acceptable to both parties, by payment agreement. Failure to resolve this obligation shall result in the suspension of her California Horse Racing Board licensing privileges for violation of rule 1876 (Financial Responsibility).

The foregoing ruling was issued after the California Horse Racing Board referred this matter to the Stewards to set a date for either the debt to be paid or a payment agreement set that both parties agree upon.

2-1-13⁴**INQUIRY – JOCKEY OBJECTION – 4th Race**

After the running of the fourth race the inquiry sign was posted for a review of the stretch run involving #7 TRICKY SHANE (1st place – jockey Saul Arias) and #2 CARDIO ROYALE (2nd place – jockey Alejandro Gomez).

Mr. Gomez also lodged a claim of foul against the winner for interference.

After talking to the riders involved and reviewing the recordings #7 TRICKY SHANE was disqualified from 1st to 2nd.

The tapes show two separate points of contact with the rider of #7 drifting inward, while whipping right handed inside the eighth pole, making contact with the #2 bumping and impeding that rival. Thus, the disqualification.

Both horses contributed to the second incident inside the sixteenth pole as #7 drifted inward again as #2 drifted out making that a non issue.

2-2-13¹

CAL-BRED REPORT

Purse \$12,000. For California bred or California sired fillies and mares four years old and upward at six furlongs. The race was called off with one entry.

2-2-13²

RULING NO. 19 – JOCKEY SAUL ARIAS

Jockey SAUL ARIAS, who rode TRICKY SHANE in the fifth race at Golden Gate Fields on Thursday, February 1, 2013 is suspended three (3) racing days (February 9, 10 and 14, 2013) for failure to make a proper effort to maintain a straight course in the stretch and causing interference resulting in the disqualification of his mount from first to second. A violation of California Horse Racing Board rule 1699 (d) & (f) (Riding Rules – careless riding).

The preceding ruling was issued after jockey David Lopez, who was representing Mr. Arias, reviewed the race with the Stewards and relayed what Mr. Arias told him yesterday when they reviewed the race. Mr. Arias did not dispute that he erred, in the first incident, when he allowed his mount to drift inward and foul the horse on his inside. Mr. Arias was of the opinion that the second incident of contact was caused by the inside horse drifting out into him. The recordings show both horses contributed to the second incident.

2-2-13³

INQUIRY – DOUBLE DISQUALIFICATION – 5th RACE

Following the running of the fifth race the inquiry sign was posted for review of interference at the start involving #2 CATATONIC CAT (3rd place – jockey Alejandro Gomez), #3 DREWTHETIGER (5th place – jockey Francisco Duran), #4 MOJAVE SECRET (11th place – jockey Eric Camacho), #5 MANSION MAYHEM (10th place – Alvarado), #6 GALEA (9th place – jockey Pedro Terrero), #7 GOLDEN EMPEROR (8th Place – jockey Kerwin John) and #9 WAKE (4th place – jockey Arnold Perez).

After a thorough review of the incident the #2 CATATONIC CAT and #9 WAKE were disqualified for 3rd and 4th place to 10th and 11th.

The recordings show #2 break outward and interfere with #3, #4 and #5 as #9 crosses over without clearance and causes interference to #6, #7 and #5 costing the rivals a better placing. The decision was unanimous.

2-3-13¹

CAL-BRED REPORT

Purse \$13,000. For California bred or California sired fillies and mares four years old and upward, claiming \$10,000 at one mile. The race was called off with two entries.

2-3-13²**RULING NO. 20 – APPRENTICE JOCKEY ARNOLD PEREZ**

Apprentice jockey ARNOLDO G. PEREZ, who rode WAKE in the fifth race at Golden Gate Fields on Saturday, February 2, 2013 is suspended three (3) racing days (February 10, 14 and 15, 2013) for crossing over without sufficient clearance leaving the starting gate and causing interference failure to make a proper effort to maintain a straight course leaving the starting gate and causing interference resulting in the disqualification of his mount from third to tenth. A violation of California Horse Racing Board rule 1699 (d) & (f) (Riding Rules – careless riding).

The above ruling was issued after Mr. Perez and his agent, John Valenzuela, reviewed the race with the Stewards. After reviewing the different angles of the incident Mr. Perez candidly acknowledged his errors of not making the necessary course corrections when horses were on his mounts heels.

2-3-13³**RULING NO. 21 – JOCKEY ALEJANDRO GOMEZ**

Jockey ALEJANDRO E. GOMEZ, who rode CATATONIC CAT in the fifth race at Golden Gate Fields on Saturday, February 2, 2013 is suspended three (3) racing days (February 10, 14 and 15, 2013) for failure to make a proper effort to maintain a straight course leaving the starting gate and causing interference resulting in the disqualification of his mount from third to tenth. A violation of California Horse Racing Board rule 1699 (d) & (f) (Riding Rules – careless riding).

The preceding ruling was issued after Mr. Gomez and his interpreter reviewed the race and acknowledged his mistakes of failing to straighten his mount in a timely fashion.

2-3-13⁵**ACCIDENT – INQUIRY - 6th RACE**

The inquiry sign was lit for a review of an accident near the eighth pole in the sixth race involving #7 BLAST THE CAT (3rd place – jockey Pedro Flores), #5 THIRSTY FOR MORE (fell – jockey Navin Mangalee), #2 BLACK MANGO (fell – jockey Jose Delgadillo) and #9 MONSAJEM MIMESIS (7th place – jockey Arnold Perez).

After reviewing the recordings of the race #7 BLAST THE CAT was disqualified from 3rd to unplaced.

The recordings show #7 BLAST THE CAT drift over into the path of #5 THIRSTY FOR MORE causing that horse to stumble and fall. #2 BLACK MANGO, unable to avoid the fallen horse and rider tripped and also fell. #9 MONSAJEM MIMESIS, while racing on the rail behind the accident, managed to stay up after stumbling over #5 THIRSTY FOR MORE.

Jockey Navin Mangalee, after examination by Dr. Seftel (Track Physician) was transported to Highland Hospital. It was reported later that Mr. Mangalee suffered a broken collarbone. Jockey Jose Delgadillo was uninjured.

#2 BLACK MANGO sustained a severe right foreleg fracture and was euthanized at the scene. #5 THIRSTY FOR MORE appeared to escape serious injury.
