10-30-13¹ **DUTY STEWARD**

Steward Darrel McHargue was present to supervise the entry and declaration process.

10-31-13¹ **CAL-BRED REPORT**

The Cal-bred race for maidens, three years old and older, claiming \$12,500., one mile, failed to fill.

10-31-13² **RULING #16 – KYLE FREY**

Jockey **KYLE FREY** who rode **STOP THE CLOCK** in the seventh race at Golden Gate Fields on Sunday, October 27, 2013 is suspended five (5) racing days (November 7, 8, 9, 10 and 11, 2013) for failure to make a proper effort to maintain a straight course in the stretch and causing interference resulting in the disqualification of his mount from second to fifth; a violation of California Horse Racing Board Rule #1699 (d) & (f) (Riding Rules - Careless Riding).

The above ruling was issued after Mr. Frey met with the Stewards regarding his ride in the seventh race on Sunday, October 27, 2013.

Mr. Frey acknowledged he erred by failing to control his mount in the stretch, resulting in the disqualification of his mount. Steward McHargue felt a warning was warranted.

11-1-13³ **RULING NO.17**

Acting on a report from University of California at Davis Maddy Laboratories, the official Laboratory for the California Horse Racing Board, that the post race urine sample GG17236 taken from the horse **SORENSTAM**, first place finisher in the seventh race at Golden Gate Fields on August 23, 2013 contained the prohibited substances Meprobamate and OH-Carisoprodol, a metabolite of Carisoprodol, it is hereby ordered that SORENSTAM be disqualified from all purse monies earned and deemed unplaced, in accordance with California Horse Racing Board rule #1859.5 (Disqualification Upon Positive Test Finding).

It is further ordered that all purse monies (\$16,200.00) earned or awarded to owners Gary and Wendy Broad, trainer Rene Amescua and jockey Alejandro Gomez be returned to the Paymaster of Purses for redistribution pursuant to California Horse Racing Board rule #1760 (Purse Award or Prize to be Withheld).

The revised order of finish is as follows:

- 1st: GOTTA LOVE HER
- 2nd: GLOBAL WARMING
- 3rd: PURE SMILES
- 4th: SOUL OF VERVE
- 5th: TIZ SHOCKING
- 6th: ONNA BUGEISHA
- 7th: VALI'S HALO

The foregoing ruling was issued after Owners Gary and Wendy Broad waived their right to a hearing with the understanding that their horse, SORENSTAM, would be disqualified and deemed unplaced.

A hearing is scheduled on November 29, 2013 for Rene Amescua, the trainer of SORENSTAM.
