EXERCISE RIDER ARTURO M. CASTANEDA

RULING NO.22

Pursuant to a stipulated agreement with the California Horse Racing Board Exercise Rider **ARTURO M. CASTANEDA** is placed on probation through February 1, 2015 for violation of California Horse Racing Board rule #1530 (Cases Not Covered by Rules and Regulations) on August 2, 2013.

The ruling listed above was issued after a stipulated agreement was reached with all parties involved. Mr. Castaneda was cited after he purchased belt buckles at the fair that could also be used as brass knuckles.

02-06-14⁵**TRAINER JERRY HOLLENDORFER – RULING NO.23**

Trainer **JERRY HOLLENDORFER**, who started the horse **ROSEWHITENBLUE**, winner of the first race at Golden Gate Fields on October 25, 2013, is fined the sum of five hundred dollars (\$500.00)* pursuant to California Horse Racing Board Rule #1887 (Trainer to Insure Condition of Horse) for violation of CHRB rule #1843 (a) & (d) (Medication, Drugs and Other Substances: Phenylbutazone – (a) in excess of permitted level 2.6 ug/ml [Class 4]).

The foregoing ruling was issued after Mr. Hollendorfer appeared before this Board and pled guilty with an explanation. After reviewing his records regarding the medications given to the horse he was at a loss as to how the horse tested above the permitted level since the administration of Bute was given early in the morning on the day prior to the horse's race, which, in his experience, is sufficient time for the medication to clear the horse's system.

02-06-14⁶**MORRIS PARKER MEDICATION WARNING**

Trainer Morris Parker phoned the Stewards this morning to address California Horse Racing Board case number 14GG0002 filed against him for a Bute overage of 4.8 ug/ml and was issued a warning as outlined in rule 1844 (c) (1) Category "D" penalties. Mr. Parker stated he has since stopped using Phenylbutazone paste and will have the Veterinarian administer the medication in the future.

02-06-14⁷**VOIDED CLAIM – 6th RACE**

The claim submitted for #3 VERY ELUSIVE (IRE) was deemed void after the Horse Was placed on the Veterinarian's List following the 6th race. The horse was returned to William E. Morey's barn.

In the matter of:
Owner/Exercise Rider Clemente V. Galvan

The Exercise Rider license privileges of Clemente V. Galvan are hereby summarily suspended pending certification from the track physician that Mr. Clemente is cleared to resume exercising horses.

The preceding ruling was issued after this Board became aware that Mr. Galvan circumvented getting a medical clearance, before obtaining an exercise license, by traveling to Southern California and securing the license. Mr. Galvan came into the Stewards office earlier seeking approval for the license and was instructed to get medical clearance when it was learned he had an injury (horse related) that had kept him from working for two years.

Nolan, for an overage of Phenylbutazone (5.0 ug/ml) taken from the horse "LUCY WIGGLES" that raced on December 1, 2013 was addressed with a warning. Mr. Nolan reported that he administered the medication via a paste syringe and has since stopped using the syringes due to the lack of dosage consistencies.
