04-16-15³**RULING #67 – EDWARD R. FREEMAN****RULING#67**

Trainer **EDWARD R. FREEMAN** is hereby fined the sum of Three Hundred Dollars (\$300.00)* pursuant to California Horse Racing Board rule #1629 (Penalty for Late Declaration) for violation of California Horse Racing Board rule #1588 (i) (Horse Ineligible To Start in Race - on Veterinarian's list) necessitating a declaration for the horse **EDDIE COULD GO** in the seventh race on Thursday April 16, 2015.

The foregoing ruling was issued after Mr. Freeman accepted responsibility for the late declaration of his horse EDDIE COULD GO from the seventh race on Thursday, April 16, 2015.

Mr. Freeman acknowledged EDDIE COULD GO was treated with the anabolic steroid Stanozolol within the last sixty days and was not properly reported to any state veterinarian for inclusion on the Vets List.

04-16-15⁴ **CHRB EQUINE MEDICAL DIRECTOR**
Dr. Rick Arthur, DVM, met with the Stewards this morning prior to the California Horse Racing Board meeting. Discussions with Dr. Arthur are always informative and today was no exception.

04-16-15⁵ **BREAKDOWN – 1ST RACE**
#3 DIAMOND FLUSH (Trainer R.B. Hess) went wrong inside the 1/16 pole and was pulled up by jockey Abe Cedillo. Track Veterinarian Sara Sporer, DVM, reported a left foreleg suspensory injury and DIAMOND FLUSH was vanned off.

04-16-15⁶ **HORSE PULLED UP SORE – 5TH RACE**
#1 SUMMER FASCINATION (Trainer Gerard Piccioni) went wrong following the fifth race and was given a ride home in the horse ambulance. Track Veterinarian Sara Sporer, DVM, reported the five year old mare was sore in both forelegs with no major injury apparent.

04-16-15⁷ **GUILD REPRESENTATIVE VISITS**
Jockey Guild representative Darrell Haire met with the Stewards following the California Horse Racing Board monthly meeting.

04-17-15³ **RULING #68 – JOSEPH BROOK**

RULING#68

Trainer **JOSEPH BROOK** is fined the sum of One Hundred Dollars (\$100.00)* for failure to follow proper procedure regarding the policy for running a horse

unshod on Sunday, April 12, 2015; a violation of California Horse Racing Board rule #1853 (b) (Examination Required).

Trainer Joseph Brook appeared before the Board of Stewards to explain why he failed to note on the entry of his horse LUCK LASTS that he runs with hind shoes off.

Mr. Brooks explained he made the entry by telephone and thought he told the clerk no hind shoes, but accepts responsibility.

04-17-15⁴ **OBJECTION – NO CHANGE – 2ND RACE**

While the Stewards were conducting a review of the stretch run for the public, jockey Russell Baze, who finished second, lodged a claim of foul against the winner #3 CURLY BOY (Juan Hernandez).

After posting the objection sign and conducting a thorough review, the Stewards decided unanimously to make the original order of finish official.

The video shows #3 CURLY BOY drift in slightly on two occasions inside the 1/16 pole while on the lead and #6 HONDO shifted in with him.

The incident, in the Stewards opinion had no bearing on the outcome.

04-17-15⁵ **CLAIM VOIDED – 2ND RACE**

The Stewards voided the claim submitted by Trainer Efrain Miranda for #1 VALLEY CAT (Jerry Hollendorfer) after State Veterinarian Forrest Franklin reported the eight year old gelding bowed in the right foreleg. VALLEY CAT was returned to the Hollendorfer barn.

04-17-15⁶ **INQUIRY – NO CHANGE – 3RD RACE**

The Stewards posted the inquiry sign to review an incident near the 3/16 pole on the turf. #1 CHARLIE'S ANGEL (Russell Baze) took a bad step and no other horses were involved.

Safety Steward Richard Lewis, who watched the race went immediately to the spot on the turf and reported there were no soft spots or holes, just hoof divots. Mr. Lewis instructed the turf maintenance crew to fill those divots with the san-loam-seed mixture used on the turf.

Mr. Hernandez' mount was the subject of an objection and while there was no disqualification he was advised to maintain a straight course, whether on the lead or otherwise.

04-18-15⁴**ACCIDENT – POST PARADE – 1ST RACE**

Jockey Pablo Flores was unseated from his mount #6 MONSAJEM ACCRETE during the parade to the post and injured his hand. Track physician David Seftel, M.D., reported a possible broken thumb.

MONSAJEM ACCRETE was captured by the outrider and returned to the paddock. Mr. Flores was excused and replaced by jockey Russell Baze. Accident report attached.

04-19-15³**INQUIRY – NON STARTER – 2ND RACE**

The Stewards posted the inquiry sign following the second race for a review of the start, to determine if #7 COURTING MISCHIEF (Jockey Anne Sanguinetti) had a fair start.

After reviewing the video, the Stewards decided unanimously to declare #7 COURTING MISCHIEF a non-starter and ordered a refund of all wagers on that horse (\$8,516.27).

The video clearly shows COURTING MISCHIEF had her head pinned behind the stall post when the field was dispatched.

04-19-15⁴ **ACCIDENT – 5TH RACE**

#5 SHARPTON (Dennis Carr) became fractious and flipped in the starting gate prior to the start of the fifth race and was scratched. Jockey Carr suffered what appeared to be a head injury and track physician David Seftel, M.D., reported the veteran rider would be transported to Highland Hospital.

04-19-15⁵ **CLAIM VOIDED – 9TH RACE**

The claim for #8 HER AGAIN (Tr. W. E. Morey) submitted by trainer Sheldon Paldanius was voided by the Stewards after State Veterinarian Forrest Franklin, DMV, reported the three year old filly was unsound in the right hind leg.
