11-06-15³ RULING #17-JONATHAN HERNANDEZ

Jockey **Jonathan Hernandez** who rode Sacrificial Action in the first race at Golden Gate Fields on Sunday, November 1, 2015 is suspended three (3) racing days (November 12, 13 and 14, 2015) for failure to make a proper effort to maintain a

straight course in the stretch and causing interference resulting in the disqualification of his mount from third to fifth a violation of California Horse Racing Board rule #1699 (d) & (f) (Riding Rules-Careless Riding).

The above ruling was issued after Mr. Hernandez and the Stewards reviewed the video of the first race from Sunday November 1, 2015. Mr. Hernandez was very candid in acknowledging that he erred by failing to keep a straight course down the stretch.

11-06-15⁴ **RULING #18-MIGUEL PEREZ**

Jockey **Miguel Perez** is fined the sum of fifty dollars (\$50.00)* for reporting late to the jockey's room on Sunday, November 1, 2015; a violation of California Horse Racing Board rule #1680 (Jockeys and Drivers to Report).

The foregoing ruling was issued as Mr. Perez was late reporting to the Jockey's quarters. Mr. Perez apologized and accepted the penalty.

11-06-15⁵ **RULING #19-DAVID C. LOPEZ**

Apprentice jockey David C. Lopez is hereby granted an extension of his apprentice allowance for good cause due to injury for one hundred and thirty-eight days (138). The termination date of his apprenticeship shall now be at the end of the day on March 26, 2016.

The above ruling was issued after the Stewards received documentation outlining the extent of Mr. Lopez' injury and the duration of his absence.

11-06-15⁶ **FILM REVIEW**

Jockey Frank Alvarado and the Stewards reviewed the video of the fourth race from Sunday, November 1, 2015. The majority opined that Mr. Alvarado made a satisfactory effort in attempting to straighten his mount. Steward McHargue felt a suspension was warranted.

11-06-2015⁴ **INQUIRY-OBJECTION-DISQUALIFICATION-3RD RACE**

The Stewards posted the inquiry sign following the third race for a review of an incident in the stretch involving #5 Barrel Knot (William Antongeorgi) first and #1 Yahoo Tahoe (Russell Baze) second. Jockey Baze also lodged a claim of foul regarding the same incident.

The video shows #1 Yahoo Tahoe driving into a clear opening along the rail inside #5 Barrel Knot, near the 1/8 pole, when the latter drifts in and impedes the former, forcing that rider to take back and lose all chance.

The Stewards decided unanimously to disqualify #5 Barrel Knot from first to second.

Jockey **William Antongeorgi III** who rode **Barrel Knot**, in the third race at Golden Gate Fields on Friday, November 6, 2015 is hereby suspended three (3) racing days (November 14, 15 & 19, 2015) for failure to make a proper effort to maintain a straight course in the stretch and causing interference resulting in the disqualification of his mount from first to second. A violation of California Horse Racing board rule #1699 (d) & (f) (Riding Rules-Careless Riding).

The above ruling was issued after Mr. Antongeorgi and the Stewards reviewed the third race from November 6, 2015.

Mr. Antongeorgi was very forthright by acknowledging he was trying to ride tight, but crossed the line. The Stewards decided unanimously that a suspension was in order.

11-07-2015⁴ **COMPLAINT #15GG0124-DISMISSED**
The complaint filed by Barbara McDaniel (dba Golden State Stables, Inc.) against owner/trainer Morris Parker, alleging an outstanding boarding debt, (\$2,260.00) was dismissed as the complainant failed to appear for the scheduled hearing.

11-07-2015⁵ **STEWARDS REVIEW-3RD RACE**
The Stewards conducted a review of an incident in the stretch involving #2 Night Train Lane (Cristobal Herrera) second and #5 Sir Gawain (Alejandro Gomez) third. The video clearly shows #5 Sir Gawain attempting to go into an opening that did not exist along the rail. Jockey Gomez took up sharply after making that poor decision.
