Trainer **Gloria Buckridge** who started the horse Tizfit in the 1st race at Golden Gate Fields on November 28, 2015, is fined the sum of five Hundred dollars (\$500.00)* pursuant to California Horse Racing Board rule #1887 (Trainer to Insure Condition of Horse) for violation of CHRB rule #1843 (A, B & D) (Medication, Drugs and Other Substances and #1843.1 (Prohibited Drugs and Other Substances-Guafenesen 34 ng/ml).

The foregoing ruling was issued after Ms. Buckridge stated she has no knowledge of a Guiafenesen treatment, but as the trainer of record accepts responsibility.

02-25-2016⁴ **CERAPIO FIGUEROA RULING #35**

Apprentice Jockey **Cerapio Figueroa** who rode **Grumpy** in the sixth race at Golden Gate Fields on Sunday, February 21, 2016 is suspended three (3) racing days (March 3, 4, & 5, 2016) for failure to make the proper effort to maintain a straight course and causing interference in the stretch. A violation of California Horse Racing Board rule #1699 (d) & (f) (Riding Rules-Careless Riding)

The term of this suspension shall not prohibit participation in designated races in California.

The above ruling was issued after Mr. Figueroa and the Stewards reviewed the video of the sixth race from February 21, 2016. The young rider admitted he erred in allowing his mount to drift in and cause interference.

02-25-2016⁵ **WILLIAM E. MOREY RULING #36**

Trainer **William E. Morey** is fined the sum of One Hundred Dollars (\$100.00)* for failure to follow proper procedures when declaring the horse **Pat's Gray Ray** will race unshod in the ninth race on Sunday, February 21, 2016: a violation of California Horse Racing Board rule #1853 (Examination Required).

The above ruling was issued after Mr. Morey accepted responsibility for failing to follow the guidelines regarding the entry of unshod horses.

02-25-2016⁶ **LATE DECLARATION-2ND RACE**

#4 Our Princecharming (Trainer Jeff Bonde) was declared on the recommendation of the track veterinarian Sara Sporer, who reported the gelding failed to warm up and was off in the right foreleg resulting in a total refund of \$10,759.75.

Groom **Robin Vasquez-Ortiz** is hereby fined the sum of One Hundred Dollars (\$100.00)* for violation of California Horse Racing Board rule #1874 (Disorderly Conduct-Intoxication).

The foregoing ruling was issued after Mr. Vasquez-Ortiz appeared in response to the complaint filed against him by California Horse Racing Board Investigator Louis Quezada.

Mr. Vasquez-Ortiz admitted having to many beers after working on January 22, 2016. His employer, Trainer Rhoda March, appeared on his behalf and stated he is a reliable employee and has never been observed or shown signs of drinking while working.

02-26-2016⁴ **INQUIRY-DISQUALIFICATION-6TH RACE**

The Stewards posted the inquiry sign following the sixth race to review an incident near the 3/16 pole involving #4 Danzig Thorn Song (Richard Oliver) second, #2 Stormin Belle (Juan Hernandez) fourth and #5 Nellie Gail (Catalino Martinez) who finished sixth.

After interviewing the rides involved and reviewing all video angles, the Stewards decided unanimously to disqualify #4 Danzig Thorn Song from second to fourth for altering course and forcing #2 Stormin Belle to take up sharply and lose the opportunity of a better placing. #5 Nellie Gail was slightly inconvenienced, but not to the extent of costing her a better placing.

02-27-2016³ **SHAWN SPIKES RULING #38**

Jockey **Shawn Spikes** who rode **Game Seeker** in the fourth race at Golden Gate Fields on Friday, February 26, 2016 is fined the sum of One Hundred Dollars (\$100.00)* for violation of California Horse Racing Board rule #1688 (Use of Riding Crop-used more than three times without giving the horse a chance to respond).

The Stewards issued the foregoing ruling after Mr. Spikes readily admitted he violated the crop rule by striking his mount more than three consecutive times.

Apprentice Jockey **Richard Oliver** who rode **Danzig Thorn Song** in the sixth race at Golden Gate Fields on Friday, February 26, 2016 is suspended three (3) days (March 5, 6, & 10, 2016) for altering course without sufficient clearance and causing interference in the stretch resulting in a disqualification of his mount from 2nd to 4th. A violation of California Horse Racing Board rule #1699 (d) & (f) (Riding Rules-Careless Riding).

The term of this suspension shall not prohibit participation in designated races in California.

The preceding ruling was issued after Mr. Oliver and the Stewards reviewed the video of the sixth race from Friday, February 26, 2016.

Mr. Oliver was very candid in acknowledging he erred and accepted the penalty imposed.

02-27-2016⁵ **FERNANDO SARMIENTO AMEZCUA (CASE # 6GG0013)**

Mr. Amezcua appeared in the response to a complaint filed by California Horse Racing Board Investigator Louis Quezada. Chaplain Rob Cochran assisted Mr. Amezcua, who requested an informal hearing.

Mr. Amezcua was apprehended on the Golden Gate Fields barn on January 31, 2016, while under a thirty-day suspension (Golden Gate ruling #12 issued 01-18-2016) for being under the influence of Methamphetamine and Marijuana. Golden Gate Fields security transported Mr. Amezcua to the California Horse Racing Board investigator's office when apprehended and although not tested, displayed objective symptoms of stimulant influence and admitted to Methamphetamine use the previous night. Decision forthcoming.

02-27-2016⁶ **CLAIM VOIDED-8TH RACE**

The Stewards voided the claim in eighth race submitted by trainer Jack Steiner for the gelding Quackin (Trainer Manual Calvario) after State Veterinarian Forrest Franklin, DVM reported the six year old was lame in the left foreleg. Quackin was returned to the Calvario barn.

Groom **Fernando Amezcua** is hereby suspended thirty (30) days, February 29, 2016 through March 29, 2016 and placed on probation for one year from the date of this ruling, for violation of California Horse Racing Board rules #1874 (Disorderly Conduct-

Under Influence of Methamphetamine) and violation of probation imposed in Pacific Racing Association ruling #12 issued January 18, 2016.

Prior to the reinstatement of his license privileges **Fernando Amezcua** must show proof of completion of an in-house rehabilitation program acceptable to this Board of Stewards. The conditions of probation are that **Mr. Amezcua** must sign a testing agreement with the California Horse Racing Board and a contract with the Winners Foundation. Failure to comply with the terms of probation will be grounds for action against **Mr. Amezcua's** license privileges.

During the term of the suspension, all licenses and license privileges of **Fernando Amezcua** are suspended and pursuant to California Horse Racing Board rule #1528 (Jurisdiction of Stewards) subject is denied access to all premises in this jurisdiction.

The preceding ruling was issued subsequent to the hearing held on February 27, 2016.

02-28-2016⁴ **CLAIM VOIDED**

The Stewards voided the claim submitted by Trainer Gary Greiner for the mare Spending Plan (Trainer Steve Sherman) after State Veterinarian Forrest Franklin, DVM reported the six year old bowed a tendon in the right foreleg and was placed on the Veterinarian's List.

Spending Plan was returned to the Sherman barn.

02-28-2016⁵ **HORSE EUTHANIZED**

Salah Loves Tegan (Trainer George Papaprodromou) broke down near the 3/16 pole and was pulled up by Jockey Felipe Martinez. Track Veterinarian Sara Sporer, DVM reported the three year old gelding severely injured his right foreleg and was given a ride home in the horse ambulance.

It was later reported that Salah Loves Teagan was euthanized at the Papaprodromou barn by Veterinarian Steve Boyer, DVM.
