JOCKEY OBJECTION-SEVENTH RACE-NO CHANGE

The Stewards posted the objection sign when Jockey Kyle Frey (3rd, #2 Do U Know Who I Am) lodged a claim of foul against the winner, #4 Alamo Pintado with Juan Hernandez. Frey alleged interference shortly after the start of this one mile event. After a thorough review the Stewards dismissed the objection. Tapes showed that Frey steadied his mount briefly in traffic leaving the gate but the Stewards were not convinced that Alamo Pintado was responsible for the incident or that Do U Know Who I Am was cost the opportunity at a better placing.

05-27-2016² **STEWARDS INQUIRY-FOURTH RACE-NON-STARTER**

The Stewards lit the inquiry lamp to review the start of #5 Nicole Michelle, trained by Tim McCanna and ridden by Russell Baze, after the horse got away poorly from the gate. While the race was in progress Starter Todd Stephens contacted the Stewards via walkie-talkie and reported the filly "sucked back" at the start which delayed her departure. After a thorough review the Stewards declared Nicole Michelle a non-starter.

Tapes showed, and Jockey Baze confirmed, that Nicole Michelle did dwell in the gate after the doors opened but it was also apparent that the Assistant Starter did not turn her head loose. The Assistant Starter felt the filly may have flipped over backwards and maintained a grip on the bridle to prevent same.

The Stewards concluded the actions of the Assistant Starter may have impeded Nicole Michelle from obtaining a fair start and she was declared a non-starter. Steward Herbuveaux dissented.

05-28-2016² **JOCKEY OBJECTION-SIXTH RACE-NO CHANGE**

The Stewards posted the objection sign at the request of Frank Alvarado who rode the fifth placed horse #3 One Tuff Minister. Alvarado alleged interference at the ¼ where he felt #2 Semper Gumby (1st Hugo Herrera) came in and took his path while Alvarado was racing along the rail. After a thorough review the Stewards disallowed the claim of foul.

Tapes showed that Alvarado checked his mount at the ¼ while being passed by Herrera aboard Semper Gumby. What the tapes don't show is why Alvarado checked. No camera angle offered a definitive view on whether Alvarado's mount tried to get out around the turn or whether Herrera's mount stepped in and took Alvarado's path.

05-29-2016⁴ **VET'S LIST ENTRANT**

It came to the Stewards' attention late yesterday that the horse Buymeabond, trained by Jonathan Wong and entered in today's seventh race, might not be eligible for the race. The issue involved the fact that the horse was scratched from a race at Santa Anita on May 20, 2016 and may still be on the Vet's List.

Conversations were held with Equine Medical Director Rick Arthur, DVM, Trainer Wong and Santa Anita Official Veterinarian Tim Grande, DVM. These talks resulted in Buymeabond's declaration from today's seventh race.

Buymeabond's scratch on May 20, 2016, resulted in the horse being placed on Santa Anita's 10-day Vet's List. Wong's Santa Anita operation was notified in writing of the placement but the horse wasn't timely entered in the state's INCOMPASS computer system. This allowed Buymeabond to be entered back in today's race at Golden Gate Fields where the Vet's List detention period is only five days.

After the facts were sorted it was determined the horse was ineligible to be entered in today's race and a late declaration was activated. While Wong and his connections were disappointed with the outcome all understood how and why the discrepancy arose. The refund amount to \$1,644.81.
