**MINUTES – EIGHTH WEEK OF HOLLYWOOD PARK SPRING/SUMMER MEETING**  
**For the period: Wednesday, June 10, 2009 through Sunday, June 14, 2009**

**WEDNESDAY**  
06/10/09<sup>1</sup>

**KRULJAC RULING**

Trainer ERIC KRULJAC accepted the following penalty when he informed the Stewards that he had neglected to put his horse running last Sunday on the bleeder's list in California. To protect the welfare of the horse, we allowed the horse to run on lasix but issued the following ruling for the violation:

**HRT# #039**

Trainer **J. ERIC KRULJAC** is fined **THREE HUNDRED DOLLARS (\$300.00)\*** for violation of California Horse Racing Board rule #1845 (Authorized Bleeder Medication) on June 07, 2009 at Hollywood Park.

**BECERRA RULING**

Trainer RAFAEL BECERRA contacted the Stewards by telephone to discuss case number 09HP069 which alleged that one of the horses under his care was late to the receiving barn. Mr. Becerra admitted the error and accepted the following penalty:

**HRT# #040**

Trainer **RAFAEL BECERRA** is fined **ONE HUNDRED DOLLARS (\$100.00)\*** for violation of California Horse Racing Board rules #1852 (Reporting to Receiving Barn-Late) and #1894 (Duties of Trainer) with his horse "Major Smoke" in the fifth race on May 24, 2009.

**MILLER RULING**

After careful consideration, trainer PETER MILLER was issued the following ruling regarding the late declaration described in the minutes last week (see 5/31/09<sup>2</sup>). This case (09HP058) involved a veterinarian treating an in-today horse with bute instead of lasix. While Mr. Miller blamed the veterinarian for the mistake, the following ruling was nevertheless issued:

**HRTH #041**

Trainer **PETER MILLER** is fined **THREE HUNDRED DOLLARS (\$300.00)\*** for violation of California Horse Racing Board rule # 1844 (b) (Authorized Medication) pursuant to California Horse Racing Board rule # 1629 (Penalty for Late Declaration) necessitating the late declaration of his horse "Justalittletipsy" from the fourth race on May 15, 2009.

**MILLER RULING**

After careful consideration, trainer PETER MILLER was issued a ruling regarding his failure to report a gelding (case number 09HP078). Pursuant to rule 1865 (Altering Sex of Horse) which sets the penalty at \$1,000.00 absent mitigating circumstances, this BOS believed the following penalty was appropriate, given that the gelding was a first time starter gelded at the farm:

**HRTH #042**

Trainer **PETER MILLER** is fined **SEVEN HUNDRED AND FIFTY DOLLARS (\$750.00)\*** for failure to properly report the gelding of the horse "Trade Master", which ran in the eighth race at Hollywood Park Race Track on May 29, 2009. This constitutes a violation of California Horse Racing Board rule #1865 (Altering of Sex of Horse).

**CERIN RULING**

Trainer VLADIMIR CERIN contacted the Stewards by telephone to discuss case number 09HP067 which alleged that one of the horses under his care was late to the receiving barn. Mr. Cerin admitted the error and accepted the following penalty:

**HRTH #043**

Trainer **VLADIMIR CERIN** is fined **ONE HUNDRED DOLLARS (\$100.00)\*** for violation of California Horse Racing Board rules #1852 (Reporting to Receiving Barn-Late) and #1894 (Duties of Trainer) with his horse "Afleet's Picasso" in the third race on May 24, 2009.

**WALKER REINSTATEMENT**

Owner/trainer PAUL WALKER was reinstated when we received evidence that he had satisfied his financial obligations to MOC Insurance Company:

**HRTH#044**

Owner/Trainer **PAUL WALKER**, having satisfied his financial obligations under the provisions of California Horse Racing Board rule #1876 (Financial Responsibility), is restored to good standing. DMTD Ruling #005, issued at Del Mar on July 22, 2006, is set aside.

**VICTORVILLE DISMISSAL**

This Board of Stewards voted to dismiss case number 09SA107 which involved a complaint filed by the CHRB against OTB Victorville. The CHRB complaint alleged that OTB Victorville violated CHRB Rule 2057 (Initial Application and Approval of a Simulcast Facility) which, in part, provides that “no guest association. . . may discontinue its operation nor conduct any activity which would cause interruption of the signal without giving the Board and the host association prior written notice within fifteen (15) calendar days. . .” Evidence revealed that there was no fifteen day notice, but also revealed that the OTB was an hour late in opening while a dispute was being resolved with their host association Santa Anita. We believed that this did not constitute violation of the CHRB for four reasons: (1) opening and closing times are determined by the OTB itself; (2) the OTB opened in time to take wagers from Santa Anita’s entire card; (3) the dispute had arisen from the fact that the OTB had not been paid by their host association for three consecutive weeks; and (4) host associations who have called off entire cards have not been penalized under this rule. The complaint was therefore unanimously dismissed.

**DELIMA COMPLAINT**

Trainer JOSE DELIMA contacted the Stewards by telephone to discuss case number 09HP053 which involved a complaint filed by the CHRB alleging that Mr. Delima’s horse arrived late to Hollywood Park on race day. Fortunately, the horse did arrive in time for timely pre-race veterinary inspection and lasix and was therefore permitted to run. It appears that the van company was partly to blame for the incident so a warning was issued to Mr. Delima.

**ROSARIO COMPLAINT AND RULING**

Jockey JOEL ROSARIO met with the Stewards informally to discuss a complaint (case number 09HP056) filed by the CHRB that alleged violation of the whip rules, in that one of Mr. Rosario’s mounts returned from a race with a break in the skin, presumably caused by his whip. Mr. Rosario did not have an explanation for the cut, other than his overzealousness to win the race. He was warned that repeated violations of this type resulted in particularly onerous penalties and was issued the following ruling:

**HRTH #045**

Jockey **JOEL ROSARIO**, is fined **THREE HUNDRED DOLLARS (\$300.00)\*** for violation of California Horse Racing Board rule #1688 (3) (Use of Whip-causing welts or breaks in the skin) in the ninth race on May 16, 2009 at Hollywood Park.

**MCEWIN DISMISSAL**

Case number 09HP076 which was a financial complaint filed by trainer Mike Marlow against owner DILLON MCEWIN for unpaid training expenses was dismissed when Mr. Marlow informed us that the debt was paid in full.

**FILM REVIEW**

Jockey MARTIN GARCIA came to the office in order to review his ride in the seventh race. Specifically, Mr. Garcia allowed his horse to run up on the heels of a tiring horse, when his horse took evasive action to avoid clipping heels but in doing so, came out into the path of a rival. While we did not believe that days were in order because part of the incident was circumstantial and part could be blamed on the horse, Mr. Garcia was warned that he must anticipate that horses will tire in the latter stages of races and that he should adjust accordingly.

**HOLMES RULING**

After careful consideration of case 09HP063 involving exercise rider Joe Holmes Sr. (see 06/03/09<sup>2</sup>) the following ruling was issued:

**HRTH#046**

Exercise rider **JOE HOLMES, Sr.** is suspended for **FIFTEEN (15) DAYS** (June 12, 2009, thru June 26, 2009) and fined **TWO HUNDRED DOLLARS\* (\$200.00)** for violation of California Horse Racing Board rule #1874 (Disorderly Conduct). The suspension will be stayed provided that Mr. Holmes, Sr. remain on probation for the term of his license (October 31, 2010), sign a testing agreement with the California Horse Racing Board, and participate in the Winners Foundation program.

**SHIRREFFS COMPLAINT AND RULING**

Trainer JOHN SHIRREFFS appeared before the stewards to discuss case number 09HP068 which alleged that one of the horses under his care was late to the receiving barn. Mr. Shirreffs admitted the error and grudgingly accepted the following penalty:

**HRTH #047**

Trainer **JOHN SHIRREFFS** is fined **ONE HUNDRED DOLLARS (\$100.00)\*** for violation of California Horse Racing Board rules #1852 (Reporting to Receiving Barn-Late) and #1894 (Duties of Trainer) with his horse "Sabina Fay" in the third race on May 24, 2009.

**MOGER RULING**

Trainer ED MOGER's assistant trainer appeared before the Stewards to discuss case number 09HP081 which alleged that one of the horses under his care was late to the receiving barn. The barn admitted the error and accepted the following penalty:

**HRTH #048**

Trainer **ED MOGER, Jr** is fined **ONE HUNDRED DOLLARS (\$100.00)\*** for violation of California Horse Racing Board rules #1852 (Reporting to Receiving Barn-Late) and #1894 (Duties of Trainer) with his horse "Hard Woman" in the first race on May 30, 2009.

**SMITH HEARING AND DISMISSAL**

Trainer DONALD SMITH contacted the Stewards' office by telephone to discuss case number 09HP083 which embodied a complaint filed by the CHRB alleging that one of Mr.

Smith's trainees reported late to the Hollywood Park grounds on race day. The Stewards' office was somewhat involved on the day of the race when Mr. Smith's jockey took off for health reasons and Mr. Smith was saddled with the burden of finding a rider for a long shot in the last race on Friday night. Given this uncertainty, he was a bit delayed in shipping his horse because he preferred not to go to the expense in the event that substitute rider could not be secured. Under these circumstances, we felt that a warning was appropriate.

**YOUNG COMPLAINT**

Exerciser rider Saqueo Catalan filed a financial complaint against trainer STACY YOUNG (case number 09HP079) for unpaid wages in the amount of \$90.00. Ms. Young contacted the Stewards by telephone and agreed to pay then full amount. The complaint was therefore dismissed.

**OBJECTION/NO CHANGE**

Following the running of the fourth race, jockey Tyler Baze, aboard second place finisher #4 Star Redeemer, claimed foul against the winner #1 Teamwork, ridden by Joel Rosario, for interference around the far turn and during the early stretch run. Mr. Baze asserted that Mr. Rosario, in attempting to secure running room for his mount, came out and bumped Mr. Baze's mount at several points around the turn and into the stretch. After reviewing the films, and speaking with the patrol judges and both riders, the Stewards unanimously concluded that although the contact did occur, it did not constitute interference and therefore no change was required.

**INQUIRY/DISQUALIFICATION**

Following the running of the sixth race, the inquiry sign was illuminated in order to examine an incident in the stretch involving the third, fourth and fifth place finishers. Films showed that third place finisher #3 Digestivo, ridden by Rafael Bejarano, drifts out in mid-stretch, into the paths of fifth place finisher #8 Miss Bodine and fourth place finisher #9 Sparks Flying. While #3 Digestivo appears to be clear of #8, the rider of #9 Sparks Flying, Joe Talamo, is forced to check sharply. #9 Sparks Flying was beaten a length and a quarter for third. After speaking with the patrol judges and riders involved, the stewards unanimously determined that #3 Digestivo should be disqualified from third and placed fourth.

**BEJARANO HEARING AND RULING**

Jockey RAFAEL BEJARANO met with the stewards to review the sixth race from yesterday in which his horse was disqualified. Films revealed that Mr. Bejarano’s horse was drifting out during the stretch run, while Mr. Bejarano used his whip one time on the right side. Films also revealed that his horse drifted out about two paths and finally angled back in after Mr. Bejarano made the correction. It was the unanimous position of the stewards that Mr. Bejarano be suspended in the following ruling:

**HRT#049**

Jockey **RAFAEL BEJARANO**, who rode #3 Digestivo in the sixth race at Hollywood Park on June 13, 2009, is suspended for **THREE RACING DAYS (3) (June 21, 25 and 26, 2009)** for failure to make the proper effort to maintain a straight course in the stretch and causing interference which resulted in the disqualification of his mount from third to fourth position. This is a violation of California Horse Racing Board rule #1699 (Riding Rules-careless riding). Term of suspension shall not prohibit participation in designated races.
