LEE HEARING CASE #09HP172

Trainer Suzie M. Lee was contacted telephonically for an informal hearing regarding the late arrival of her horse to the receiving barn for the eighth race on November 26, 2009 at Hollywood Park. Ms. Lee told the Stewards that her groom did not hear the call over the loud speaker and that he is somewhat new and green handling horses for racing. Trainer Suzie M. Lee was given an official warning due to her overall good record as a trainer

FILM REVIEW

Jockey Christian Santiago-Reyes was in to review two films regarding his riding from Saturday and Sunday. In Saturday's second race Mr. Reyes was counseled to be more careful going up on the inside approaching the far turn. The Stewards told him to be either in or out in that spot.

The second incident concerned keeping his mount straight when he is on a tired horse that is backing up in the stretch. Mr. Reyes was cooperative and said he would be compliant in future races.

Jockey Omar Berrio reviewed the first race from Saturday when his mount broke inward coming out of the starting gate and came over two paths in front of the horse to his inside who broke slowly. Mr. Berrio was counseled to make a better effort to grab and straighten his mount and to be more aware of horses to his inside regardless if they broke slowly or not. Mr. Berrio was given a stern warning and told that the next time he wouldn't be so lucky.

REYES RULINGS

HRTH #020

Apprentice jockey Christian Santiago Reyes, his appeal of ruling #8, issued at Del Mar Thoroughbred Club on July 26, 2009, having been heard and a decision from that appeal having been adopted by the California Horse Racing Board, it is ordered that the original suspension be re-imposed with the dates of suspension to be as follows: December 6, 9, 10, 11, and 12, 2009. All other terms of the original ruling shall remain in effect.

This ruling reflects the decision of Mr. Reyes' appeal of his suspension days at Del Mar being re-imposed on the above dates.

HRTH #021

Apprentice jockey Christian Santiago Reyes, having withdrawn his appeal of ruling #28, issued at the Los Angeles County Fair on September 28, 2009, is suspended for three (3) racing days (December 13, 17, and 18, 2009). All other terms of the original ruling shall remain in effect.

This ruling reflects the decision of Jockey Reyes to withdraw his appeal of ruling #28 at the Los Angeles County Fair, which was for three (3) suspension days. These days will be re-imposed on the above dates.

Jockey **CHRISTIAN SANTIAGO REYES** is fined **ONE HUNDRED DOLLARS (\$100.00)*** pursuant to California Horse Racing Board rule #1930 (Obedience to Security Officers and Public Safety Officers-Failed to Appear Before the Board of Stewards).

The above ruling was issued to Jockey Christian Santiago-Reyes for failing to appear before the Board of Stewards concerning a film review.

GARCIA RULING

HRTH #023

Jockey **MARTIN GARCIA** is suspended for three (3) racing dates (December 9, 10, and 11, 2009) for crossing over on the backstretch without sufficient clearance, causing interference while riding Professnl Courtesy in the second race at Hollywood Park on November 29, 2009. This constitutes a violation of California Horse Racing Board rule #1699 (Riding Rules-careless riding).

Terms of suspension shall not prohibit participation in designated races.

The above ruling was issued to Jockey Martin Garcia due to his poor effort in maintaining a straight line shortly after the start and down the backside, coming over four or five paths and putting a horse to his inside on heels, which caused him to make contact with the horse to his inside.

GOMEZ RULING

HRTH #024

Jockey **GARRETT GOMEZ**, who rode Stoneside (IRE) in the seventh race at Hollywood Park on November 29, 2009, is suspended for three (3) racing days (December 9, 10, 11, 2009) for failing to maintain a straight course in the stretch and causing interference which resulted in the disqualification of his mount from second to third.

This constitutes a violation of California Horse Racing Board rule #1699 (Riding Rules-Careless Riding). Term of suspension shall not prohibit participation in designated races pursuant to California Horse Racing Board rule #1766 (Designated Races).

The above ruling was issued to Jockey Garrett Gomez after Jockey David Flores represented him concerning his disqualification on Sunday, November 29, 2009, in the seventh race. David Flores offered little in Mr. Gomez's defense.

ACCIDENT-EIGHTH RACE

In the eighth race (Six Furlongs-Cushion Track) as #9 Deuce Amore (DNF-J. Talamo) was leading from just off the inner rail, when she suddenly went wrong and broke down falling hard to the track surface, throwing Jockey Joe Talamo to the ground, who then scurried for safety under the inside railing (see attached accident report).

As the trailing horses tried to avoid the fallen horse, #1 Continental Dancer (DNF-J. Herrera) wasn't so lucky and stumbled over #9 and unseated Jockey Jorge Herrera who also fell to the track and was attended to by the track EMTs (see attached accident reports). #9 Deuce Amore was euthanized on track, while #1 Continental Dancer ran loose but was caught and returned to her barn.

HRTH #026

Trainer **SHAWN TALBOT**, having failed to appear to address charges alleging violation of California Horse Racing Board rules #1876 (Financial Responsibility) and #1877 (Checks), is suspended for violation of California Horse Racing Board rule #1547 (Failure to Appear).

During the term of suspension, all licenses and license privileges of Shawn Talbot are suspended and pursuant to California Horse Racing Board rule #1528 (Jurisdiction of Stewards to Suspend or Fine), Mr. Talbot is denied access to all premises in this jurisdiction.

Trainer Shawn Talbot failed to appear on Sunday November 29th, 2009, to answer complaint 09HP163 regarding his indebtedness to Del Mar Thoroughbred Club in the amount of \$1,960.00 for writing four (4) checks against insufficient funds. Therefore the above ruling was issued.

ROSARIO HEARING CASE #09PM001

The hearing continued this morning regarding case 09PM001 filed against Jockey Joel Rosario (Ref. 11/19/09¹) for not putting forth his best effort into riding the horse "Cedros" at Del Mar race course in the eleventh race on September 6, 2009. The location was shifted to a small Hollywood Park board room due to freeing up the Stewards' office for regular routine morning matters.

Present were Deputy Attorney General Kenneth Jones, representing the California Horse Racing Board, Roger Licht attorney for Respondent Joel Rosario, Jockey Joel Rosario, Interpreter Daniel Trigueros, Tina Stauffer as an observer, Steve Andersen representing the Daily Racing Form, Court Reporter Barbara Weinstein and the Board of Stewards, Albert Christiansen, Kim Sawyer and Randy Winick.

Today's proceedings continued to have witnesses called by the Deputy Attorney General to testify, which included Jockey/Exercise rider Jordan Springer who galloped and worked "Cedros" on a regular basis, Trainer John Glenney who gave his testimony telephonically from Kentucky, Steward Scott Chaney who was a Steward at Del Mar and observed the race live as it happened from the Stewards' Stand, Senior Special Investigator Rick Amieva who wrote the reports and finally Jockey Joel Rosario, the Respondent.

At the end of the testimony and cross examinations the Deputy Attorney General asked for all exhibits be moved into evidence. Attorney Roger Licht at this time argued various reasons why the proceedings should be dismissed and Deputy Attorney General Kenneth Jones then rebutted reasons for not dismissing this case. The Stewards asked all parties to leave the room to confer on a decision and then shortly called them back to deny the motion and to continue the proceedings on Friday December 11, 2009, for a possible final day of testimony and arguments. The hearing was now off the record and closed for the day.
