CHITRAKAR HEARING CASE #10HP002

This informal hearing involved an alleged violation of CHRB rule 1845 (Authorized Bleeder Medication). Official Veterinarian Jill Bailey filed the complaint which declared that Dr. Chitrakar turned in a Bleeder Treatment Report and treated a horse that had not been registered to race on bleeder medication. Dr. Chitrakar stated the morning of the incident she was told by the trainer to administer lasix to his horse and she did so without performing proper verification. The medication change was announced before windows opened for wagering and the horse did race. The following ruling was issued:

HRTH #024

Veterinarian **APRIL CHITRAKAR** is fined **THREE HUNDRED DOLLARS (\$300.00)*** for violation of California Horse Racing Board rule #1845 (Authorized Bleeder Medication) on April 8, 2010.

MANDELLA HEARING CASE #10HP009

A formal hearing was held which involved an alleged violation of CHRB rule 1843 (a) (d) (Medication, Drugs and Other Substances) and #1887 (a) (Trainer to Insure Condition of Horse). The medication was Methocarbamol (class 4). The hearing was recorded by court reporter Barbara Weinstein. Investigator Phillip Miyazaki represented the CHRB and observing the proceedings were Chief Investigator Bill Westermann and Safety Steward Luis Jauregui. Mr. Mandella was sworn in and testified he felt there had been contamination from another

feed tub in his shedrow. The horse "Apriority" was treated with Methocarbamol 60 hours prior to the race by Mr. Mandella's practicing veterinarian. Exhibits were entered into evidence and the record was closed. The following ruling was issued in accordance with a class C penalty:

Trainer **GARY MANDELLA**, who started the horse "Apriority" in the fourth race at Santa Anita Park on April 4, 2010, is fined **FIVE HUNDRED DOLLARS (\$500.00)*** pursuant to California Horse Racing Board rule #1887 (Trainer to Insure Condition of Horse), for violation of California Horse Racing Board rule #1843(a) and (d) (Medication, Drugs and Other Substances-Methocarbamol).

O'NEILL HEARING CONTINUANCE CASE#SAC10-0019(ref.5/23/10⁴)

Recorded by Barbara Weinstein and in attendance before the Board of Stewards, attorney Steve Schwartz was available for trainer Doug O'Neill who was not present and currently out of the country. Representing the CHRB, Chief Investigator Bill Westermann, also present as observers, investigator Phillip Miyazaki and Safety Steward Luis Jauregui.

The record was opened and Mr. Westermann reported that the CHRB was seeking full reciprocity in accordance with CHRB rule 1484 (Evidence of Unfitness For License) of the Illinois ruling # 104052 suspending Mr. O'Neill from May 3, 2010 through May 17, 2010. Mr. Schwartz presented his case, all exhibits were entered into evidence and the record was closed. Decision to follow.

Trainer **TED H. WEST**, is fined **THREE HUNDRED DOLLARS (\$300.00)*** for violation of California Horse Racing Board rule #1845 (Authorized Bleeder Medication-late registration) in the eighth race at Hollywood Park on May 28, 2010.

This ruling was issued after Mr. West was made aware of and accepted the penalty.

INQUIRY NINTH RACE (6 furlongs-turf)/DISQUALIFICATION

Following the running of the race the inquiry sign was posted to review an incident leaving the 1/8 pole. Involved were #1 Repo (J. Rosario 1st) and # 3 Southern Fireball (Martin Garcia 2nd). After a review of the video replays, conversation with the Patrol Judge and both jockeys involved, the Stewards were in agreement to disqualify #1 from first and place her second behind #3. The #1

horse, after entering the stretch, steadily veers inward, causing #3 to check and alter course costing him the opportunity of a better placing.

HRTH #044

Jockey **JOEL ROSARIO**, who rode "Repo" in the eighth race at Hollywood Park on May 30, 2010, is suspended for three (3) racing days (June 6, 9, and 10, 2010) for failure to make the proper effort to maintain a straight course in the stretch, causing interference which resulted in the disqualification of his mount. This constitutes a violation of California Horse Racing Board rule #1699 (Riding Rules-careless riding).

Term of suspension shall not prohibit participation in designated races pursuant to California Horse Racing Board rule #1766 (Designated Races).

This ruling was issued after a film review of the race with Joel Rosario. It was in the Stewards' opinion that Mr. Rosario chose to ride close and his decision to do so created the infraction. He accepted his penalty without argument.
