OWNER HEARING

Kevin Kirk was in the office this morning in response to a complaint filed against him by Board investigators alleging violation of California Horse Racing Board rule #1902(b). The CII report the investigators received noted that on two occasions Kirk had been convicted of possession of cocaine. The second conviction, in 2009, resulted in felony probation. According to a Board memorandum dated 2009, applicants are not eligible to hold a license for five years following completion of probation. Kirk said that he thought the case had been dismissed after he completed the diversion program and thought that since the probation was over he would not encounter any problems. He said he is in the process of getting the felony probation reduced to a misdemeanor.

He was informed that until such time as he is successful in the court system, he is precluded from licensure by the Board.

Owner **KEVIN KIRK** is suspended pursuant to California Horse Racing Board rule #1489 (Grounds for Denial or Refusal of License-ineligible due to felony conviction under CHRB Directive 01-09).

During the term of suspension, all licenses and license privileges of Kevin Kirk are suspended and pursuant to California Horse Racing Board rule #1528 (Jurisdiction of Stewards to Suspend or Fine), Mr. Kirk is denied access to all premises in this jurisdiction.

EXERCISE RIDER IN

Johnny Allen was in the office this morning to respond to a complaint filed against him for holding a license while on felony probation. He was convicted of felony assault in 2009 and is currently on 36 month felony probation. He was told that until he gets the probation reduced to a misdemeanor he is not eligible to hold a license.

HRTH #019

Exercise rider **JOHNNY ALLEN** is suspended pursuant to California Horse Racing Board rule #1489 (Grounds for Denial or Refusal of License-ineligible due to felony conviction under CHRB Directive 01-09).

During the term of suspension, all licenses and license privileges of Johnny Allen are suspended and pursuant to California Horse Racing Board rule #1528 (Jurisdiction of

Stewards to Suspend or Fine), Mr. Allen is denied access to all premises in this jurisdiction.

RULING HRTH #015

Jockey **DOMINIC TERRY** is suspended pending payment of a fine levied in ruling LATS #106 on April 10, 2011 pursuant to California Horse Racing Board rule #1532 (Payment of Fines).

This ruling was issued after it was determined that Mr. Terry has yet to pay a fine issued at the recently concluded Santa Anita meeting. Mr. Terry's current whereabouts are unknown.

RULING HRTH #016

Trainer **CASH ROBERTSON**, having failed to appear to respond to a complaint alleging violation of California Horse Racing Board rule #1876(Financial Responsibility-Tom Doolan \$4,595.00) is suspended for violation of California Horse Racing Board rule #1547 (Failure to Appear).

During the term of suspension, all licenses and license privileges of Cash Robertson are suspended and pursuant to California Horse Racing Board rule #1528 (Jurisdiction of Stewards to Suspend or Fine), Mr. Robertson is denied access to all premises in this jurisdiction.

This ruling was issued after Mr. Robertson failed to appear to address a financial complaint filed against him by horseshoer Tom Doolan.

RULING HRTH #017

Trainer **DON CHATLOS**, having failed to appear to respond to a complaint alleging violation of California Horse Racing Board rule #1876(Financial Responsibility-Tom Doolan \$3,125.00) is suspended for violation of California Horse Racing Board rule #1547 (Failure to Appear).

During the term of suspension, all licenses and license privileges of Don Chatlos are suspended and pursuant to California Horse Racing Board rule #1528 (Jurisdiction of Stewards to Suspend or Fine), Mr. Chatlos is denied access to all premises in this jurisdiction.

The preceding ruling was issued after efforts to contact Mr. Chatlos proved unsuccessful.

The foregoing ruling was issued after Dr. Griffin took full responsibility for treating a horse with Lasix when it was not on the approved list. She said that she misread the overnight put out by the Official Veterinarian's staff denoting horses on the medication.

finished a game second. Management had to add \$7,882.86 to balance the ledger sheet.
