Mr. Valenzuela, in mid turn of the six furlong event, tried to finesse his mount to the outside, but in doing so he bumped a horse to his outside. This incident did not warrant a penalty but Mr. Valenzuela acknowledged that this type of riding is not acceptable.

STEIN RULING (ref. 06/18/11²)

HRTH #058

Trainer **ROGER STEIN** is fined **FOUR HUNDRED DOLLARS (\$400.00)*** pursuant to California Horse Racing Board rule #1887 (Trainer to Insure Condition of Horse) for violation of California Horse Racing Board rule #1845(e)(Authorized Bleeder Medication-more than one administration), resulting in the late declaration of his horse "Uncommon Sense" from the first race on April 24, 2011. The above ruling was issued after Mr. Stein was notified of the penalty.

These three cases were heard simultaneously as the three respondents involved were at the same location when the alleged violations occurred.

Description of complaints;

The CHRB filed a complaint against groom Carlos Silva, exercise rider Ruben Miranda and foreman Bernice Campbell for alleged violations of CHRB rules 1902 (Conduct Detrimental to Horse Racing) and 1489 (h) (Grounds for Denial or Refusal of License). Representing the CHRB was Investigator Rick Amieva and Court Reporter Barbara Weinstein recorded the proceedings. Also in attendance before the BOS were respondents Carlos Silva, Ruben Miranda and Bernice Campbell, Safety Steward Luis Jauregui and Winner's Foundation representative Leroy Martinez. The record was opened and testimony was given by all involved; documents were entered into evidence and the hearing was closed. Both Mr. Miranda and Mr. Silva were found with drug paraphernalia in Mr. Miranda's sleeping quarters by race track security. After taking into consideration recommendations submitted by the CHRB and Leroy Martinez the following two rulings were issued:

HRTH #059

Groom **CIRILO SILVA** is ordered to enroll in the Winner's Foundation program and sign a testing agreement with the California Horse Racing Board for violation of California Horse Racing Board rule #1489(h)(Engaged in the Use of Drugs) and #1902(Conduct Detrimental to Horse Racing). Additionally, subject is placed on probation while under licensure by the California Horse Racing Board.

HRTH #060

Exercise rider **RUBEN MIRANDA** is ordered to enroll in the Winner's Foundation program and sign a testing agreement with the California Horse Racing Board for violation of California Horse Racing Board rule #1489(h)(Engaged in the Use of Drugs) and #1902(Conduct Detrimental to Horse Racing). Additionally, subject is placed on probation while under licensure by the California Horse Racing Board.

After Ms. Campbell testified and considering the CHRB's recommendation of penalty, that case was dismissed after she signed a testing agreement. Mr. Silva resides in Ms. Campbell's room, which is located next to Mr. Miranda's room. Her room was searched and there was no discovery of drugs or wrong doing on her part.

Folding into the first turn it appeared on DVD that Mr. John crossed over in front of a horse to his inside without sufficient clearance. Mr. John stated he thought he was clear and will be more cognizant in the future to promote safer riding. The angle provided by the DVD made it hard to prove Mr. John culpable.

Jockey Martin Garcia joined the Stewards to discuss his ride in the sixth race (7/8- cushion) on Sunday. In the stretch drive,

Mr. Garcia's mount drifted outward down the lane and, in the Stewards' opinion he should have made an effort to correct by pulling on the left rein. His drift did not create a punishable infraction but he was cautioned to be more aware of a drift and to make an effort to correct it. He promised he would.

SATURDAY06/25/11¹**FORMAL PROTEST HEARING FILE #11HP063**

This hearing pertains to CHRB rules 1755 (Grounds for Protest), 1420 (r) (Definitions), 1592 (Ineligible Horse to Be Disqualified), 1750 (Stewards to Make Inquiry), 1588 (g) (Horse Ineligible to Start in a Race), 1756 (Persons Empowered to File Objection or Protest), 1759 (Horse to Be Disqualified on Valid Protest) and 1760 (Purse Award or Prize to Be Withheld). Court reporter Barbara Weinstein recorded the proceedings and Investigator Jim Hamilton presented the case. In attendance before the BOS as observers were Safety Steward Luis Jauregui and Vic Stauffer. Trainers Paul Aguirre (trainer of the winner "Doc Can Dance") with his attorney Roger Licht, two of the owners of the horse "Doc Can Dance", Mark and Jim Xitco and Richard Rosales (trainer of second place finisher "Preferred Behavior") were also present. A Stewards inquiry initiated the investigation into the eligibility of said horse upon notification after the running of the seventh race on June 10, 2011, that the horse "Doc Can Dance" might not have been eligible for the condition of the race. A protest was also filed by Richard Rosales. All owners, trainers and jockeys who participated in the race in question were notified of the hearing. All witnesses were sworn in and testimony and opinions were given. All documents were entered into evidence and the record was closed. Decision to follow.
