WEEK 1-Thursday, November 8, 2012-Saturday, November 10, 2012**THURSDAY**11/08/12¹**NEW ALARM INSTALLED**

After an incident at Santa Anita that involved calling off the race during the running (ref. 10-12-12⁵), Hollywood Park took the initiative to install a warning siren that can be turned on from the Stewards' stand. This switch can be turned on during the running of the race to help the jockeys be aware they need to pull up as soon as possible and not finish the race. There will be a meeting with the jockeys to inform them of the new policy.

After confirmation that Mr. Rosario was aware of the penalty issued, the following ruling was published:

HRT# #001

Jockey **JOEL ROSARIO** is fined **TWO HUNDRED DOLLARS (\$200.00)*** for failure to fulfill his riding engagement in the tenth race at Santa Anita Park on November 4, 2012. This constitutes a violation of California Horse Racing Board rule #1872 (Failure to Fulfill Jockey Agreement).

FRIDAY11/09/12¹**BREUER HEARING CASE #12SA180****BRYTON RACING LLC HEARING CASE #12SA181**

The two complaints filed by Vincent Baker DVM against owner Michael Breuer for \$3,564.93, and Bryton Racing LLC, owners Tom Staunton and Kevin Bryar for \$3,308.98 were dismissed. Both complaints are pursuant to CHRB rule 1876 (Financial Responsibility).

Mr. Breuer was available for the hearing but after the complainant failed to appear or contact the Stewards, the complaint was dismissed.

EICKERMAN FORMAL HEARING CASE #12SA143

The following complaint was filed by the CHRB for alleged violations of CHRB rule 1843 (a) (d), (Medication, Drugs and Other Substances), 1866(d) (Veterinarians List) and 1887(a) (Trainer to Insure Condition of Horse). Present at this hearing was court reporter Michelle Derig who documented the proceedings. Representing the CHRB was Investigator Phil Miyazaki, also in attendance were Safety Steward Luis Jauregui and Chief Investigator Bill Westerman. Trainer Gary Eickerman was available by telephone at his request. On September 13, 2012, Mr. Eickerman worked his trainee "Concert Goer" to be removed from the Veterinarian List. The test results from U.C. Davis reported a level of Phenylbutazone at a level of 7.15 ug/ml. After Mr. Eickerman was sworn in he testified that he administered the medication and forgot that the new level is now 2.0 ug/ml. Mr. Eickerman stated he felt he deserved a warning. He was informed that the Stewards would discuss the facts and the decision will follow.

SATURDAY11/10/12¹**BAZE RULING**

The following ruling was issued after a meeting with Tyler Baze and a review of the second race on 11-08-12. Mr. Baze stated his aggressive ride was due to the trainer's instructions. The Stewards informed him that repeatedly hitting a horse that is not pursuing a better placing is unacceptable and worthy of a penalty. Mr. Baze stated he understood and promised to be more cautious in the future.

HRT# #002

Jockey **TYLER BAZE** is fined **THREE HUNDRED DOLLARS (\$300.00)*** for violation of California Horse Racing Board rule #1688(b)(4&5) (Use of Whips-continuing to use whip when his mount was clearly out of the race).

11/10/12²**EICKERMAN RULING (ref. 11/09/12³)**

The following ruling was issued after Mr. Eickerman was informed of the penalty.

HRT# #003

Pursuant to California Horse Racing Board rule #1866(d)(Veterinarian's List), trainer **GARY EICKERMAN** is fined **FIVE HUNDRED DOLLARS (\$500.00)*** for violation of California Horse Racing Board rules #1843(a)(d)(Medication, Drugs, and Other Substances) and #1844(c)(1)(Authorized Medication-phenylbutazone in excess of authorized level-7.15ug/ml).

11/10/12³**HERNANDEZ HEARING CASE #12SA187**

The complaint filed by the CHRB against jockey Juan Hernandez involves CHRB rule 1688(b) (3) (Use of Whips). The horse "Where's the Remote" post race had a documented cut on its right flank. Mr. Hernandez agreed he could have hit the horse in a vulnerable area in the stretch run and will be more aware in the future. A majority vote, (Chaney dissent, voted for a \$500.00 penalty), the following ruling was issued:

HRT# #004

Jockey **JUAN HERNANDEZ** is fined **THREE HUNDRED DOLLARS (\$300.00)*** for violation of California Horse Racing Board rule #1688(b)(3) (Use of Whips-hit horse on flank causing a break in the skin).

Jockey Garrett Gomez met with the Stewards to review the sixth race yesterday. Mr. Gomez was warned he needs to do better correcting his horses' drifts. This drift that caused the contact actually affected his mount more than the opponent. Mr. Gomez acknowledged the advice and stated he would do better.
