The following ruling was issued after Ms. Gaines was made aware of the penalty. Two of her practicing veterinarians treated the horse with Phenylbutazone without knowing the other had done so.

Trainer **CARLA GAINES** is fined **FOUR HUNDRED DOLLARS (\$400.00)*** pursuant to California Horse Racing Board rule #1629 (Late Declaration-double administration of permitted medication) for failure to start the horse "Ruled by Kisses" in the ninth race at Betfair Hollywood Park on November 18, 2012.

O'NEILL RULING (ref. 11/23/12²)

The following ruling was issued after Mr. O'Neill was made aware of the Stewards' decision.

HRTH #010

Trainer **DOUG O'NEILL** is fined **ONE THOUSAND DOLLARS (\$1,000.00)*** for violation of California Horse Racing Board rule

#1866(b)(Veterinarian's List-worked horse within 72 hours of being placed on veterinarian's list) on November 4, 2012.

INQUIRY/FIFTH RACE (1 mile-turf)/NO CHANGE

Following the running of the race, the Inquiry sign was posted to review an incident into the first turn. Involved was # 5 Dayatthespa (J. Castellano). After a review of the video, conversation with the Patrol Judges and the jockey it was a unanimous decision to make the original order of finish official. "Dayatthespa" while in tight quarters, propped then jumped losing her action for several strides, causing her own problems. Her jockey Javier Castellano confirmed this.

INQUIRY/ACCIDENT/SEVENTH RACE (1 mile-turf)/NO CHANGE

Following the running of the race, the inquiry sign was posted to review an incident leaving the starting gate. # 3 "Will True Up" stumbled and unseated his jockey Juan Hernandez. After a review of the video, it was the Stewards' decision to make the race official. The incident did not involve any other person or horse. Accident report attached.

GAINES PRE-TRIAL HEARING

The morning hours were occupied by a formal pre trial hearing pertaining to cases #12DM0014, 12DM0015, 12DM0051 and 12DM0052. These cases involved possible violations of CHRB rules 1843 (a,b & d)(Medication Drugs and Other Substances), 1844(b,e &14) (Authorized Medication), 1887 (Trainer to Insure Condition of Horse) and 1859.5 (Disqualification Upon Positive Test Findings). In attendance were court reporter Michell Derig documenting the proceedings, Investigator Rick Amieva sitting in as an observer, Darrell Vienna attorney for trainer Carla Gaines and owner John Harris, and Supervising Deputy Attorney General Jerald Mosley. Both counsels argued their positions on allowing a Motion for a Continuance and/or a Motion to Compel Discovery. The hearing for these cases is scheduled for December 6, 2012. The BOS will discuss the request and make a decision.

MOTION DECISION (ref.11/29/12¹)

Attorney Darrell Vienna and Supervising Deputy Attorney General Jerald Mosley were contacted by the Stewards telephonically to receive the Stewards' decision from the previous day's proceedings. In attendance along with the BOS were Investigator Rick Amieva and Safety Steward Luis Jauregui. The two counselors were informed that the Motion to Compel Discovery would be granted, though not necessarily in its entirety. In addition, the hearing on December 6, 2012 would go forward and at that time decisions will be made what as to discovery requests will be granted.

Stable Foreman **RAUL MARTINEZ MORA**, having failed to respond to charges alleging violation of California Horse Racing Board rule #1902.5 (Animal Welfare), is suspended for violation of California Horse Racing Board rule #1547 (Failure to Appear).

During term of suspension, all licenses and license privileges of Raul Martinez Mora are suspended and pursuant to California Horse Racing Board rule #1528 (Jurisdiction of Stewards to Suspend or Fine), Mr. Martinez is denied access to all premises in this jurisdiction.

JOCKEY OBJECTION/FIFTH RACE (1 ¼ mile-cushion)/NO CHANGE

Following the running of the race, jockey Edwin Maldonado who finished second on #6 Imponente Purse (BRZ), lodged a claim of foul against the winner # 5 Dreamcatcher (Martin Garcia). After a review of the video, conversation with the Patrol Judges and both jockeys involved it was a unanimous decision to make the original order of finish official. The video did not support Mr. Maldonado's claim that he was bothered near the 3/8s marker.

During term of suspension, all licenses and license privileges of Vincent Lentini are suspended and pursuant to California Horse Racing Board rule #1528 (Jurisdiction of Stewards to Suspend or Fine), Mr. Lentini is denied access to all premises in this jurisdiction.

VEGA FOARMAL HEARING CASE #12PM103

A complaint was filed against Stable café employee John V. Vega alleging in violation of CHRB rule 1902(b) (Conduct Detrimental to Horse Racing). Investigator Phil Miyazaki presented this case filed by the CHRB and Barbara Weinstein recorded the proceedings.
