VALENZUELA HEARING CASE #13HP008

The CHRHB filed a complaint against assistant trainer Martin Valenzuela for a possible violation of rule 1902 (Conduct Detrimental to Horse Racing), this rule was amended to rule 1874 (Disorderly Conduct) before the start of the hearing. The Respondent agreed to the change. Present for the hearing, were trainer Jorge Periban and assistant trainer Martin Valenzuela. Investigator Rick Amieva represented the CHRHB. Mr. Valenzuela had two witnesses, valet Ricardo Peniche, Martin Valenzuela III. Mr. Valenzuela is an assistant trainer for trainer Bobby Grayson. On April 27, 2013 trainer Jorge Periban claimed Mr. Grayson's horse "Queen of the Hill", Mr. Valenzuela, was on the steps of the grandstand leading in to the winner's circle, when he allegedly cursed and threatened Mr. Periban. Both parties admitted to an exchange of abusive language in Spanish towards each other, which the witnesses verified. A warning (Steward Chaney voted for a fine) was given and any further display of temper in public will warrant a fine and or suspension. The complaint was signed off.

Groom **HUMBERTO MACIAS**, having failed to respond to a complaint alleging violation of California Horse Racing Board rule #1489(h)(Grounds for Denial or Refusal of License-possession of a controlled substance), is suspended for violation of California Horse Racing Board rule #1547(Failure to Appear).

During the term of suspension, all licenses and license privileges of Humberto Macias are suspended and pursuant to California Horse Racing Board rule #1528(Jurisdiction of Stewards to Suspend or Fine), Humberto Macias is denied access to all premises in this jurisdiction.

KIF ENTERPRISE HEARING CASE #0010

This case was filed by the CHRB, pursuant to CHRB rule 1876 (Financial Responsibility) against KIF Enterprises, (Gabriel Guy Coscas and Marc Albert Belhassen) for services provided by von Bluecher, Blea, Hunkin Inc. veterinarian group for \$5,407.00. Jeff Blea appeared on the behalf of the group and explained the communication he has had with the owners; each owner stated the other owes the bill. HELLUM FORMAL HEARING CASE #13HP0007

The CHRB filed against owner Lance Hellum for a possible violation of CHRB rules 1503 (Qualifications for License as Trainer or Assistant Trainer) and 1930 (Obedience to Security officers and Public Safety Officers). The hearing was originally set for May 19, 2013. Due to the availability of witnesses, the date for the hearing was rescheduled for May 17, 2013. Investigator Rick Amieva notified Mr. Hellum of the new date by mail, but there was no evidence Mr. Hellum had received a certified notification. This information was documented for the record, decision to follow.

Exercise rider **MARCO ORTIZ**, having failed to respond to a complaint alleging violation of California Horse Racing Board rule #1902(Conduct Detrimental to Horse Racing-domestic violence), is suspended for violation of California Horse Racing Board rule #1547(Failure to Appear).

During the term of suspension, all licenses and license privileges of Marco Ortiz are suspended and pursuant to California Horse Racing

Board rule #1528(Jurisdiction of Stewards to Suspend or Fine), Mr. Ortiz is denied access to all premises in this jurisdiction.

AVILA FORMAL HEARING CASES #13SA079 & 13SA110

The two complaints filed by the CHRB against trainer A.C. Avila involve a violation of CHRB rules 1843(a) (d) (Medication, Drugs and Other Substances.) 1844(c) (Authorized Medication.) and 1887(a) (Trainer Responsibility.). Present for the hearing before the BOS were Court Reporter Eulah Stewart, representing the CHRB, Investigator Phillip Miyazaki and trainer A.C. Avila was available by telephone. The alleged offense (case # 13SA079) occurred on February 15, 2012, involving horse "Viva Carina" who finished first in the seventh race at Santa Anita and had a Phenylbutazone level of 2.8 UG/ML. Mr. Avila requested a split sample; HFL Sport Science in Lexington Kentucky did not receive payment for the split within the five-day window, which expired on March 14, 2013. On March 17, 2013, Official Veterinarian Tim Grande interviewed Mr. Avila and wrote in a declaration, "Phenylbutazone paste administration was not reliable".

The second case (#13SA110) involved the horse "Glowing Spirit" who finished first in the fifth race at Santa Anita on March 14, 2013 and had a Phenylbutazone level of 3.1 UG/ML. Mr. Avila declined a split sample. Mr. Avila reported to Official Veterinarian Tim Grande that he used paste to treat this horse.

Mr. Avila testified his personal veterinarian recommended paste, but he plans to administer pills when he medicates to avoid future positives. Decision to follow.

During the term of suspension, all licenses and license privileges of Ramon Villalobos are suspended and pursuant to California Horse Racing Board rule #1528(Jurisdiction of Stewards to Suspend or Fine), Mr. Villalobos is denied access to all premises in this jurisdiction.
