**LATSON RULING**

The following ruling was issued when Dr. Keith Latson failed to administer lasix yesterday to a runner, necessitating its late declaration:

**HRTH #016**

Veterinarian **KEITH LATSON**, pursuant to California Horse Racing Board rule #1629 (Late Declaration) is fined **FOUR HUNDRED DOLLARS (\$400.00)\*** for violation of California Horse Racing Board rule #1845 (Authorized Bleeder Medication-failed to administer bleeder medication ), which resulted in the late declaration of "Wednesday" in the third race at Betfair Hollywood Park on May 18, 2013.

**NORMAN SETTLEMENT**

Owner GREG NORMAN and trainer Henry Moreno came to an agreement to settle a complaint (case number 13HP002) alleging unpaid training bills. The agreement was reduced to writing and signed by both parties.

**GERSON HEARING**

We held a formal hearing into case number 12SA071 which was a complaint filed by the CHRB against owner SEAN GERSON alleging the

violation of two CHRB rules centered around an arrest for a possible felony involving selling vet products out of state. The record was opened, written and documentary evidence was taken and the record was closed. Decision to follow.

**AVILA HEARING**

Pursuant to the two bute cases heard last week, we issued a warning (case number 13SA079) and the following ruling (case number 13SA110):

**HRTH #017**

Trainer **ANTONIO "A.C." AVILA**, who started the horse "Glowing Spirit" in the fifth race at Santa Anita Park on March 14, 2013, is fined **FIVE HUNDRED DOLLARS (\$500.00)\*** for violation of California Horse Racing Board rules #1843(a)(d)(Medications, Drugs and Other Substances), #1887 (Trainer to Insure Condition of Horse) and #1844(c)(1)(Authorized Medication-Phenylbutazone in excess of permitted level-3.1 ug/ml-second offense).

**VOIDED CLAIM**

The new claiming rule was invoked today when Official Veterinarian Grande reported to us that he was placing #7 Plenny of Henny, who ran in the first race, on the Vet's list for unsound. We therefore voided the claim and returned him to his original trainer, Bill Spawr. Interestingly, he won the race before becoming unsound in the test barn.

**INQUIRY/NO CHANGE**

Following the running of the sixth race we posted the inquiry sign to examine an incident in which #8 Gnarly Dude lost his rider Tyler Baze shortly after the start. Films revealed that Mr. Baze's mount stumbled and unseated him, and no change was appropriate. Mr. Baze was transported to first aid where he was declared uninjured and cleared to ride. **HRTH #018**

Jockey **RAFAEL BEJARANO**, having withdrawn his appeal of Ruling #LATS 065, issued at Los Angeles Turf Club on March 16, 2013, is suspended for **THREE (3) RACING DAYS** (May 31, June 1, and 2, 2013). All other terms of the original ruling shall remain in effect.

Term of suspension shall not prohibit participation in designated races pursuant to California Horse Racing Board rule #1766 (Designated Races).

**INQUIRY/ACCIDENT/NO CHANGE**

About an eighth of a mile from the finish of the first race on the main track, #4 Randino (P. Miller, trainer) ducked into the inside fence while racing on the lead, fell, and unseated his rider Garrett Gomez. We posted the inquiry sign to examine the incident. Films showed that no other horses were involved and therefore no change was appropriate. Unfortunately, the horse fractured his radius and severed an artery upon impact with the rail and was euthanized by the racing veterinarian on the track. Mr. Gomez was transported to the hospital for precautionary x-rays. See attached accident report.

He had ridden 32 winners in Puerto Rico before moving his tack to Southern California and although he had evidence of his wins from PR, that country's version of an apprentice certificate might have been unclear should he leave Southern California. We therefore issued a California certificate to clarify the matter.

Apprentice jockey IRVING OROZCO brought evidence of an absence from riding due to an injury and requested an extension to his apprenticeship. We granted that request and published the following ruling:

**HRTH #019**

Apprentice jockey **IRVING OROZCO**, having supplied medical documentation to verify his request for an extension to his apprentice jockey's license, is granted an extension of 250 days. Irving Orozco's apprenticeship shall terminate on January 28, 2014 at midnight, or until he has ridden his fortieth (40<sup>th</sup>) winner, whichever occurs later.

**ESQUIVEL HEARING**

We held an informal hearing this morning regarding case number 11GG225 which was partly a fitness for license hearing and partly a regular hearing on an underlying DUI conviction. Exercise rider LORENZO ESQUIVEL had failed to appear for a hearing in Northern California regarding a DUI conviction in 2002 and possible misrepresentation on his license application. After a short explanation of the situation, we accepted the CHRB's recommendation and issued the following ruling:

**HRTH #021**

Exercise rider **LORENZO ESQUIVEL**, having appeared before the Board of Stewards, is restored to good standing. Ruling CFHC #05, issued at California State Exposition and Fair on July 15, 2012, is set aside. Furthermore, Mr. Esquivel is ordered to enroll in the Winner's Foundation program and sign a testing agreement with the California Horse Racing Board for violation of California Horse Racing Board rules #1489(a)(c)(Engaged in the Use of Drugs). Additionally, subject is placed on probation for **ONE (1) YEAR** by the California Horse Racing Board.

**CLAIM VOIDED**
