**BAZE FORMAL HEARING CASE #13HP0048 (ref. 6/13/13<sup>3</sup>)**

The CHRB filed a complaint against jockey Tyler Baze involving CHRB rules #1874 (Disorderly Conduct) and #1902 (Conduct Detrimental to Horse Racing). Mr. Baze has not participated in racing since being removed from his mounts on June 13, 2013, when he failed a breathalyzer test. In attendance, representing the CHRB, Investigator Rick Amieva, Court Reporter Michelle Derieg and Executive Director of the Winners' Foundation Bob Fletcher who testified for the CHRB. Also attending, jockey Tyler Baze, with his counsel, Michael Oddenino, his agent, Craig O'Brian and friend trainer Jeff Mullins who testified on his behalf. Tyler Baze signed the Waiver of Proper Notice and the hearing went forward. Cammie and Earl Baze, Tyler's parents, testified to their availability in a planned support system for Mr. Baze. All recommendations and promises for Mr. Baze's future were heard and recorded. Decision to follow.

**JOCKEY OBJECTION/THIRD RACE (5/8-cushion)/NO CHANGE**

Following the running of the race, jockey Edwin Maldonado aboard second place finisher #2 Yodelmesomemagic who finished second, lodged a claim of foul against the winner #5 Santa Lucia ridden by apprentice jockey Arnold Perez. After a review of the videos and conversation with the Patrol Judges and both jockeys it was a unanimous decision to let the original order of finish stand. The videos confirmed that near the quarter pole #2 actually stepped out into #5 initiating the contact.

**AZCARATE RULING**

**HRTH #035**

Trainer **DAN AZCARATE** is suspended for violation of California Horse Racing Board rule #1876 (Financial Responsibility-Salah Al Mudarris \$7,000.00).

During the term of suspension, all licenses and license privileges of Dan Azcarate are suspended and pursuant to California Horse Racing Board rule #1528(Jurisdiction of Stewards to Suspend or Fine), Mr. Azcarate is denied access to all premises in this jurisdiction.

After Mr. Azcarate missed two payments for a signed financial agreement, the ruling listed above was issued.

**NORMAN CASE #13HP053**

The financial filed against owner Greg Norman filed by the CHRB for a debt owed to Flying H Express for \$3,720.00 was withdrawn after verification that full payment was received.

**CAPESTRO FORMAL HEARING CASE #13HP038**

The complaint filed by the CHRB against trainer Paula Capestro involved a violation of CHRB rules 1843(a) (d) (Medication, Drugs and Other Substances.) 1844(c) (1) (Authorized Medication.), 1866(d) (Veterinarian's List.) and 1887(a) (Trainer Responsibility.). Ms. Capestro requested and was granted permission to have the hearing by telephone. Ms. Capestro's husband/attorney Andy Capestro was with her during the hearing. Court reporter Michelle Derieg was present to document the proceedings and Investigator Jim Hamilton represented the CHRB. The horse in question, "Miracle Merger" had received a "Phenylbutazone" injection 26 hours prior to it's workout to be removed from the Veterinarian List. Official Veterinarian Dr. Grande recommended in a written declaration that Ms. Capestro, in the future, use no more than 2g of "Phenylbutazone" no later than 30 hours prior to a workout for list removal or a race. Ms. Capestro had no explanation other than the horse was slow to metabolize the drug and she will not use this medication again on "Miracle Merger". Ms. Capestro was eligible for and received a warning.

**ALLEN FORMAL HEARING CASE #13HP0013**

The CHRB filed a complaint against trainer Robert Allen for a possible violation of CHRB rule 1865 (Altering of Sex of Horse). Present for the

hearing before the BOS, were trainer Robert Allen, Court Reporter Michele Derieg and representing the CHRB, Investigator Phil Miyazaki. Official Veterinarian Tim Grande and Clerk of the Course Melanie Stubblefield testified on behalf of the CHRB.

Mr. Allen testified and produced documents in argument that he had registered the horse "Mark's Cat" as a gelding on the stall application, had turned in a report to Ms. Stubblefield, which she gave back to him and a copy of a cancelled check that showed a payment for a castration of a horse on May 4, 2012.

After all testimony and documents were submitted into evidence, the hearing was closed. Decision to follow.
