FILM REVIEW

Apprentice jockey IRVING OROZCO came to the office this morning to discuss the circumstances under which he missed apprentice film review. He had no acceptable excuse and was issued the following ruling:

HRTH #036

Apprentice jockey **IRVING OROZCO** is fined **ONE HUNDRED DOLLARS (\$100.00)*** for violation of California Horse Racing Board rule #1930 (Obedience to Security Officers and Public Safety Officers-failure to attend film review class).

Jockey KEVIN KRIGGER came to the office to discuss his ride in the sixth race on Thursday and failure to see this Board as directed. On Thursday, it appeared that he did not ride his mount to the finish, most likely costing him fourth position. He was candid in explaining that his mount was drifting out a bit but he should have continued riding for two more strides. He was issued the following rulings:

HRTH #034

Jockey **KEVIN KRIGGER** is fined **THREE HUNDRED DOLLARS (\$300.00)*** for failure to ride his mount to the finish in the sixth race at Betfair Hollywood Park on June 27, 2013. This constitutes a violation of California Horse Racing Board rule #1692 (Requirements for Horse, Trainer and Jockey).

HRTH #037

Jockey **KEVIN KRIGGER** is fined **ONE HUNDRED DOLLARS (\$100.00)*** for violation of California Horse Racing Board rule #1930 (Obedience to Security Officers and Public Safety Officers-failure to see stewards).

ALLEN DISMISSAL

The complaint against trainer **ROBERT ALLEN** alleging violation of the gelding rule was dismissed because the evidence indicated that he complied with the rule to the satisfaction of this Board.

HELLUM RULING

We issued the following ruling concerning owner/trainer **LANCE HELLUM** and case number 13HP0007:

HRTH #038

Owner/trainer **LANCE HELLUM** is fined **TWO HUNDRED DOLLARS (\$200.00)*** and prohibited from applying for a trainer's license for a period of two years pursuant to California Horse Racing Board rule #1503 (Qualifications for License as Trainer or Assistant Trainer) for violation of California Horse Racing Board rule #1930 (Obedience to Security Officers and Public Safety Officers). Furthermore, the condition with respect to revocation in the event of any further Stewards' rulings present in his conditional license is reinstated for a period of two years from the date of this ruling.

INQUIRY/NO CHANGE

Following the running of the sixth race, Gary Stevens, the jockey who rode the fourth place finisher #4 Branding, claimed foul against the winner #1 Miss Radiance, alleging interference in the stretch. Films revealed that #4 Branding did suffer interference when a riderless horse drifted in slightly and the eventual winner drifted out. The winner was also somewhat influenced by the horse to her inside. While #4 did suffer interference, it was our unanimous opinion that she was not cost the opportunity at a better placing. (Accident report regarding the loose horse attached.)

FILM REVIEW

Jockey ALONSO QUINONEZ came to the office this morning to review his ride in the sixth race on Sunday. His mount was the subject of a jockey's objection following that race. Films revealed that his mount drifted out late in the stretch under left handed urging and contributed to the interference suffered by a rival. In our opinion, that interference was also caused by a loose horse on the outside and another rival on his inside drifting out. We therefore voted to issue a warning rather than suspension days.

We approved French rider JEROME LEMYTRE this morning for a license. He will be riding in Southern California for the next two months and has over 300 career wins in France.

The following ruling was issued when trainer ANGEL RODRIGUEZ sold a horse in his care and transferred trainers after entry, necessitating its late declaration:

HRTH #039

Trainer **ANGEL RODRIGUEZ** is fined **FOUR HUNDRED DOLLARS (\$400.00)*** for violation of California Horse Racing Board rule #1629 (Penalty For Late Declaration-horse sold after entry) in the sixth race on June 14, 2013 at Betfair Hollywood Park.

HRTH #040

Trainer **R.B. HESS, Jr.** is fined **FIVE HUNDRED DOLLARS (\$500.00)*** for violation of California Horse Racing Board rule #1629 (Penalty For Late Declaration-horse mismedicated) necessitating a late declaration in the fifth race on July 5, 2013 at Betfair Hollywood Park.

DIODORO HEARING AND RULING

We held a formal hearing today into case numbers 13SA0073 and 13SA0074 which were complaints filed against trainer ROBERTINO DIODORO alleging two medications positives discovered in one of his runners – tranexamic acid and carbazochrome. We opened the record and entered into evidence a stipulated agreement between the CHRB and Mr. Diodoro. We approved the agreement and issued the following ruling:

HRTH #041

Trainer **ROBERTINO DIODORO**, trainer of the horse “MR. BOSSY PANTS”, the winner of the second race at Santa Anita Park on February 2, 2013, having entered into a stipulated agreement with the California Horse Racing Board, is fined **TWENTY FIVE HUNDRED DOLLARS (\$2,500.00)*** and suspended for **SEVEN (7) DAYS**, such suspension to be stayed provided that Respondent be placed on probation for a period of one year from the date of this ruling and not be found in violation of California Horse Racing rule #1843.5 (Medication, Drugs and other Substances Permitted After Entry in a Race).

As part of this agreement (Section 8) respondent agrees that he is in violation of California Horse Racing Board rule #1843(a)(b) (Medication, Drugs and Other Substances – Carbazochrome and Tranexamic Acid, Class 4 - Penalty Category C).

TROEGER HEARING

We held a formal hearing this morning into a complaint filed by the CHRB (case number 13HP054) that alleged a phenylbutazone overage discovered in one of trainer ROBERT TROGER’S runners. Given the level and Mr. Troeger’s record, the CHRB recommended and we issued a warning in this matter.

AZCARATE RULING

After trainer DAN AZCARATE made a large payment, returning him to current on his financial agreement with owner Salah al Mudaris, we issued the following ruling:

HRTH #042

Trainer **DAN AZCARATE**, having come in compliance with a signed financial agreement, is restored to good standing. Ruling HRTH #035, issued on June 29, 2013, is set aside.

INQUIRY/NO CHANGE

Following the running of the fifth race (Grade 2 Royal Heroine), we posted the inquiry sign to review the circumstances under which #1 Stormy Lucy (last place, Martin Pedroza aboard) appears to clip heels near the quarter pole. Films revealed that Mr. Pedroza attempted to shift out around the second place horse and clipped heels, causing his horse to stumble. Since the horse caused her own problems, there was no need for a change.
